# Community Colleges - Supplemental Services and Supports for Students With Disabilities Grant Program

4 FOR the purpose of requiring the Maryland Higher Education Commission to consult with  $\mathbf{5}$ the Maryland Association of Community Colleges when establishing a certain review 6 process and adopting certain guidelines or regulations for a grant program for 7 supplemental services and supports for students with disabilities; requiring, 8 beginning in a certain fiscal year, that the Governor include in the annual budget 9 bill at least a certain appropriation to the Maryland Higher Education Commission to be used to award grants for a certain program; and generally relating to the grant 10 11 program for supplemental services and supports for students with disabilities in 12community colleges.

#### HOUSE BILL 1388

1 CONSULTATION WITH THE MARYLAND ASSOCIATION OF COMMUNITY COLLEGES, 2 shall:

3 (1) Establish a competitive review process for the awarding of grants to 4 community colleges; and

5 (2) Adopt any other guidelines or regulations necessary for the 6 administration of this section.

7 (C) FOR FISCAL YEAR 2020 AND EACH FISCAL YEAR THEREAFTER, THE 8 GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL A GENERAL FUND 9 APPROPRIATION OF AT LEAST \$2,500,000 TO THE COMMISSION TO BE USED TO 10 AWARD GRANTS UNDER THIS SECTION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
1, 2018.
