A BILL ENTITLED

1 AN ACT concerning

2 **Garrett County – Alcoholic Beverages Act of 2018**

3 FOR the purpose of establishing an art establishment license in Garrett County;
4 authorizing the Board of License Commissioners for Garrett County to issue the
5 license to a certain organization; prohibiting the Board from issuing the license to a
6 certain organization; specifying that the license authorizes the holder to sell or serve
7 beer and wine at retail for on–premises consumption; specifying the hours of sale;
8 prohibiting the transfer of the license; making a certain business subject to alcohol
9 awareness training requirements; specifying certain fees; adding a person that is
10 eligible to hold a Class C multiple day or multiple event license to the list of persons
11 to whom the Board may issue a beer festival license; authorizing a person to hold a
12 beer festival license in addition to another license; establishing in the county a Class
13 C beer and wine street festival license; specifying a certain person that may be issued
14 the license; specifying that the license authorizes the holder to sell beer and wine
15 under certain circumstances; specifying certain activities, under certain
16 circumstances, that an individual may take during an event for which the license is
17 issued; requiring a license applicant to submit a certain application; requiring the
18 Board to publish a certain notice under certain circumstances; requiring the holder
19 of a beer and wine street festival license to distribute wristbands for a certain
20 purpose under certain circumstances; requiring a certain organization to ensure that
21 at least one certain server is on the premises when alcoholic beverages are served;
22 allowing a holder of a beer and wine street festival license to hold another license of
23 a different class or nature; authorizing the use of the beer and wine street festival
24 license for a certain maximum number of days in a year; establishing the Garrett
25 County Beer and Wine Festival and a beer and wine festival license; authorizing the
26 Board to issue the license to certain persons; specifying that the license authorizes
27 the holder to display and sell beer and wine under certain circumstances; requiring
28 the license holder to display and sell beer and wine under certain circumstances;
29 requiring the Board to hold a certain hearing, publish a certain notice, and choose a
30 location for the festival; requiring that beer and wine displayed and sold meet certain
31 requirements; authorizing a holder of a State wholesale license or retail license to

1 enter into a certain agreement; requiring the Board to establish a license fee and
 2 adopt certain regulations; establishing a Class BWLT beer, wine, and liquor tasting
 3 license; authorizing the Board to issue the license to a certain license holder;
 4 specifying that the license authorizes the holder to allow the on-premises
 5 consumption, for tasting, of beer, wine, or liquor; setting certain notice requirements
 6 and certain fees; requiring the Board to adopt certain regulations; altering a certain
 7 residency requirement; defining certain terms; making technical changes; and
 8 generally relating to alcoholic beverages licenses in Garrett County.

 31 That Section(s) 21–1001 of Article – Alcoholic Beverages of the Annotated Code of Maryland
 32 be renumbered to be Section(s) 21–1001.1.

2 (A) **THERE IS AN ART ESTABLISHMENT LICENSE.**

3 (B) (1) **THE BOARD MAY ISSUE THE LICENSE TO A NONPROFIT**
4 **ORGANIZATION ENGAGED IN:**

5 (I) **THE DISPLAY, SALE, OR DEMONSTRATION OF ART BY AN**
6 **INDIVIDUAL ARTIST OR A GROUP OF ARTISTS; OR**

7 (II) **THE INSTRUCTION OF PARTICIPATING CLIENTS IN**
8 **CREATING ART.**

9 (2) **THE BOARD MAY NOT ISSUE THE LICENSE TO AN ORGANIZATION**
10 **THAT DISPLAYS AND SELLS COMMERCIALY PREPARED OR MASS-PRODUCED**
11 **ARTISTIC PRODUCTS.**

12 (C) **THE LICENSE AUTHORIZES THE HOLDER TO SELL OR SERVE BEER AND**
13 **WINE AT RETAIL FOR ON-PREMISES CONSUMPTION.**

14 (D) **THE LICENSE HOLDER MAY SELL OR SERVE BEER AND WINE DURING**
15 **THE HOURS AND DAYS AS SET OUT FOR BEER AND WINE LICENSES UNDER §**
16 **21-2003(B) THIS TITLE.**

17 (E) **THE LICENSE MAY NOT BE TRANSFERRED TO ANOTHER LOCATION.**

18 (F) **A BUSINESS FOR WHICH THE LICENSE IS ISSUED IS SUBJECT TO THE**
19 **ALCOHOL AWARENESS TRAINING REQUIREMENTS UNDER § 4-505 OF THIS ARTICLE.**

20 (G) **THE ANNUAL LICENSE FEE IS \$205 IN ADDITION TO A ONE-TIME ISSUING**
21 **FEE FOR A NEW LICENSE OF \$205.**

22 **21-1304.**

23 (a) (1) **There is a beer festival license.**

24 (2) **The Board may issue not more than two beer festival licenses each year.**

25 (b) **The Board may issue the license to a holder of:**

26 (1) **a retail license issued by the Board;**

27 (2) **a Class 5 brewery license;**

1 (3) a Class 6 pub–brewery license;

2 (4) a Class 7 micro–brewery license; [or]

3 (5) a Class 8 farm brewery license; **OR**

4 **(6) A PERSON THAT IS ELIGIBLE TO HOLD A CLASS C MULTIPLE DAY**
5 **OR MULTIPLE EVENT LICENSE.**

6 (c) The license authorizes the holder to display and sell beer that is:

7 (1) manufactured and processed in any state; and

8 (2) distributed in the State when the license application is filed.

9 (d) A license holder may display and sell beer:

10 (1) at retail for on– and off–premises consumption; and

11 (2) during the hours and days designated for a beer festival.

12 (e) The Board shall choose:

13 (1) a fixed period of time for the festival of up to 2 consecutive days,
14 excluding Sunday; and

15 (2) a location that is not already licensed.

16 (f) Notwithstanding subsection (e)(1) of this section, a holder of a beer festival
17 license issued for a location at which Sunday sales are allowed under § 21–2002(e) of this
18 title may make Sunday sales beginning at 10 a.m.

19 (g) Beer displayed and sold shall be:

20 (1) invoiced to the license holder by a wholesaler or holder of a Class 5
21 brewery license, Class 6 pub–brewery license, Class 7 micro–brewery license, or Class 8
22 farm brewery license; and

23 (2) delivered to the beer festival from the licensed premises of the
24 wholesaler.

25 (h) A holder of a State wholesaler’s license, a Class 5 brewery license, a Class 6
26 pub–brewery license, a Class 7 micro–brewery license, or a Class 8 farm brewery license
27 may enter into an agreement with the license holder to:

28 (1) deliver beer not earlier than 2 days before the effective date of the
29 license; and

1 (2) accept returns not later than 2 days after the expiration date of the
2 license.

3 **(I) A PERSON MAY HOLD A BEER FESTIVAL LICENSE IN ADDITION TO**
4 **ANOTHER LICENSE.**

5 **[(i)] (J)** The Board shall set the fee.

6 **[(j)] (K)** The Board shall adopt regulations to carry out this section.

8 **(A) THERE IS A CLASS C BEER AND WINE STREET FESTIVAL LICENSE.**

9 **(B) THE BOARD MAY ISSUE THE LICENSE TO A PERSON THAT IS ELIGIBLE**
10 **TO HOLD A CLASS C MULTIPLE DAY OR MULTIPLE EVENT LICENSE.**

11 **(C) THE LICENSE AUTHORIZES THE HOLDER TO SELL BEER AND WINE FOR**
12 **ON-PREMISES CONSUMPTION AT AN ENTERTAINMENT EVENT THAT IS:**

13 **(1) HELD IN AN ARTS AND ENTERTAINMENT DISTRICT; AND**

14 **(2) IF REQUIRED, APPROVED BY THE MAYOR AND TOWN COUNCIL OF**
15 **THE MUNICIPALITY WHERE THE EVENT IS LOCATED.**

16 **(D) DURING AN EVENT FOR WHICH THE LICENSE IS ISSUED, AN INDIVIDUAL**
17 **IN THE EVENT AREA APPROVED BY THE BOARD WHO USES A DESIGNATED**
18 **CONTAINER UNIQUE TO THE EVENT MAY:**

19 **(1) PURCHASE BEER OR WINE FROM:**

20 **(I) THE HOLDER OF THE BEER AND WINE STREET FESTIVAL**
21 **LICENSE; OR**

22 **(II) ANOTHER LICENSE HOLDER WITH ON-SALE PRIVILEGES**
23 **WITHIN THE ARTS AND ENTERTAINMENT DISTRICT;**

24 **(2) TRANSPORT BEER OR WINE IN THE DESIGNATED CONTAINER:**

25 **(I) TO THE PREMISES OF A LICENSE HOLDER WITH ON-SALE**
26 **PRIVILEGES IN THE ARTS AND ENTERTAINMENT DISTRICT; AND**

27 **(II) IN THE APPROVED EVENT AREA; AND**

1 **(3) CONSUME BEER AND WINE:**

2 **(I) ON THE PREMISES OF A LICENSE HOLDER WITH ON-SALE**
3 **PRIVILEGES IN THE ARTS AND ENTERTAINMENT DISTRICT; AND**

4 **(II) IN THE APPROVED EVENT AREA.**

5 **(E) AN APPLICANT FOR THE LICENSE SHALL SUBMIT AN APPLICATION ON**
6 **THE FORM THAT THE BOARD PROVIDES.**

7 **(F) THE BOARD SHALL PUBLISH A NOTICE FOR APPLICATIONS FOR THE**
8 **LICENSE ONE TIME AT LEAST 7 DAYS BEFORE A LICENSE HEARING.**

9 **(G) A LICENSE HOLDER MAY PURCHASE BEER AND WINE FROM A HOLDER**
10 **OF A RETAIL OR WHOLESALE LICENSE.**

11 **(H) THE LICENSE HOLDER:**

12 **(1) SHALL DISTRIBUTE A WRISTBAND TO EACH INDIVIDUAL WHO IS AT**
13 **LEAST 21 YEARS OLD AT THE EVENT FOR WHICH THE LICENSE IS ISSUED; AND**

14 **(2) MAY NOT SERVE BEER OR WINE TO AN INDIVIDUAL WHO DOES NOT**
15 **WEAR A WRISTBAND.**

16 **(I) THE ORGANIZATION FOR WHICH THE LICENSE IS ISSUED SHALL ENSURE**
17 **THAT AT LEAST ONE SERVER WHO IS CERTIFIED BY AN APPROVED ALCOHOL**
18 **AWARENESS PROGRAM IS ON THE PREMISES WHEN ALCOHOLIC BEVERAGES ARE**
19 **SERVED.**

20 **(J) THE LICENSE HOLDER MAY HOLD ANOTHER LICENSE OF A DIFFERENT**
21 **CLASS OR NATURE.**

22 **(K) THE LICENSE MAY BE USED FOR A MAXIMUM OF 26 DAYS IN A CALENDAR**
23 **YEAR.**

24 **(L) THE LICENSE FEE IS \$150 PER DAY.**

26 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
27 **INDICATED.**

1 (2) **“FESTIVAL” MEANS THE GARRETT COUNTY BEER AND WINE**
2 **FESTIVAL.**

3 (3) **“FESTIVAL ORGANIZATION” MEANS A NONPROFIT ORGANIZATION**
4 **THAT IS CHOSEN BY THE COUNTY IN ACCORDANCE WITH SUBSECTION (C) OF THIS**
5 **SECTION TO ORGANIZE A FESTIVAL.**

6 **(B) (1) THERE IS A GARRETT COUNTY BEER AND WINE FESTIVAL.**

7 (2) **UNDER THE SUPERVISION OF THE BOARD, THE FESTIVAL**
8 **ORGANIZATION MAY CONDUCT THE FESTIVAL ANNUALLY ON THE SECOND**
9 **SATURDAY OF SEPTEMBER.**

10 **(C) (1) IN SELECTING A NONPROFIT ORGANIZATION TO BE A FESTIVAL**
11 **ORGANIZATION, THE COUNTY SHALL ENSURE THAT THE NONPROFIT ORGANIZATION**
12 **HAS EXTENSIVE EXPERIENCE IN ORGANIZING AND MANAGING LARGE-SCALE PUBLIC**
13 **EVENTS.**

14 (2) **THE BOARD MAY ISSUE ONE BEER AND WINE FESTIVAL LICENSE**
15 **EACH YEAR.**

16 **(D) THE BOARD MAY ISSUE THE LICENSE TO A HOLDER OF A RETAIL**
17 **LICENSE OR A PERSON THAT IS ELIGIBLE TO HOLD A CLASS C MULTIPLE DAY OR**
18 **MULTIPLE EVENT LICENSE.**

19 **(E) THE LICENSE AUTHORIZES THE HOLDER TO DISPLAY AND SELL BEER**
20 **AND WINE THAT IS:**

21 (1) **MANUFACTURED AND PROCESSED IN OR OUTSIDE THE STATE;**
22 **AND**

23 (2) **DISTRIBUTED IN THE STATE WHEN THE LICENSE APPLICATION IS**
24 **FILED.**

25 **(F) A LICENSE HOLDER SHALL DISPLAY AND SELL BEER AND WINE:**

26 (1) **AT RETAIL FOR ON- AND OFF-PREMISES CONSUMPTION; AND**

27 (2) **DURING THE HOURS AND DAYS DESIGNATED FOR THE BEER AND**
28 **WINE FESTIVAL.**

29 **(G) THE BOARD SHALL:**

1 **(1) HOLD A HEARING ON A LICENSE APPLICATION; AND**

2 **(2) PUBLISH NOTICE OF A LICENSE APPLICATION HEARING IN A**
3 **NEWSPAPER OF GENERAL CIRCULATION IN THE COUNTY ONE TIME AT LEAST 7 DAYS**
4 **BEFORE THE HEARING.**

5 **(H) (1) THE BOARD SHALL CHOOSE A LOCATION FOR THE FESTIVAL THAT**
6 **IS NOT ALREADY LICENSED.**

7 **(2) IF THE LOCATION CHOSEN ALLOWS FOR SUNDAY SALES, SUNDAY**
8 **SALES MAY BEGIN AT 10 A.M.**

9 **(I) BEER AND WINE DISPLAYED AND SOLD SHALL BE:**

10 **(1) INVOICED TO THE LICENSE HOLDER BY A RETAILER OR**
11 **WHOLESALE; AND**

12 **(2) DELIVERED TO THE FESTIVAL FROM THE LICENSED PREMISES OF**
13 **THE RETAILER OR WHOLESALE.**

14 **(J) A HOLDER OF A RETAIL LICENSE OR STATE WHOLESALE LICENSE MAY**
15 **ENTER INTO AN AGREEMENT WITH THE HOLDER OF THE FESTIVAL LICENSE TO:**

16 **(1) DELIVER BEER AND WINE NOT EARLIER THAN 2 DAYS BEFORE THE**
17 **EFFECTIVE DATE OF THE LICENSE; AND**

18 **(2) ACCEPT RETURNS NOT LATER THAN 5 DAYS AFTER THE**
19 **EXPIRATION DATE OF THE LICENSE.**

20 **(K) THE BOARD SHALL ESTABLISH THE LICENSE FEE.**

21 **(L) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION.**

22 **21-1307.**

23 **(A) THERE IS A CLASS BWLT BEER, WINE, AND LIQUOR TASTING LICENSE.**

24 **(B) THE BOARD MAY ISSUE THE LICENSE TO A HOLDER OF A BEER, WINE,**
25 **AND LIQUOR LICENSE.**

26 **(C) THE LICENSE AUTHORIZES THE HOLDER TO ALLOW THE ON-PREMISES**
27 **CONSUMPTION, FOR TASTING, OF BEER, WINE, OR LIQUOR.**

1 **(D) THE LICENSE HOLDER SHALL NOTIFY THE BOARD AT LEAST 7 DAYS**
2 **BEFORE A TASTING EVENT IS HELD.**

3 **(E) (1) THE ANNUAL FEE FOR A CLASS BWLT BEER, WINE, AND LIQUOR**
4 **TASTING LICENSE IS \$150.**

5 **(2) THE ANNUAL FEE IS IN ADDITION TO:**

6 **(1) A ONE-TIME ISSUING FEE OF \$150 FOR A NEW CLASS BWLT**
7 **BEER, WINE, AND LIQUOR TASTING LICENSE; AND**

8 **(2) THE ANNUAL FEE FOR THE UNDERLYING BEER, WINE, AND**
9 **LIQUOR LICENSE.**

10 **(F) THE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS SECTION.**

9 **AN INDIVIDUAL WHO IS A RESIDENT OF THE COUNTY FOR 1 YEAR**
10 **IMMEDIATELY BEFORE FILING THE LICENSE APPLICATION MEETS THE RESIDENCY**
11 **REQUIREMENT UNDER § 4-109(A)(4) OF THIS ARTICLE.**

12 **SECTION 3. AND BE IT FURTHER ENACTED,** That this Act shall take effect July
13 1, 2018.
