A BILL ENTITLED

1 AN ACT concerning

Heritage Structure Rehabilitation Tax Credit – Commercial Rehabilitations – Transferability and Affordable Housing

- 4 FOR the purpose of making the State income tax credit under the heritage structure $\mathbf{5}$ rehabilitation tax credit program transferable and refundable under certain 6 circumstances; authorizing a certain additional tax credit under the program for 7 certain commercial rehabilitations that qualify as affordable housing; repealing a 8 requirement that the rehabilitation of certain structures be treated as a single 9 commercial rehabilitation under the program; requiring the Director of the Maryland Historical Trust, in consultation with the Smart Growth Subcabinet, to 10 11 adopt certain regulations; providing for the application of this Act; defining a certain 12term; and generally relating to the heritage structure rehabilitation tax credit 13 program.
