## A BILL ENTITLED

1 AN ACT concerning

2 **Corporations and Associations – Filing Fee – Annual Report**

3 FOR the purpose of altering a certain fee that the State Department of Assessments and  
4 Taxation must collect from a certain limited liability company with a certain number  
5 of employees for filing a certain annual report; and generally relating to business  
6 entity filing fees.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

12	Annual report of a Maryland limited liability company, limited	
13	liability partnership, limited partnership, or of a foreign limited liability	
14	company, foreign limited liability partnership, or foreign limited	
15	partnership, except a family farm.....	\$300
16	Annual report of a business trust.....	\$300
17	Annual report of a real estate investment trust or foreign statutory	
18	trust doing business in this State .....	\$300
19	Annual report of a family farm.....	\$100

20           **(15) THE FILING FEE FOR AN ANNUAL REPORT OF A MARYLAND**  
21 **LIMITED LIABILITY COMPANY WITH FEWER THAN FIVE EMPLOYEES IS \$25.**

22           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
23           October 1, 2018.
