1 AN ACT concerning

Baltimore City - Continuing the Creating Opportunities for Renewal and Enterprise (CORE) Partnership Fund

FOR the purpose of establishing the Continuing the CORE Partnership Fund as a special, 4 nonlapsing fund; specifying the purpose of the Fund; requiring the Secretary of $\mathbf{5}$ 6 Housing and Community Development to administer the Fund; requiring the State 7 Treasurer to hold the Fund and the Comptroller to account for the Fund; specifying 8 the contents of the Fund; specifying the purpose for which the Fund may be used; 9 providing for the investment of money in and expenditures from the Fund; beginning in a certain fiscal year, requiring declaring the intent of the General Assembly that 10 beginning in a certain fiscal year, authorizing the Governor to to include in the 11 annual budget bill an appropriation of a certain amount to the Fund for certain fiscal 12years; defining a certain term; providing for the termination of this Act; and 13 14generally relating to the Continuing the CORE Partnership Fund.
