## Alcohol and Drug Abuse Program Facilities - ASAM Criteria Assessments

3 FOR the purpose of requiring a certified alcohol and drug abuse program facility to provide 4 a patient with a copy of certain records on the patient's request; requiring the 5 members of a certain assessment team to meet with the patient for a certain purpose; 6 requiring a certain facility to send certain application records to a certain treatment 7 provider within a certain period of time under certain circumstances; requiring a 8 certain treatment provider provide certain referrals to certain other treatment 9 providers; authorizing a patient to request that a certain individual be designated as 10 the patient's personal representative to advocate and speak for the patient for a 11 certain purpose; requiring certain persons sign a certain discharge plan before a 12 patient is discharged; defining a certain term; and generally relating to ASAM 13 criteria assessments in alcohol and drug abuse program facilities.

- 23 (A) IN THIS SECTION, "ASAM CRITERIA" MEANS THE NATIONALLY 24 RECOGNIZED COMPREHENSIVE GUIDELINES ESTABLISHED BY THE AMERICAN

- 4 (B) A CERTIFIED ALCOHOL AND DRUG ABUSE PROGRAM FACILITY SHALL
- 5 PROVIDE A PATIENT WITH A COPY OF THE PATIENT'S TREATMENT RECORDS ON THE
- 6 REQUEST OF THE PATIENT.
- 7 (C) WITHIN 72 HOURS AFTER COMPLETING AN ASAM CRITERIA
- 8 ASSESSMENT, THE MEMBERS OF A PATIENT'S ASAM CRITERIA ASSESSMENT TEAM
- 9 SHALL MEET WITH THE PATIENT TO EXPLAIN OR CLARIFY THE PATIENT'S

- 11 (1) HOW THE ASSESSMENT RESULTS IMPACT DISCHARGE PLANNING;
- 12 (2) THE PATIENT'S DISCHARGE OPTIONS BASED ON THE RESULTS OF

- 14 (3) THE TREATMENT PROVIDERS SPECIFIED FOR THE PATIENT'S
- 15 NEXT LEVEL OF CARE.
- 16 (D) IF THE RESULTS OF A PATIENT'S ASAM CRITERIA ASSESSMENT
- 17 INDICATE THAT A PATIENT SHOULD RECEIVE RESIDENTIAL TREATMENT OR
- 18 TREATMENT IN A HALFWAY HOUSE, THE CERTIFIED ALCOHOL AND DRUG ABUSE
- 19 PROGRAM FACILITY SHALL SEND THE APPROPRIATE APPLICATION RECORDS TO THE
- 20 TREATMENT PROVIDER OF THE PATIENT'S NEXT LEVEL OF CARE WITHIN 72 HOURS
- 21 AFTER COMPLETING THE ASSESSMENT.
- 22 (E) THE PATIENT'S TREATMENT PROVIDER AT THE CERTIFIED ALCOHOL
- 23 AND DRUG ABUSE PROGRAM FACILITY SHALL PROVIDE DIRECT PATIENT
- 24 REFERRALS TO ANY OTHER TREATMENT PROVIDERS SPECIFIED IN THE RESULTS OF
- 25 THE PATIENT'S ASAM CRITERIA ASSESSMENT AND THE PATIENT'S DISCHARGE
- 26 PLAN.
- 27 (F) A PATIENT MAY REQUEST THAT AN INDIVIDUAL OF THE PATIENT'S
- 28 CHOOSING BE DESIGNATED AS THE PATIENT'S PERSONAL REPRESENTATIVE TO
- 29 ADVOCATE AND SPEAK FOR THE PATIENT FOR THE PURPOSE OF CREATING A
- 30 DISCHARGE PLAN BASED ON THE RESULTS OF THE PATIENT'S ASAM CRITERIA
- 31 ASSESSMENT.
- 32 (G) THE PATIENT AND THE PATIENT'S TREATMENT PROVIDER SHALL SIGN
- 33 THE PATIENT'S DISCHARGE PLAN BEFORE THE PATIENT MAY BE DISCHARGED.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2018.
