CHAPTER _____

1 AN ACT concerning

Education – Juvenile Services Education Programs – Management and Operation

4 FOR the purpose of authorizing a certain individual to be employed or contracted to provide $\mathbf{5}$ certain services for a certain time period with a certain salary; establishing the 6 Juvenile Services Education County Pilot Program; requiring the Program to begin 7 in a certain school year; providing for the purpose of the Program; requiring the State 8 Department of Education, after consultation with certain county boards of education, 9 to identify a certain number of juvenile services education programs in certain 10 locations program to participate in the Program; requiring a certain county board to follow certain laws and regulations and ensure that certain individuals have access 11 12to certain curricula materials; authorizing a certain county board to employ or 13 contract with certain teachers for a certain time period and to be paid at a salary 14determined by the county board; requiring the State to provide funding to a certain 15county board in a certain amount; requiring the Department to convene a certain 16 workgroup on or before a certain date; providing for the composition, chair, and 17staffing of the workgroup; prohibiting a member of the workgroup from receiving 18 certain compensation, but authorizing the reimbursement of certain expenses; 19 requiring the workgroup to study certain issues and make certain recommendations 20related to the management and operation of juvenile services education programs; 21 requiring the workgroup to report its findings and recommendations to the Governor 22and the General Assembly on or before a certain date; defining certain terms;

17 (a) [An] EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, AN 18 individual who is employed as a teacher, librarian, principal, director of education, or 19 supervisor of vocational education on the staffs of the following institutions or in the 20 following programs, or an individual who is employed as a central office director, 21 superintendent, specialist, or coordinator of education for the following institutions or 22 programs, shall be paid the annual salary determined under subsection (b) of this section:

33 (b) (1) There shall be a single, statewide institutional educator pay plan for 34 the positions described under subsection (a) of this section. The pay plan shall be

1 established by the Department of Budget and Management as provided in paragraph (2) of

2 this subsection.

3 (2)In establishing and administering the pay plan, the Secretary of Budget and Management on an annual basis shall review the salaries of public school teachers, 4 librarians, and administrators in the six jurisdictions with the highest number of $\mathbf{5}$ institutional educator positions and shall recommend salaries at levels that will be 6 7 adequate to recruit and retain qualified institutional educators. The pay plan shall include 8 classifications and pay grades based on the duties, responsibilities, education, and training 9 required. The Secretary's recommendations shall be made by December 1 of each year for implementation on July 1 of the following fiscal year. 10

11 (3) The Secretary of Budget and Management shall submit any 12 recommendations to the Governor for approval.

 AMOUNT FOR THE CURRENT FISCAL YEAR DIVIDED BY THE NUMBER OF WEEKDAYS
 IN A FISCAL YEAR.

(2) THE PROGRAM SHALL BEGIN IN THE 2018–2019 SCHOOL YEAR.

6 (3) THE PURPOSE OF THE PROGRAM IS TO PILOT A MANAGEMENT 7 MODEL WHERE A JUVENILE SERVICES EDUCATION PROGRAM AT A FACILITY 8 LOCATED IN A COUNTY IS OPERATED BY THE COUNTY BOARD OF EDUCATION.

9 (C) THE DEPARTMENT, AFTER CONSULTATION WITH THE COUNTY BOARDS 10 OF EDUCATION, SHALL IDENTIFY UP TO THREE ONE JUVENILE SERVICES 11 EDUCATION PROGRAMS AT FACILITIES THAT ARE EACH LOCATED IN A DIFFERENT 12 COUNTY PROGRAM TO PARTICIPATE IN THE PROGRAM.

28 29	SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2018. Section 2 of this Act shall remain effective for a period of 2 years and, at the end of

30 June 30, 2020, Section 2 of this Act, with no further action required by the General 31 Assembly, shall be abrogated and of no further force and effect.
