## A BILL ENTITLED

### 1 AN ACT concerning

# 2 Creation of a State Debt – Washington County – Hagerstown Paper and Plastic 3 Plant

FOR the purpose of authorizing the creation of a State Debt not to exceed \$1,000,000, the
proceeds to be used as a grant to the Board of Trustees of the Blind Industries and
Services of Maryland for certain development or improvement purposes; providing
for disbursement of the loan proceeds, subject to a requirement that the grantee
provide and expend a matching fund; establishing a deadline for the encumbrance
or expenditure of the loan proceeds; and providing generally for the issuance and
sale of bonds evidencing the loan.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,That:

13(1)The Board of Public Works may borrow money and incur indebtedness on 14behalf of the State of Maryland through a State loan to be known as the Washington County - Hagerstown Paper and Plastic Plant Loan of 2018 in a total principal amount equal to 1516the lesser of (i) \$1,000,000 or (ii) the amount of the matching fund provided in accordance 17with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and delivery of 18 State general obligation bonds authorized by a resolution of the Board of Public Works and 19issued, sold, and delivered in accordance with §§ 8-117 through 8-124 and 8-131.2 of the 20State Finance and Procurement Article.

(2) The bonds to evidence this loan or installments of this loan may be sold as a
single issue or may be consolidated and sold as part of a single issue of bonds under §
8–122 of the State Finance and Procurement Article.

(3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer and first shall be applied to the payment of the expenses of issuing, selling, and delivering the bonds, unless funds for this purpose are otherwise provided, and then shall be credited on

the books of the Comptroller and expended, on approval by the Board of Public Works, for the following public purposes, including any applicable architects' and engineers' fees: as a grant to the Board of Trustees of the Blind Industries and Services of Maryland (referred to hereafter in this Act as "the grantee") for the acquisition, planning, design, construction, repair, renovation, reconstruction, site improvement, and capital equipping of a paper and plastic manufacturing facility, located in Washington County.

7 (4) An annual State tax is imposed on all assessable property in the State in rate 8 and amount sufficient to pay the principal of and interest on the bonds, as and when due 9 and until paid in full. The principal shall be discharged within 15 years after the date of 10 issuance of the bonds.

11 Prior to the payment of any funds under the provisions of this Act for the (5)12purposes set forth in Section 1(3) above, the grantee shall provide and expend a matching 13fund. No part of the grantee's matching fund may be provided, either directly or indirectly, 14from funds of the State, whether appropriated or unappropriated. No part of the fund may 15consist of real property, in kind contributions, or funds expended prior to the effective date 16of this Act. In case of any dispute as to the amount of the matching fund or what money or 17assets may qualify as matching funds, the Board of Public Works shall determine the 18matter and the Board's decision is final. The grantee has until June 1, 2020, to present evidence satisfactory to the Board of Public Works that a matching fund will be provided. 1920If satisfactory evidence is presented, the Board shall certify this fact and the amount of the 21matching fund to the State Treasurer, and the proceeds of the loan equal to the amount of 22the matching fund shall be expended for the purposes provided in this Act. Any amount of 23the loan in excess of the amount of the matching fund certified by the Board of Public Works 24shall be canceled and be of no further effect.

(6) The proceeds of the loan must be expended or encumbered by the Board of Public Works for the purposes provided in this Act no later than June 1, 2025. If any funds authorized by this Act remain unexpended or unencumbered after June 1, 2025, the amount of the unencumbered or unexpended authorization shall be canceled and be of no further effect. If bonds have been issued for the loan, the amount of unexpended or unencumbered bond proceeds shall be disposed of as provided in § 8–129 of the State Finance and Procurement Article.
