3 Oversight Committee on Quality of Care in Nursing Homes and Assisted Living  
4 Facilities – Revisions

5 FOR the purpose of ~~requiring the Department of Aging to study the quality of care in~~  
6 ~~nursing homes in Maryland; requiring the Department to review, assess, and~~  
7 ~~examine certain matters related to the quality of care in nursing homes; requiring~~  
8 ~~the Department to report its findings and recommendations to the Governor and the~~  
9 ~~General Assembly on or before a certain date; and generally relating to the study of~~  
10 ~~quality of care in nursing homes in Maryland~~ altering the membership, powers, and  
11 duties of the Oversight Committee on Quality of Care in Nursing Homes and  
12 Assisted Living Facilities; providing that the designee of the Secretary of Aging may  
13 chair the Oversight Committee; requiring the Oversight Committee to review  
14 changes to the membership and duties of the Oversight Committee enacted by this  
15 Act and make certain recommendations to the Senate Finance Committee and the  
16 House Health and Government Operations Committee on or before a certain date;  
17 providing for the construction of this Act; and generally relating to the Oversight  
18 Committee on Quality of Care in Nursing Homes and Assisted Living Facilities.

3 ~~(a) The Department of Aging shall study the quality of care in nursing homes in~~

5 ~~(b) As part of the study required under subsection (a) of this section, the~~  
 6 ~~Department shall:~~

7 ~~(1) examine and assess the number and types of complaints made to the~~  
 8 ~~Office of Health Care Quality regarding patient care in nursing homes;~~

9 ~~(2) examine and assess the results of scheduled and unscheduled nursing~~  
 10 ~~home inspections by the Office of Health Care Quality;~~

11 ~~(3) review the number and the level of compensation of inspectors~~

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
 19 That the Laws of Maryland read as follows:

20 Article – Health – General

21 19–1409.

22 (a) There is an Oversight Committee on Quality of Care in Nursing Homes and  
 23 Assisted Living Facilities.

24 (b) The Oversight Committee shall consist of the following members:

25 (1) One member of the Senate Finance Committee, appointed by the  
 26 President of the Senate;

27 (2) One member of the Senate Education, Health, and Environmental  
 28 Affairs Committee, appointed by the President of the Senate;

29 (3) Two members of the House Health and Government Operations  
 30 Committee, appointed by the Speaker of the House;

1           (4) The Secretary [of the Department] of Aging, OR THE SECRETARY'S  
2 DESIGNEE;

3           (5) The Secretary of Health, or the Secretary's designee;

4           (6) THE DIRECTOR OF THE OFFICE OF HEALTH CARE QUALITY, OR  
5 THE DIRECTOR'S DESIGNEE;

6           [(6)] (7) One representative from the Maryland Department of Health's  
7 Behavioral Health Administration, APPOINTED BY THE DEPUTY SECRETARY FOR  
8 BEHAVIORAL HEALTH;

9           [(7)] (8) The Secretary of Human Services, or the Secretary's designee;

10          (9) THE SECRETARY OF DISABILITIES, OR THE SECRETARY'S  
11 DESIGNEE;

12          (10) THE STATE LONG-TERM CARE OMBUDSMAN;

13          [(8)] (11) [Three] TWO representatives of area agencies on aging, one of  
14 which shall be a member of a local long-term care ombudsman program established under  
15 Title 10, Subtitle 9 of the Human Services Article, [appointed by the Secretary of Aging]  
16 SELECTED BY THE PRESIDENT OF THE MARYLAND ASSOCIATION OF AREA  
17 AGENCIES ON AGING;

18          (12) ONE REPRESENTATIVE OF A LOCAL LONG-TERM CARE  
19 OMBUDSMAN ENTITY, SELECTED BY THE STATE LONG-TERM CARE OMBUDSMAN;

20          (13) THREE CONSUMER MEMBERS, SELECTED BY THE STATE  
21 LONG-TERM CARE OMBUDSMAN, ALL OF WHOM SHALL BE CONSUMERS LIVING IN  
22 AN ASSISTED LIVING FACILITY OR A NURSING HOME OR HAVE A FAMILY MEMBER  
23 LIVING IN AN ASSISTED LIVING FACILITY OR A NURSING HOME; AND

24          (14) THE FOLLOWING REPRESENTATIVES, SELECTED BY THE  
25 ORGANIZATIONS THE INDIVIDUAL REPRESENTS:

26           [(9)] (I) One representative from the Health Facilities Association of  
27 Maryland;

28           [(10)] (II) One representative from the Mid-Atlantic LifeSpan;

29           [(11)] (III) One representative of the Hospice Network of Maryland;

30           [(12)] (IV) One representative of the Maryland Hospital Association;

1 [(13)] (V) One representative of [the Service Employees International  
 2 Union] 1199SEIU UNITED HEALTH WORKERS EAST;

3 [(14)] (VI) One representative of the Maryland Chapter of AARP;

4 [(15)] (VII) One representative of United Seniors of Maryland;

5 [(16)] (VIII) One representative of Voices for Quality Care;

6 [(17)] (IX) One representative of the Mental Health Association OF  
 7 MARYLAND knowledgeable in [elderly] issues OF AGING;

8 [(18)] (X) One representative of the Greater Maryland Chapter of the  
 9 Alzheimer's Association;

10 [(19) Three representatives from the assisted living industry, of which one  
 11 shall represent a program that cares for one to four residents, one shall represent a program  
 12 that cares for five to nine residents, and one shall represent a program that cares for more  
 13 than 10 residents; and

14 (20) Three consumer members appointed by the Governor, one of whom  
 15 shall be a consumer living in an assisted living facility] AND

16 (XI) ONE REPRESENTATIVE OF THE MARYLAND ASSOCIATION  
 17 OF ADULT DAY SERVICES.

18 (c) The Secretary of Aging, OR THE SECRETARY'S DESIGNEE, shall chair the  
 19 Oversight Committee.

20 (d) The Oversight Committee shall evaluate the progress in improving nursing  
 21 home care quality and assisted living facility quality statewide, [including] WHICH MAY  
 22 INCLUDE consideration of:

23 (1) Quality of care standards for nursing homes and assisted living  
 24 facilities;

25 (2) Standards for the identification of the onset of dementia and  
 26 Alzheimer's disease;

27 (3) Standards for the identification of conditions appropriate for hospice  
 28 services;

29 (4) Staffing patterns and staffing standards;

30 (5) Policies and procedures for inspecting nursing homes and assisted  
 31 living facilities, and responding to quality of care complaints;

1           (6) A comparison of Maryland standards, policies, and procedures to those  
2 in other states;

3           (7) The labor pool available to fill nursing and nursing aide jobs;

4           (8) State funding mechanisms for nursing homes and assisted living  
5 facilities, including the Medicaid Nursing Home Reimbursement System, **POTENTIAL**  
6 **BARRIERS TO ELIGIBILITY IN THE MARYLAND MEDICAL ASSISTANCE PROGRAM,**  
7 **POTENTIAL BARRIERS TO THE TIMELY PAYMENT OF CLAIMS SUBMITTED TO THE**  
8 **MARYLAND MEDICAL ASSISTANCE PROGRAM,** and regulation of nursing homes; [and]

9           (9) The provision and quality of [mental] **DEMENTIA CARE** and behavioral  
10 health [care] **SUPPORTS AND** services to meet the needs of nursing home and assisted  
11 living facility residents;

12           **(10) STAFF TRAINING AND DEVELOPMENT;**

13           **(11) THE RIGHTS OF RESIDENTS;**

14           **(12) DATA ON RESIDENT SATISFACTION;**

15           **(13) RESIDENT ASSESSMENTS;**

16           **(14) RESIDENT CARE PLANNING;**

17           **(15) THE MONITORING OF RESIDENTS; AND**

18           **(16) THE CHANGE OF RESIDENT STATUS.**

19           (e) The Office of Health Care Quality in the Maryland Department of Health shall  
20 submit a report to the Oversight Committee annually on the status of quality of care in  
21 nursing homes and assisted living facilities.

22           (f) The Deputy Secretary of Health Care Financing, or the Deputy Secretary's  
23 designee, shall report annually to the Oversight Committee on the status of the Medicaid  
24 Nursing Home Reimbursement System, which shall include but not be limited to:

25           (1) Elements of the existing methodology that are no longer relevant;

26           (2) Elements of the existing methodology that can be revised;

27           (3) The appropriateness of redesigning the system given changing  
28 demographics of the target population; and

1           (4) General Fund and federal fund savings from a system redesign that  
 2 may be redirected to nursing home staff development in the nursing cost center.

3           (g) The Oversight Committee shall review the reports of the Office of Health Care  
 4 Quality and the Deputy Secretary of Health Care Financing and develop recommendations  
 5 to continue improvement in nursing home and assisted living facility care.

6           (H) THE OVERSIGHT COMMITTEE MAY:

7           (1) REVIEW LEGISLATION INTRODUCED IN THE GENERAL ASSEMBLY  
 8 THAT MAY AFFECT NURSING HOME AND ASSISTED LIVING FACILITY CARE; AND

9           (2) MAKE RECOMMENDATIONS ABOUT THE LEGISLATION TO THE  
 10 GENERAL ASSEMBLY.

11           (I) THE OVERSIGHT COMMITTEE MAY:

12           (1) REVIEW PROPOSED REGULATIONS THAT MAY AFFECT NURSING  
 13 HOME AND ASSISTED LIVING FACILITY CARE; AND

14           (2) MAKE RECOMMENDATIONS ABOUT THE REGULATIONS TO THE  
 15 DEPARTMENTS PROPOSING THE REGULATIONS AND TO THE JOINT COMMITTEE ON  
 16 ADMINISTRATIVE, EXECUTIVE, AND LEGISLATIVE REVIEW.

17           [(h)] (J) The Oversight Committee shall report its findings and  
 18 recommendations to the Governor and, subject to § 2–1246 of the State Government Article,  
 19 to the General Assembly on or before December 1 of each year.

20           [(i)] (K) The Department of Aging, with assistance from the Maryland  
 21 Department of Health, the Department of Human Services, and the Department of  
 22 Legislative Services, shall provide staff support for the Oversight Committee.

23           SECTION 2. AND BE IT FURTHER ENACTED, That, on or before November 1,  
 24 2018, the Oversight Committee on Quality of Care in Nursing Homes and Assisted Living  
 25 Facilities shall review the changes to the membership and duties of the Oversight  
 26 Committee enacted by this Act and, subject to § 2–1246 of the State Government Article,  
 27 make recommendations on any additional legislative changes that may be necessary to the  
 28 Senate Finance Committee and the House Health and Government Operations Committee.

29           SECTION 3. AND BE IT FURTHER ENACTED, That § 19–1409(b) of the Health –  
 30 General Article, as enacted by Section 1 of this Act, may not be construed to require the  
 31 resignation or replacement of any members currently serving on the Oversight Committee  
 32 on Quality of Care in Nursing Homes and Assisted Living Facilities solely on the basis of  
 33 who selected or appointed the individual to serve on the Oversight Committee.

1 SECTION ~~2~~ 4. AND BE IT FURTHER ENACTED, That this Act shall take effect  
2 June 1, 2018.
