1 AN ACT concerning

2 **Maryland Chiropractic Act – Revisions**

3 FOR the purpose of repealing a requirement that the State Board of Chiropractic
4 Examiners issue paper copies of licenses; prohibiting, under certain circumstances,
5 an applicant for a license to practice chiropractic from being required under a certain
6 provision of law to hold a bachelor's degree; altering the number of sets of
7 fingerprints a certain applicant for licensure is required to submit to the Criminal
8 Justice Information System Central Repository of the Department of Public Safety
9 and Correctional Services; requiring the Central Repository to forward to the Board
10 certain information regarding a certain applicant's criminal history record
11 information under certain circumstances; repealing the authority of the Board to
12 accept, under certain circumstances, an alternate method of criminal history records
13 check as approved by the Director of the Central Repository and the Director of the
14 Federal Bureau of Investigation; authorizing the Board to grant an extern license to
15 an individual who meets certain requirements; establishing the qualifications for an
16 extern license; providing for the term and termination of an extern license; requiring
17 the Board to maintain an electronic roster of certain individuals licensed by the
18 Board; requiring the electronic roster to be available on the Board's website;
19 authorizing certain individuals to contact the Board to verify a license; requiring a
20 certain electronic license record to include certain information; ~~requiring certain~~
21 ~~applicants and licensees to submit to a mental health or physical examination under~~
22 ~~certain circumstances; providing that certain applicants or licensees are deemed to~~
23 ~~have consented to a certain mental health examination and waived certain claims~~

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

That the Laws of Maryland read as follows:

Article – Health Occupations

3–101.

(a) In this title the following words have the meanings indicated.

(b) “Board” means the State Board of Chiropractic Examiners.

(c) “Chiropractor” means an individual who practices chiropractic.

(D) “EXTERN LICENSE” MEANS A LICENSE TO PRACTICE CHIROPRACTIC UNDER THE SUPERVISION OF A BOARD-APPROVED LICENSED CHIROPRACTOR.

~~[(d)]~~ **(E)** “License” means, unless the context requires otherwise, a license ~~[issued]~~ **GRANTED** by the Board:

(1) To practice chiropractic; or

(2) To practice chiropractic with the right to practice physical therapy.

1 (2) An individual licensed to practice chiropractic in any other state or a
2 foreign country while that individual makes a clinical demonstration before:

3 (i) A chiropractic association;

4 (ii) A chiropractic convention; or

5 (iii) A chiropractic college.

6 3–302.

7 (a) To qualify for a license, an applicant shall be an individual who:

8 (1) Submits to a criminal history records check in accordance with §
9 3–302.1 of this subtitle;

10 (2) Meets the requirements of this section; and

11 (3) Meets the examination requirements of this title.

12 (b) The applicant shall be of good moral character.

13 (c) Except as otherwise provided in this title, the applicant shall:

14 (1) (i) Hold a bachelor’s degree from a college or university approved by
15 an accrediting agency of the United States Department of Education; and

16 (ii) Have completed satisfactorily college courses required by the
17 Board; and

18 (2) (i) Be a graduate of a school of chiropractic that has been approved
19 by the Board under § 3–402 of this title; or

20 (ii) 1. Be licensed in another state for at least 2 years; and

21 2. Be a graduate of a school of chiropractic:

22 A. That has been approved by the Council on Chiropractic
23 Education within 4 years after the applicant graduated from that school; and

24 B. That the Board determines had standards comparable to
25 an approved school at the time the applicant graduated.

26 (d) An applicant shall be entitled to a license to practice chiropractic with the
27 right to practice physical therapy if the applicant:

1 (1) Satisfies the requirements of this section and §§ 3–303 and 3–304(e)(2)
2 of this subtitle;

3 (2) Was licensed as a chiropractor on or before June 1, 1949; or

4 (3) Was enrolled at an approved college of chiropractic on June 1, 1949, and
5 later was graduated by that college and licensed.

6 **(E) AN APPLICANT MAY NOT BE REQUIRED UNDER SUBSECTION (C)(1)(I) OF**
7 **THIS SECTION TO HOLD A BACHELOR’S DEGREE IF THE APPLICANT:**

8 **(1) GRADUATED FROM A SCHOOL OF CHIROPRACTIC BEFORE JULY 1,**
9 **1999; AND**

10 **(2) MEETS THE EDUCATIONAL REQUIREMENTS IN PLACE AT THE**
11 **TIME OF THE APPLICANT’S GRADUATION FROM A SCHOOL OF CHIROPRACTIC.**

12 3–302.1.

13 (a) In this section, “Central Repository” means the Criminal Justice Information
14 System Central Repository of the Department of Public Safety and Correctional Services.

15 (b) As part of an application to the Central Repository for a State and national
16 criminal history records check, an applicant shall submit to the Central Repository:

17 (1) **[Two complete sets] ONE COMPLETE SET** of legible fingerprints taken
18 on forms approved by the Director of the Central Repository and the Director of the Federal
19 Bureau of Investigation;

20 (2) The fee authorized under § 10–221(b)(7) of the Criminal Procedure
21 Article for access to State criminal history records; and

22 (3) The processing fee required by the Federal Bureau of Investigation for
23 a national criminal history records check.

24 (c) In accordance with §§ 10–201 through 10–228 of the Criminal Procedure
25 Article, the Central Repository shall forward to the Board and to the applicant the criminal
26 history record information of the applicant.

27 **[(d) If an applicant has made three or more unsuccessful attempts at securing**
28 **legible fingerprints, the Board may accept an alternate method of a criminal history records**
29 **check as permitted by the Director of the Central Repository and the Director of the Federal**
30 **Bureau of Investigation.]**

31 **(D) IF CRIMINAL HISTORY RECORD INFORMATION IS REPORTED TO THE**
32 **CENTRAL REPOSITORY AFTER THE DATE OF THE INITIAL CRIMINAL HISTORY**

1 **RECORDS CHECK, THE CENTRAL REPOSITORY SHALL PROVIDE TO THE BOARD A**
2 **REVISED PRINTED STATEMENT OF THE INDIVIDUAL'S CRIMINAL HISTORY RECORD.**

3 (e) Information obtained from the Central Repository under this section:

4 (1) Is confidential and may not be redisseminated; and

5 (2) May be used only for the licensing [or registration] purpose authorized
6 by this title.

7 (f) The subject of a criminal history records check under this section may contest
8 the contents of the printed statement issued by the Central Repository as provided in §
9 10–223 of the Criminal Procedure Article.

10 **3–305.1.**

11 (A) **THE BOARD MAY GRANT, AS APPROPRIATE, AN EXTERN LICENSE TO AN**
12 **INDIVIDUAL WHO MEETS THE REQUIREMENTS OF THIS SECTION.**

13 (B) **TO QUALIFY FOR AN EXTERN LICENSE, AN APPLICANT SHALL BE AN**
14 **INDIVIDUAL SEEKING TO PARTICIPATE IN A CHIROPRACTIC EXTERNSHIP WHO:**

15 (1) **SUBMITS AN APPLICATION PROVIDED BY THE BOARD;**

16 (2) **HAS GRADUATED FROM AN ACCREDITED CHIROPRACTIC**
17 **COLLEGE;**

18 (3) **HAS BEGUN THE PROCESS OF APPLYING TO THE BOARD FOR A**
19 **LICENSE TO PRACTICE CHIROPRACTIC, BUT WHO HAS NOT MET CERTAIN**
20 **REQUIREMENTS, SPECIFIED IN REGULATION, TO QUALIFY FOR A LICENSE;**

21 (4) **HAS TAKEN AND PASSED THE EXAMINATION OF THE NATIONAL**
22 **BOARD OF CHIROPRACTIC EXAMINERS;**

23 (5) **AGREES TO PRACTICE UNDER THE SUPERVISION OF A**
24 **BOARD-APPROVED SUPERVISOR WHO IS A LICENSED CHIROPRACTOR WHILE THE**
25 **EXTERN LICENSE IS IN EFFECT; AND**

26 (6) **PAYS THE LICENSE FEE SET BY THE BOARD.**

27 (C) **THE APPLICANT SHALL BE OF GOOD MORAL CHARACTER.**

28 (D) (1) **THE TERM OF AN EXTERN LICENSE IS THE LESSER OF:**

1 **(I) THE DURATION OF THE INDIVIDUAL’S PARTICIPATION IN**
 2 **THE CHIROPRACTIC EXTERNSHIP; OR**

3 **(II) 6 MONTHS FROM THE DATE OF THE BOARD’S APPROVAL OF**
 4 **THE EXTERNSHIP APPLICATION.**

5 **(2) THE TERM OF AN EXTERN LICENSE SHALL TERMINATE ON THE**
 6 **EARLIER OF:**

7 **(I) THE DATE THE INDIVIDUAL’S CHIROPRACTIC EXTERNSHIP**
 8 **TERMINATES; OR**

9 **(II) THE DATE THE INDIVIDUAL IS LICENSED BY THE BOARD TO**
 10 **PRACTICE CHIROPRACTIC WITHOUT THE SUPERVISION OF A BOARD–APPROVED**
 11 **LICENSED CHIROPRACTOR.**

12 3–306.

13 (a) Subject to subsection [(c)] **(D)** of this section, the Board shall [issue a] license
 14 [to any] **AN** applicant who[:

15 (1) Pays a license fee set by the Board; and

16 (2) Otherwise meets] **MEETS** the requirements of this title.

17 **(B) (1) THE BOARD SHALL MAINTAIN AN ELECTRONIC ROSTER OF EACH**
 18 **INDIVIDUAL LICENSED BY THE BOARD.**

19 **(2) THE ROSTER SHALL BE AVAILABLE FOR THE PURPOSE OF**
 20 **ELECTRONICALLY VERIFYING LICENSURE ON THE BOARD’S WEBSITE.**

21 **(3) INDIVIDUALS WITHOUT ACCESS TO THE BOARD’S WEBSITE MAY**
 22 **CONTACT THE BOARD TO VERIFY A LICENSE.**

23 [(b)] **(C)** The Board shall include on each **ELECTRONIC** license [that it issues]
 24 **RECORD:**

25 (1) [Its seal] **THE FULL NAME OF THE LICENSEE; [and]**

26 **(2) A LICENSE NUMBER;**

27 [(2)] **(3)** Designations that clearly distinguish between those licensees
 28 who may practice [chiropractic]:

29 **(I) CHIROPRACTIC [and those who may practice chiropractic];**

1 (II) CHIROPRACTIC with the right to practice physical therapy;

2 AND

3 (III) CHIROPRACTIC UNDER THE SUPERVISION OF A
4 BOARD-APPROVED LICENSED CHIROPRACTOR;

5 (4) THE STATUS OF THE LICENSE;

6 (5) THE EXPIRATION DATE OF THE LICENSE; AND

7 (6) THE ORIGINAL DATE OF LICENSURE.

8 [(c)] (D) (1) On receipt of the criminal history record information of an
9 applicant for licensure [or registration] forwarded to the Board in accordance with §
10 3-302.1 of this subtitle, in determining whether to grant a license [or registration], the
11 Board shall consider:

12 (i) The age at which the crime was committed;

13 (ii) The circumstances surrounding the crime;

14 (iii) The length of time that has passed since the crime;

15 (iv) Subsequent work history;

16 (v) Employment and character references; and

17 (vi) Any other evidence that demonstrates whether the applicant
18 poses a threat to the public health or safety.

19 (2) The Board may not [issue a license or registration] LICENSE AN
20 APPLICANT if the criminal history record information required under § 3-302.1 of this
21 subtitle has not been received.
