Correctional Officers' Retirement System - Membership

- 3 FOR the purpose of altering the membership of the Correctional Officers' Retirement 4 System to include certain individuals serving in certain positions in the Department 5 of Public Safety and Correctional Services; providing that certain members of the 6 Correctional Officers' Retirement System who meet certain criteria may receive a 7 normal service retirement allowance that is based on certain creditable service; requiring the State Retirement Agency, on or before a certain date, to notify certain 8 9 individuals affected by this Act of their rights to transfer certain service credit to the 10 Correctional Officers' Retirement System; and generally relating to membership in 11 the Correctional Officers' Retirement System.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 18 That the Laws of Maryland read as follows:

- 21 (a) Except as provided in subsection (b) of this section, this subtitle applies only 22 to:
- 23 (1) correctional officers serving in any of the first six job classifications;



2 3 4	(3) a detention center officer employed by a participating governmental unit that on or after July 1, 2006, has elected to participate in the Correctional Officers' Retirement System;

7 8	(5) an individual serving as a Maryland Correctional Enterprises officer, officer trainee, plant supervisor, plant manager, or regional manager;
9 10	(6) a correctional officer serving as a security chief, a facility administrator, an assistant warden, or a warden who:
11	(i) begins employment in that position on or after July 1, 2014; or
12 13	(ii) is serving in that position on June 30, 2014, and elects to transfer to the Correctional Officers' Retirement System from:

1 (ii) a mental health professional counselor, graduate professional 2 counselor, professional counselor advanced, or professional supervisor; 3 (iii) a psychologist, psychology associate, or psychology associate 4 doctorate; 5 a social worker, social worker advanced, social worker (iv) 6 supervisor, or social work regional supervisor; or 7 (v) a recreation officer or supervisor; 8 (10) AN INDIVIDUAL SERVING AS A PAROLE AND PROBATION ASSISTANT REGIONAL ADMINISTRATOR ON OR AFTER JULY 1, 2018; 9 10 (11) AN INDIVIDUAL SERVING AS A PSYCHOLOGY SERVICES CHIEF ON 11 OR AFTER JULY 1, 2018; AND 12 (12) AN INDIVIDUAL SERVING AS A CORRECTIONAL MAINTENANCE 13 SERVICES ADMINISTRATOR ON OR AFTER JULY 1, 2018. 14 This subtitle does not apply to: (b) 15 (1) an employee of the Baltimore City Jail as of June 30, 1991, who: 16 (i) became an employee of the Baltimore City Detention Center on 17 July 1, 1991; and 18 did not elect to become a member of the Correctional Officers' (ii) 19 Retirement System on that date; 20 a detention center officer employed by a participating governmental (2)21unit as a local detention center officer on the effective date of participation on or after July 221, 2006, who did not elect to become a member of the Correctional Officers' Retirement System within 6 months of the effective date of participation; or 23 24a correctional officer serving as a security chief, a facility administrator, an assistant warden, or a warden who is in that position on June 30, 2014, and does not 25 26 elect to transfer membership to the Correctional Officers' Retirement System from: 27 the Employees' Pension System on or before December 31, 2014; (i) 28 or 29 the Employees' Retirement System on or before December 31, (ii) 30 2015.

16 17 18	(i) a correctional case management specialist, supervisor, or manager who has a combined total of 20 years of eligibility service as provided in subsection (a)(1)(ii) of this section; [or]
19 20 21	(ii) a member serving in a position specified in $\S 25-201(a)(8)$ or (9) of this title who has a combined total of 20 years of eligibility service as provided in subsection (a)(1)(iii) of this section; OR
22 23 24 25	(III) A MEMBER SERVING IN A POSITION SPECIFIED IN § 25–201(A)(10), (11), OR (12) OF THIS TITLE WHO HAS A COMBINED TOTAL OF 20 YEARS OF ELIGIBILITY SERVICE AS PROVIDED IN SUBSECTION (A)(1)(IV) OF THIS SECTION.
26 27 28	(2) A member is entitled to receive a normal service retirement allowance that equals an allowance based on the creditable service the member has in the Correctional Officers' Retirement System.

AND BE IT FURTHER ENACTED, That, on or before October 1, 2018, the State Retirement Agency shall notify the individuals who are affected by this Act of their right to transfer service credit from the Employees' Retirement System or the Employees' Pension System to the Correctional Officers' Retirement System.
