## 2 Electronic Nicotine Delivery Systems Retailer License - Sales Through Mail or 3 Electronic Network Licenses - Modifications

4 FOR the purpose of authorizing the holder of an electronic nicotine delivery systems 5 retailer license to make sales to consumers through the mail, a computer network, a 6 telephonic network, or another electronic network; repealing a certain authorization 7 relating to electronic nicotine delivery systems storage warehouses; authorizing the 8 holder of an electronic nicotine delivery systems wholesaler distributor license or an 9 electronic nicotine delivery systems wholesaler importer license to sell electronic 10 nicotine delivery systems to vape shop vendors; authorizing the holder of a vape shop vendor license to buy electronic nicotine delivery systems from an electronic nicotine 11 delivery systems wholesaler distributor or an electronic nicotine delivery systems 12 wholesaler importer; making this Act an emergency measure; and generally relating 13 to the sale of electronic nicotine delivery systems. 14

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

AND BE IT FURTHER ENACTED, That this Act is an emergence measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
