## A BILL ENTITLED

1 AN ACT concerning

## Crimes - Child Abuse and Neglect - Failure to Report

- FOR the purpose of establishing that certain persons who are required to provide certain notice or make certain reports of suspected child abuse or neglect may not knowingly fail to give the notice or make the report; establishing the misdemeanor of knowing failure to report child abuse or neglect under certain circumstances; providing certain penalties for a violation of this Act; and generally relating to child abuse and neglect.

is made under paragraph (1) of this subsection shall immediately notify the other agency. 1 2 This paragraph does not prohibit a local department and an (ii) 3 appropriate law enforcement agency from agreeing to cooperative arrangements. 4 Insofar as is reasonably possible, an individual who makes a report under this section shall include in the report the following information: 5 6 (1) the name, age, and home address of the child; 7 the name and home address of the child's parent or other person who is (2)8 responsible for the child's care; 9 (3)the whereabouts of the child; the nature and extent of the abuse or neglect of the child, including any 10 **(4)** 11 evidence or information available to the reporter concerning possible previous instances of 12abuse or neglect; and 13 (5)any other information that would help to determine: (i) the cause of the suspected abuse or neglect; and 14 15 (ii) the identity of any individual responsible for the abuse or neglect.
