## 2 Cybersecurity Investment Incentive Tax Credit - Eligibility, Appropriation, and 3 Sunset Extension Credits

FOR the purpose of altering the eligibility criteria for the cybersecurity investment incentive tax credit to provide the credit to a certain qualified investor in a certain qualified Maryland cybersecurity company rather than providing the credit to the company; altering the definition of "company" to include an entity that becomes duly organized and existing under certain laws and for a certain purpose within a certain time period; altering the definition of "investment" to include certain types of debt; altering the appropriation to a certain special fund the Governor is required to include each fiscal year in the budget bill; providing for the recapture of the credit under certain circumstances; authorizing certain buyers of certain technology to claim a credit against the State income tax for certain costs incurred to purchase certain technology or a certain service; providing that the credit may not exceed certain amounts under certain circumstances; authorizing the Department of Commerce, in consultation with the Maryland Technology Development Corporation, to establish a certain panel to assist the Department with certain determinations; authorizing certain qualified buyers to apply for the credit; requiring a qualified buyer to attach a certain certificate to the qualified buyer's income tax return; requiring the Secretary of Commerce to approve each application that qualifies for a credit; providing that for certain taxable years the total amount of credit certificates issued may not exceed certain amounts; providing for the revocation and recapture of a credit under certain circumstances; requiring the Department to make a certain report by a certain date each year; requiring the Department and the Comptroller jointly to adopt certain regulations; making

- (6) (i) "Investment" means the contribution of money in cash or cash equivalents expressed in United States dollars, at a risk of loss, to a qualified Maryland cybersecurity company in exchange for stock, a partnership or membership interest, or any other ownership interest in the equity of the qualified Maryland cybersecurity company, title to which ownership interest shall vest in the qualified investor.
- 9 (ii) "Investment" does not include debt <u>UNLESS IT IS CONVERTIBLE</u> 10 **DEBT**.
- 11 (iii) For purposes of this section, an investment is at risk of loss when 12 repayment entirely depends on the success of the business operations of the qualified 13 company.
- 14 (7) "Panel" means the panel that the Department may establish under 15 subsection (e) of this section composed of experts in the area of cybersecurity technology.
- 16 (8) (i) "Qualified investor" means any individual or entity that invests 17 at least \$25,000 in a qualified Maryland cybersecurity company and that is required to file 18 an income tax return in any jurisdiction.
- 19 (ii) "Qualified investor" does not include a qualified pension plan, an 20 individual retirement account, or any other qualified retirement plan under the Employee 21 Retirement Income Security Act of 1974, as amended, or fiduciaries or custodians under 22 such plans, or similar tax—favored plans or entities under the laws of other countries.
  - (9) "Qualified Maryland cybersecurity company" means a cybersecurity company that has met the criteria set forth in subsection [(c)(2)] (B)(2) of this section [and been determined under subsection (c)(3)(ii)2 of this section to qualify for the tax credit under this section].
  - (10) "Secretary" means the Secretary of Commerce.
- (b) (1) Subject to paragraph (2) of this subsection and subsections (d) and (f) of this section, for the taxable year in which an investment in a qualified Maryland cybersecurity company is made, a qualified [Maryland cybersecurity company] INVESTOR may claim a credit against the State income tax in an amount equal to the amount of tax credit stated in the final credit certificate approved by the Secretary for the investment as provided under this section.

14 15	(i) approve all applications that qualify for credits under this section on a first–come, first–served basis; and
16	(ii) within 30 calendar days of receipt of an application:
17 18	1. certify the amount of any approved tax credits to a qualified [Maryland cybersecurity company] INVESTOR; and
19 20	2. determine whether a cybersecurity company qualifies for investments that are eligible for the tax credit under this section.
21 22 23	[(4)] (2) (i) After the date on which the Department issues an initial tax credit certificate under this section, a qualified investor shall have 30 calendar days to make an investment in a qualified Maryland cybersecurity company under this section.
24 25 26 27	(ii) Within 10 calendar days after the date on which a qualified investor makes the investment, the qualified [Maryland cybersecurity company] INVESTOR shall provide to the Department notice and proof of the making of the investment, including:
28	1. the date of the investment;
29	2. the amount invested;

- 1 3. proof of the receipt of the invested funds by the qualified 2 Maryland cybersecurity company;
- 4. a complete description of the nature of the ownership 4 interest in the equity of the qualified Maryland cybersecurity company acquired in 5 consideration of the investment; and
- 5. any reasonable supporting documentation the 7 Department may require.
- 8 (iii) If a qualified [Maryland cybersecurity company] INVESTOR does 9 not provide the notice and proof of the making of the investment required in subparagraph 10 (ii) of this paragraph within 40 calendar days after the date on which the Department 11 issues an initial tax credit certificate under this section:
- 12 1. the Department shall rescind the initial tax credit 13 certificate; and
- 14 2. the credit amount allocated to the rescinded certificate 15 shall revert to the Maryland Cybersecurity Investment Tax Credit Reserve Fund and shall 16 be available in the applicable fiscal year for allocation by the Department to other initial 17 tax credit certificates in accordance with the provisions of this section.
- 18 (d) (1) The tax credit allowed in an initial tax credit certificate issued under 19 this section is:
- 20 (i) except as provided in item (ii) of this paragraph, 33% of the 21 investment in a qualified Maryland cybersecurity company, not to exceed \$250,000; or
- 22 (ii) if a qualified Maryland cybersecurity company is located in 23 Allegany County, Dorchester County, Garrett County, or Somerset County, 50% of the 24 investment in the qualified Maryland cybersecurity company, not to exceed \$500,000.
- 25 (2) During any fiscal year, the Secretary may not certify eligibility for tax 26 credits for investments in a single qualified Maryland cybersecurity company that in the 27 aggregate exceed 15% of the total appropriations to the Maryland Cybersecurity 28 Investment Tax Credit Reserve Fund for that fiscal year.
- 29 (3) If the credit allowed under this section in any taxable year exceeds the 30 State income tax for that taxable year, an individual or a corporation may claim a refund 31 in the amount of the excess.
- 32 (e) (1) The Department may establish a panel composed of experts in the area 33 of cybersecurity technology.
- 34 (2) The Department may establish the panel under service contracts with 35 independent reviewers.

- 1 (3) The panel shall assist the Department in its determination as to 2 whether a company is a qualified Maryland cybersecurity company.
- 3 (4) A member of the panel is not eligible to receive any benefit, direct or 4 indirect, from the tax credit under this section.
- 5 (5) (i) Except as provided in subparagraph (ii) of this paragraph, 6 Division II of the State Finance and Procurement Article does not apply to a service that 7 the Department obtains under this section.
- 8 (ii) The Department is subject to Title 12, Subtitle 4 of the State 9 Finance and Procurement Article for services the Department obtains under this section.
- 10 (f) (1) In this subsection, "Reserve Fund" means the Maryland Cybersecurity 11 Investment Tax Credit Reserve Fund established under paragraph (2) of this subsection.
- 12 (2) (i) There is a Maryland Cybersecurity Investment Tax Credit 13 Reserve Fund which is a special continuing, nonlapsing fund that is not subject to § 7–302 14 of the State Finance and Procurement Article.
- 15 (ii) The money in the Reserve Fund shall be invested and reinvested 16 by the Treasurer, and interest and earnings shall be credited to the General Fund.
- 17 (iii) The money in the Reserve Fund may be used by the Department 18 to pay the costs of administering the tax credit program under this section.
- 19 (3) (i) Subject to the provisions of this subsection, the Secretary shall 20 issue an initial tax credit certificate to a qualified [Maryland cybersecurity company] 21 INVESTOR for each approved investment in a qualified Maryland cybersecurity company 22 eligible for a tax credit.
  - (ii) An initial tax credit certificate issued under this subsection shall state the maximum amount of tax credit for which the qualified [Maryland cybersecurity company] INVESTOR is eligible.



- (iii) 1. Except as otherwise provided in this subparagraph, for any fiscal year, the Secretary may not issue initial tax credit certificates for credit amounts in the aggregate totaling more than the amount appropriated to the Reserve Fund for that fiscal year in the State budget as approved by the General Assembly, as reduced by the amount needed to pay the costs of administering the tax credit program under this section.
- 2. If the aggregate credit amounts under initial tax credit certificates issued in a fiscal year total less than the amount appropriated to the Reserve Fund for that fiscal year, any excess amount shall remain in the Reserve Fund and may be issued under initial tax credit certificates for the next fiscal year.

- 3. For any fiscal year, if funds are transferred from the Reserve Fund under the authority of any provision of law other than under paragraph (4) of this subsection, the maximum credit amounts in the aggregate for which the Secretary may issue initial tax credit certificates shall be reduced by the amount transferred.
- 5 (iv) 1. Except as provided in subsubparagraph 2 of this 6 subparagraph, for each fiscal year, the Governor shall include in the budget bill an 7 appropriation of at least [\$2,000,000] \$5,000,000 \$3,000,000 to the Reserve Fund.
- 8 2. In fiscal year 2016, the Governor shall include in the 9 budget bill an appropriation of at least \$1,500,000 to the Reserve Fund.
- 10 (v) Notwithstanding the provisions of § 7–213 of the State Finance 11 and Procurement Article, the Governor may not reduce an appropriation to the Reserve 12 Fund in the State budget as approved by the General Assembly.
- 13 (vi) Based on the actual amount of an investment made by a qualified 14 investor, the Secretary shall issue a final tax credit certificate to the qualified [Maryland 15 cybersecurity company] INVESTOR.
- 16 (4) (i) Except as otherwise provided in this paragraph, money 17 appropriated to the Reserve Fund shall remain in the Reserve Fund.
- 18 (ii) 1. Within 15 days after the end of each calendar quarter, the 19 Department shall notify the Comptroller as to each final credit certificate issued during the 20 quarter:
- A. the maximum credit amount stated in the initial tax credit certificate for the investment in the qualified Maryland cybersecurity company; and
- B. the final certified credit amount for the investment in the qualified Maryland cybersecurity company.
- 25 2. On notification that an investment has been certified, the Comptroller shall transfer an amount equal to the credit amount stated in the initial tax credit certificate for the investment from the Reserve Fund to the General Fund.
- 28 (iii) 1. Periodically, but not more frequently than quarterly, the Department may submit invoices for costs that have been incurred or are anticipated to be incurred in administering the tax credit program under this section.
- The Comptroller shall transfer money from the Reserve Fund to the Department to pay for costs that have been incurred or are anticipated to be incurred in administering the tax credit program under this section.



[(3)] (4) The qualified [Maryland cybersecurity company] INVESTOR that claimed the credit shall pay the amount to be recaptured as determined under paragraph [(2)] (3) of this subsection as taxes payable to the State for the taxable year in which the event requiring recapture of the credit occurs.

- 1 (h) (1) The Department may revoke its initial or final certification of an approved credit under this section if any representation made in connection with the application for the certification is determined by the Department to have been false.
- 4 (2) The revocation may be in full or in part as the Department may 5 determine and, subject to paragraph (3) of this subsection, shall be communicated to the 6 qualified investor, the qualified Maryland cybersecurity company, and the Comptroller.
- 7 (3) The qualified [Maryland cybersecurity company] INVESTOR shall have 8 an opportunity to appeal any revocation to the Department prior to notification of the 9 Comptroller.
- 10 (4) The Comptroller may make an assessment against the qualified [Maryland cybersecurity company] INVESTOR to recapture any amount of tax credit that the qualified [Maryland cybersecurity company] INVESTOR has already claimed.
