- 19 CREATES ANOTHER PATHWAY FOR LICENSURE AND DOES NOT OTHERWISE CHANGE
- 20 A STATE'S EXISTING MEDICAL PRACTICE ACT. THE COMPACT ALSO ADOPTS THE
- 20 A STATE S EXISTING MEDICAL I RACTICE ACT. THE COMPACT ALSO ADOLES THE
- 21 PREVAILING STANDARD FOR LICENSURE AND AFFIRMS THAT THE PRACTICE OF
- 22 MEDICINE OCCURS WHERE THE PATIENT IS LOCATED AT THE TIME OF THE
- 23 PHYSICIAN-PATIENT ENCOUNTER, AND THEREFORE REQUIRES THE PHYSICIAN TO
- 24 BE UNDER THE JURISDICTION OF THE STATE MEDICAL BOARD WHERE THE PATIENT
- 25 IS LOCATED. STATE MEDICAL BOARDS THAT PARTICIPATE IN THE COMPACT RETAIN

29 SECTION 2. DEFINITIONS

30 **IN THIS COMPACT:**

- 31 (A) "BYLAWS" MEANS THOSE BYLAWS ESTABLISHED BY THE INTERSTATE
- 32 COMMISSION PURSUANT TO SECTION 11 FOR ITS GOVERNANCE, OR FOR DIRECTING

 GUILTY OF A CRIMINAL OFFENSE THROUGH ADJUDICATION, OR ENTRY OF A PLEA
 OF GUILT OR NO CONTEST TO THE CHARGE BY THE OFFENDER. EVIDENCE OF AN
 ENTRY OF A CONVICTION OF A CRIMINAL OFFENSE BY THE COURT SHALL BE

CONSIDERED FINAL FOR PURPOSES OF DISCIPLINARY ACTION BY A MEMBER BOARD.

- 8 (D) "EXPEDITED LICENSE" MEANS A FULL AND UNRESTRICTED MEDICAL
 9 LICENSE GRANTED BY A MEMBER STATE TO AN ELIGIBLE PHYSICIAN THROUGH THE
 10 PROCESS SET FORTH IN THE COMPACT.
- 11 (E) "INTERSTATE COMMISSION" MEANS THE INTERSTATE COMMISSION 12 CREATED PURSUANT TO SECTION 11.
- 13 (F) "LICENSE" MEANS AUTHORIZATION BY A STATE FOR A PHYSICIAN TO 14 ENGAGE IN THE PRACTICE OF MEDICINE, WHICH WOULD BE UNLAWFUL WITHOUT 15 THE AUTHORIZATION.
- 16 (G) "MEDICAL PRACTICE ACT" MEANS THE LAWS AND REGULATIONS
 17 GOVERNING THE PRACTICE OF ALLOPATHIC AND OSTEOPATHIC MEDICINE WITHIN
 18 A MEMBER STATE.
- 19 (H) "MEMBER BOARD" MEANS A STATE AGENCY IN A MEMBER STATE THAT
 20 ACTS IN THE SOVEREIGN INTERESTS OF THE STATE BY PROTECTING THE PUBLIC
 21 THROUGH LICENSURE, REGULATION, AND EDUCATION OF PHYSICIANS AS DIRECTED
 22 BY THE STATE GOVERNMENT.
- 23 (I) "MEMBER STATE" MEANS A STATE THAT HAS ENACTED THE COMPACT.
- 24 (J) "OFFENSE" MEANS A FELONY, GROSS MISDEMEANOR, OR CRIME OF 25 MORAL TURPITUDE.
- 26 (K) "PHYSICIAN" MEANS ANY PERSON WHO:

- 27 (1) IS A GRADUATE OF A MEDICAL SCHOOL ACCREDITED BY THE 28 LIAISON COMMITTEE ON MEDICAL EDUCATION, THE COMMISSION ON 29 OSTEOPATHIC COLLEGE ACCREDITATION, OR A MEDICAL SCHOOL LISTED IN THE 30 INTERNATIONAL MEDICAL EDUCATION DIRECTORY OR ITS EQUIVALENT;

- 7 SPECIALTY CERTIFICATE RECOGNIZED BY THE AMERICAN BOARD OF MEDICAL
- 8 SPECIALTIES OR THE AMERICAN OSTEOPATHIC ASSOCIATION'S BUREAU OF
- 9 OSTEOPATHIC SPECIALISTS;
- 10 (5) (4) POSSESSES A FULL AND UNRESTRICTED LICENSE TO
- 11 ENGAGE IN THE PRACTICE OF MEDICINE ISSUED BY A MEMBER BOARD;
- 12 (6) (5) HAS NEVER BEEN CONVICTED OF OR RECEIVED
- 13 ADJUDICATION, DEFERRED ADJUDICATION, COMMUNITY SUPERVISION, OR
- 14 DEFERRED DISPOSITION FOR ANY OFFENSE BY A COURT OF APPROPRIATE
- 15 JURISDICTION;
- 16 (7) (6) HAS NEVER HELD A LICENSE AUTHORIZING THE PRACTICE
- 17 OF MEDICINE SUBJECTED TO DISCIPLINE BY A LICENSING AGENCY IN ANY STATE,
- 18 FEDERAL, OR FOREIGN JURISDICTION, EXCLUDING ANY ACTION RELATED TO
- 19 NONPAYMENT OF FEES RELATED TO A LICENSE;
- 20 (8) (7) HAS NEVER HAD A CONTROLLED SUBSTANCE LICENSE OR
- 21 PERMIT SUSPENDED OR REVOKED BY A STATE OR THE UNITED STATES DRUG
- 22 ENFORCEMENT ADMINISTRATION; AND
- 23 (9) (8) Is not under active investigation by a licensing
- 24 AGENCY OR LAW ENFORCEMENT AUTHORITY IN ANY STATE, FEDERAL, OR FOREIGN
- 25 JURISDICTION.
- 26 (L) "PRACTICE OF MEDICINE" MEANS THE CLINICAL PREVENTION,
- 27 DIAGNOSIS, OR TREATMENT OF HUMAN DISEASE, INJURY, OR CONDITION
- 28 REQUIRING A PHYSICIAN TO OBTAIN AND MAINTAIN A LICENSE IN COMPLIANCE
- 29 WITH THE MEDICAL PRACTICE ACT OF A MEMBER STATE.
- 30 (M) "RULE" MEANS A WRITTEN STATEMENT BY THE INTERSTATE
- 31 COMMISSION PROMULGATED PURSUANT TO SECTION 12 THAT IS OF GENERAL
- 32 APPLICABILITY, IMPLEMENTS, INTERPRETS, OR PRESCRIBES A POLICY OR
- 33 PROVISION OF THE COMPACT, OR AN ORGANIZATIONAL, PROCEDURAL, OR

9 SECTION 3. ELIGIBILITY

- 10 (A) (1) A PHYSICIAN MUST MEET THE ELIGIBILITY REQUIREMENTS AS
- 11 DEFINED IN SECTION 2(K) IN ORDER TO RECEIVE AN INITIAL EXPEDITED LICENSE
- 12 UNDER THE TERMS AND PROVISIONS OF THE COMPACT, A PHYSICIAN MUST:
- 13 (I) MEET THE ELIGIBILITY REQUIREMENTS AS DEFINED IN
- 14 SECTION 2(K); AND
- 15 (II) HOLD SPECIALTY CERTIFICATION OR A TIME-UNLIMITED
- 16 SPECIALTY CERTIFICATE RECOGNIZED BY THE AMERICAN BOARD OF MEDICAL
- 17 SPECIALTIES OR THE AMERICAN OSTEOPATHIC ASSOCIATION'S BUREAU OF
- 18 OSTEOPATHIC SPECIALISTS.
- 19 (2) A PHYSICIAN IS NOT REQUIRED TO MAINTAIN SPECIALTY
- 20 CERTIFICATION DESCRIBED UNDER PARAGRAPH (1)(II) OF THIS SUBSECTION IN
- 21 ORDER TO RENEW AN EXPEDITED LICENSE UNDER SECTION 6.
- 22 (B) A PHYSICIAN WHO DOES NOT MEET THE REQUIREMENTS OF SECTION
- 23 2(K) MAY OBTAIN A LICENSE TO PRACTICE MEDICINE IN A MEMBER STATE IF THE
- 24 INDIVIDUAL COMPLIES WITH ALL LAWS AND REQUIREMENTS, OTHER THAN THE
- 25 COMPACT, RELATING TO THE ISSUANCE OF A LICENSE TO PRACTICE MEDICINE IN
- 26 THAT STATE.

27 SECTION 4. DESIGNATION OF STATE OF PRINCIPAL LICENSE

- 28 (A) A PHYSICIAN SHALL DESIGNATE A MEMBER STATE AS THE STATE OF
- 29 PRINCIPAL LICENSE FOR PURPOSES OF REGISTRATION FOR EXPEDITED LICENSURE
- 30 THROUGH THE COMPACT IF THE PHYSICIAN POSSESSES A FULL AND UNRESTRICTED
- 31 LICENSE TO PRACTICE MEDICINE IN THAT STATE, AND THE STATE IS:
 - (1) THE STATE OF PRIMARY RESIDENCE FOR THE PHYSICIAN;

- 1 (2) THE STATE WHERE AT LEAST 25% OF THE PRACTICE OF MEDICINE 2 OCCURS;
- 3 (3) THE LOCATION OF THE PHYSICIAN'S EMPLOYER; OR
- 4 (4) If NO STATE QUALIFIES UNDER ITEMS (1), (2), OR (3), THE STATE 5 DESIGNATED AS STATE OF RESIDENCE FOR PURPOSE OF FEDERAL INCOME TAX.
- 6 (B) A PHYSICIAN MAY REDESIGNATE A MEMBER STATE AS STATE OF 7 PRINCIPAL LICENSE AT ANY TIME, AS LONG AS THE STATE MEETS THE 8 REQUIREMENTS IN SUBSECTION (A).
- 9 (C) THE INTERSTATE COMMISSION IS AUTHORIZED TO DEVELOP RULES TO 10 FACILITATE REDESIGNATION OF ANOTHER MEMBER STATE AS THE STATE OF 11 PRINCIPAL LICENSE.

12 SECTION 5. APPLICATION AND ISSUANCE OF EXPEDITED LICENSURE

- 13 (A) A PHYSICIAN SEEKING LICENSURE THROUGH THE COMPACT SHALL FILE AN APPLICATION FOR AN EXPEDITED LICENSE WITH THE MEMBER BOARD OF THE STATE SELECTED BY THE PHYSICIAN AS THE STATE OF PRINCIPAL LICENSE.
- 16 (B) (1) ON RECEIPT OF AN APPLICATION FOR AN EXPEDITED LICENSE,
 17 THE MEMBER BOARD WITHIN THE STATE SELECTED AS THE STATE OF PRINCIPAL
 18 LICENSE SHALL EVALUATE WHETHER THE PHYSICIAN IS ELIGIBLE FOR EXPEDITED
 19 LICENSURE AND ISSUE A LETTER OF QUALIFICATION, VERIFYING OR DENYING THE
 20 PHYSICIAN'S ELIGIBILITY, TO THE INTERSTATE COMMISSION.
- 21 (2) STATIC QUALIFICATIONS, WHICH INCLUDE VERIFICATION OF
 22 MEDICAL EDUCATION, GRADUATE MEDICAL EDUCATION, RESULTS OF ANY MEDICAL
 23 OR LICENSING EXAMINATION, AND OTHER QUALIFICATIONS AS DETERMINED BY THE
 24 INTERSTATE COMMISSION THROUGH RULE, MAY NOT BE SUBJECT TO ADDITIONAL
 25 PRIMARY SOURCE VERIFICATION WHERE ALREADY PRIMARY SOURCE VERIFIED BY
 26 THE STATE OF PRINCIPAL LICENSE.

- 1 (II) THE MEMBER BOARD MAY NOT DISCLOSE TO THE
- 2 Interstate Commission any information received from the Federal
- 3 BUREAU OF INVESTIGATION THAT IS PROVIDED IN A BACKGROUND CHECK OF AN
- 4 APPLICANT PERFORMED UNDER THIS PARAGRAPH.
- 5 (4) AN APPEAL ON THE DETERMINATION OF ELIGIBILITY SHALL BE
- 6 MADE TO THE MEMBER STATE, IF AN APPEAL IS ALLOWED UNDER THE LAWS OF THAT
- 7 STATE, WHERE THE APPLICATION WAS FILED AND SHALL BE SUBJECT TO THE LAW

- 9 (C) ON VERIFICATION IN SUBSECTION (B), PHYSICIANS ELIGIBLE FOR AN
- 10 EXPEDITED LICENSE SHALL COMPLETE THE REGISTRATION PROCESS ESTABLISHED
- 11 BY THE INTERSTATE COMMISSION TO RECEIVE A LICENSE IN A MEMBER STATE
- 12 SELECTED PURSUANT TO SUBSECTION (A), INCLUDING THE PAYMENT OF ANY
- 13 APPLICABLE FEES.
- 14 (D) AFTER RECEIVING VERIFICATION OF ELIGIBILITY UNDER SUBSECTION
- 15 (B) AND ANY FEES UNDER SUBSECTION (C), A MEMBER BOARD SHALL ISSUE AN
- 16 EXPEDITED LICENSE TO THE PHYSICIAN. THIS LICENSE SHALL AUTHORIZE THE

- 1 (F) REINSTATEMENT FOLLOWING WITHDRAWAL OF A MEMBER STATE 2 SHALL OCCUR ON THE WITHDRAWING STATE REENACTING THE COMPACT OR ON 3 SUCH LATER DATE AS DETERMINED BY THE INTERSTATE COMMISSION.
- 4 (G) THE INTERSTATE COMMISSION IS AUTHORIZED TO DEVELOP RULES TO
 5 ADDRESS THE IMPACT OF THE WITHDRAWAL OF A MEMBER STATE ON LICENSES
