CHAPTER _____

1 AN ACT concerning

2 **Health Insurance – Coverage of Fertility Preservation Procedures for**
3 **Iatrogenic Infertility**

4 FOR the purpose of requiring certain insurers, nonprofit health service plans, and health
5 maintenance organizations that provide certain benefits under certain insurance
6 policies or contracts to provide coverage for certain fertility preservation procedures;
7 providing for the application of this Act; defining certain terms; providing for a
8 delayed effective date; and generally relating to health insurance coverage for
9 fertility preservation procedures.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Insurance**

18 **15–810.1.**

1 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
2 **INDICATED.**

3 **(2) “IATROGENIC INFERTILITY” MEANS AN IMPAIRMENT OF**
4 **FERTILITY CAUSED DIRECTLY OR INDIRECTLY BY SURGERY, CHEMOTHERAPY,**
5 **RADIATION, OR OTHER MEDICAL TREATMENT AFFECTING THE REPRODUCTIVE**
6 **ORGANS OR PROCESSES.**

7 **(3) “MEDICAL TREATMENT THAT MAY DIRECTLY OR INDIRECTLY**
8 **CAUSE IATROGENIC INFERTILITY” MEANS MEDICAL TREATMENT WITH A LIKELY**
9 **SIDE EFFECT OF INFERTILITY AS ESTABLISHED BY THE AMERICAN SOCIETY FOR**
10 **REPRODUCTIVE MEDICINE, THE AMERICAN COLLEGE OF OBSTETRICIANS AND**
11 **GYNECOLOGISTS, OR THE AMERICAN SOCIETY OF CLINICAL ONCOLOGY.**

12 **(4) (I) “STANDARD FERTILITY PRESERVATION PROCEDURES”**
13 **MEANS PROCEDURES TO PRESERVE FERTILITY THAT ARE CONSISTENT WITH**
14 **ESTABLISHED MEDICAL PRACTICES AND PROFESSIONAL GUIDELINES PUBLISHED**
15 **BY THE AMERICAN SOCIETY FOR REPRODUCTIVE MEDICINE, THE AMERICAN**
16 **COLLEGE OF OBSTETRICIANS AND GYNECOLOGISTS, OR THE AMERICAN SOCIETY**
17 **OF CLINICAL ONCOLOGY.**

18 **(II) “STANDARD FERTILITY PRESERVATION PROCEDURES”**
19 **INCLUDES SPERM AND OOCYTE CRYOPRESERVATION AND EVALUATIONS,**
20 **LABORATORY ASSESSMENTS, MEDICATIONS, AND TREATMENTS ASSOCIATED WITH**
21 **SPERM AND OOCYTE CRYOPRESERVATION.**

22 **(III) “STANDARD FERTILITY PRESERVATION PROCEDURES”**
23 **DOES NOT INCLUDE THE STORAGE OF SPERM OR OOCYTES.**

24 **(B) THIS SECTION APPLIES TO:**

25 **(1) INSURERS AND NONPROFIT HEALTH SERVICE PLANS THAT**
26 **PROVIDE HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS**
27 **ON AN EXPENSE–INCURRED BASIS UNDER HEALTH INSURANCE POLICIES THAT ARE**
28 **ISSUED OR DELIVERED IN THE STATE; AND**

29 **(2) HEALTH MAINTENANCE ORGANIZATIONS THAT PROVIDE**
30 **HOSPITAL, MEDICAL, OR SURGICAL BENEFITS TO INDIVIDUALS OR GROUPS UNDER**
31 **CONTRACTS THAT ARE ISSUED OR DELIVERED IN THE STATE.**

32 **(C) AN ENTITY SUBJECT TO THIS SECTION SHALL PROVIDE COVERAGE FOR**
33 **STANDARD FERTILITY PRESERVATION PROCEDURES:**

1 **(1) PERFORMED ON A POLICYHOLDER OR SUBSCRIBER OR ON THE**
2 **DEPENDENT SPOUSE OF A POLICYHOLDER OR SUBSCRIBER; AND**

3 **(2) THAT ARE MEDICALLY NECESSARY TO PRESERVE FERTILITY FOR**
4 **A POLICYHOLDER OR SUBSCRIBER OR FOR THE DEPENDENT SPOUSE OF A**
5 **POLICYHOLDER OR SUBSCRIBER DUE TO A NEED FOR MEDICAL TREATMENT THAT**
6 **MAY DIRECTLY OR INDIRECTLY CAUSE IATROGENIC INFERTILITY.**

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all
8 policies, contracts, and health benefit plans issued, delivered, or renewed in the State on or
9 after January 1, 2019.

10 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 January 1, 2019.
