2 **Education – Head Start Program – Annual Appropriation**  
3 **(The Ulysses Currie Act)**

4 FOR the purpose of requiring a certain program to be referred to as the Ulysses Currie  
5 Head Start Program; requiring the Governor to include a certain appropriation to  
6 the Ulysses Currie Head Start Program in each annual budget submission; and  
7 generally relating to the Ulysses Currie Head Start Program.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
14 That the Laws of Maryland read as follows:

2 (A) THE HEAD START PROGRAM IN THE STATE SHALL BE REFERRED TO AS  
3 THE ULYSSES CURRIE HEAD START PROGRAM.

4 (B) FOR EACH FISCAL YEAR, THE GOVERNOR SHALL INCLUDE IN THE  
5 ANNUAL STATE BUDGET AN APPROPRIATION OF AT LEAST \$3,000,000 FOR THE  
6 ULYSSES CURRIE HEAD START PROGRAM.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
8 1, 2018.
