A BILL ENTITLED

1 AN ACT concerning

Baltimore Convention Facility – Operating Deficits and Capital Improvement Reserve Fund

4 FOR the purpose of extending the period during which the Maryland Stadium Authority $\mathbf{5}$ and Baltimore City are obligated under a certain agreement to contribute a certain 6 amount to the annual operating deficits of the Baltimore Convention facility and to 7 pay a certain amount to a certain capital improvement reserve fund; extending the 8 date after which Baltimore City is to be solely responsible for all operating deficits 9 and capital improvements for the Baltimore Convention facility; and generally 10 relating to the financing and payment of certain costs associated with the Baltimore Convention facility. 11

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
