#### 1 AN ACT concerning

## Off-Highway Recreational Vehicles – Excise Titling Tax – Off-Highway Recreational Vehicle Trail Fund

FOR the purpose of establishing the Off–Highway Recreational Vehicle Trail Fund as a 4  $\mathbf{5}$ special, nonlapsing fund; specifying the purpose of the Fund; requiring the Secretary 6 of Natural Resources to administer the Fund; requiring the State Treasurer to hold 7 the Fund and the Comptroller to account for the Fund; specifying the contents of the Fund; specifying the purpose for which the Fund may be used; providing for the 8 9 investment of money in and expenditures from the Fund; requiring the Comptroller 10 to transfer a certain percentage of the revenue from the excise tax imposed for 11 certain certificates of title issued for certain off-highway recreational vehicles to the 12 Off-Highway Recreational Vehicle Trail Fund; defining a certain term; making a 13stylistic change; and generally relating to revenue from the excise tax imposed on certificates of title issued for off-highway recreational vehicles. 14

23(2)Except as provided in paragraphs (3) and (6) of this subsection, no part (f)24of the Transportation Trust Fund may be transferred or diverted to a special fund of the State, unless approved by the General Assembly through legislation passed by a 25three-fifths majority vote of the full standing committee assigned the legislation in each of 26the two Houses of the General Assembly and enacted into law. No part of the 27Transportation Trust Fund may be transferred or diverted to a special fund of the State 2829pursuant to the provisions of § 7–209(e)(2) of the State Finance and Procurement Article, 30 unless the requirements of this paragraph have been satisfied.
