10	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

14 15 16	(a) (1) It is the intent of this section that each register shall receive a fair and adequate compensation for the effort and duties required of the register by the register's office.
17 18	(2) The volume and character of work done by the register shall be in comparison to the salary fixed by the Board of Public Works for each of the other registers.
19 20	(b) (1) Each register is entitled to receive an annual salary of not more than <b>[</b> \$114,500 <b>] \$124,500</b> , to be determined in each instance by the Board of Public Works.
21 22	(2) In determining the annual salary of the register, the Board of Public Works shall be guided in the exercise of its discretion by:

- 1 (i) The population of the county determined by the last official 2 United States census;
- 3 (ii) The dollar volume of total fees and taxes collected and excess fees 4 turned over to the State for each of the preceding 5 years by the office of the register for 5 which the salary is being fixed; and
- 6 (iii) Other pertinent data which have relation to the reasonableness 7 of the salary in relation to the work done and volume handled by the office.
- 8 (c) The minimum annual salary for the register in Baltimore City is \$12,000.
- 9 (d) (1) The salaries of the registers shall be paid semimonthly from the fees 10 and receipts of the office, after deducting the expenses of the office.
- 11 (2) Expenses include salaries of deputies and clerks, books, stationery, office supplies, and other necessary and customary expenses of doing business.
- 13 (e) (1) If the fees and receipts of the office are insufficient in any fiscal year to
  14 pay all or a part of the expenses of the office and authorized salary of a register, the
  15 deficiency shall be funded from the taxes remitted to the Comptroller of the treasury by the
  16 register during that fiscal year. Written authority for the transfer of funds shall be first
  17 obtained from the Comptroller.
- 18 (2) In the event that tax collections for the fiscal year are insufficient, the Comptroller shall make up the deficit from excess fees remitted from all other registers.
  - SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary or compensation of the register of wills while serving in a term of office beginning before the effective date of this Act, but the provisions of this Act concerning the salary or compensation of the register of wills shall take effect at the beginning of the next following term of office. This limitation does not apply to an individual appointed or elected after the effective date of this Act to fill out an unexpired term.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2018.
