- 3 FOR the purpose of providing that certain State employees may be entitled to parental 4 leave with pay under certain circumstances; establishing the maximum number of 5 days of parental leave that certain employees may use for the care and nurturing of 6 a child within a certain amount of time immediately following the birth or adoption 7 of the child; authorizing certain employees to use certain leave for a certain purpose; 8 requiring certain State agencies to provide certain employees with additional paid 9 leave under certain circumstances; providing that an employee may use parental 10 leave only after obtaining approval from the employee's appointing authority; 11 prohibiting an employee who uses parental leave from receiving certain payment 12 unless the employee takes a certain action; requiring the Secretary of Budget and 13 Management to adopt certain regulations; requiring the Secretary to report to 14 certain committees on or before a certain date certain information regarding the 15 importance of employee benefits for certain purposes; and generally relating to parental leave for State employees. 16
