## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Higher Education – Maryland Loan Assistance Repayment Program – Farmers**

3 FOR the purpose of establishing the Maryland Loan Assistance Repayment Program for  
4 Farmers; requiring the Office of Student Financial Assistance in the Maryland  
5 Higher Education Commission to assist in the repayment of a certain loan owed by  
6 certain farmers; requiring the Office, in consultation with the Department of  
7 Agriculture, to adopt certain regulations; specifying that funds for the Program shall  
8 be as provided in the State budget; requiring a certain annual report to include  
9 certain information about the Program; altering the requirements of a certain  
10 annual report; making a stylistic change; defining certain terms; and generally  
11 relating to the Maryland Loan Assistance Repayment Program for Farmers.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That the Laws of Maryland read as follows:

3 **Article – Education**

4 18–1505.

5 Subject to § 2–1246 of the State Government Article, the Office [of Student Financial  
6 Assistance] shall report to the General Assembly by January 1 of each year on the  
7 implementation of the Janet L. Hoffman Loan Assistance Repayment Program **AND THE**  
8 **REQUIREMENTS OF § 18–28A–05 OF THIS TITLE.**

9 **SUBTITLE 28A. MARYLAND LOAN ASSISTANCE REPAYMENT PROGRAM FOR**  
10 **FARMERS.**

11 **18–28A–01.**

12 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS  
13 INDICATED.

14 (B) “DEPARTMENT” MEANS THE DEPARTMENT OF AGRICULTURE.

15 (C) “HIGHER EDUCATION LOAN” MEANS A LOAN THAT IS OBTAINED FOR  
16 TUITION, EDUCATION EXPENSES, OR LIVING EXPENSES FOR UNDERGRADUATE OR  
17 GRADUATE STUDY LEADING TO A DEGREE IN AGRICULTURE OR AN  
18 AGRICULTURE–RELATED FIELD, INCLUDING FARMING.

19 (D) “PROGRAM” MEANS THE MARYLAND LOAN ASSISTANCE REPAYMENT  
20 PROGRAM FOR FARMERS.

21 **18–28A–02.**

22 (A) THERE IS A MARYLAND LOAN ASSISTANCE REPAYMENT PROGRAM FOR  
23 FARMERS IN THE STATE.

24 (B) THE OFFICE SHALL ASSIST IN THE REPAYMENT OF A HIGHER  
25 EDUCATION LOAN OWED BY A FARMER WHO:

26 (1) HAS RECEIVED AN UNDERGRADUATE OR GRADUATE DEGREE IN  
27 AGRICULTURE OR AN AGRICULTURE–RELATED FIELD FROM A PUBLIC OR PRIVATE  
28 NONPROFIT INSTITUTION OF HIGHER EDUCATION LOCATED IN THE STATE;

29 (2) HAS BEEN A FARMER FOR AT LEAST 5 YEARS BUT NOT MORE THAN  
30 10 YEARS SINCE OBTAINING THE DEGREE;

1           **(3) RECEIVES AN INCOME THAT IS LESS THAN THE MAXIMUM**  
2 **ELIGIBLE TOTAL INCOME LEVELS ESTABLISHED BY THE OFFICE, IN CONSULTATION**  
3 **WITH THE DEPARTMENT, INCLUDING ANY ADDITIONAL SOURCES OF INCOME; AND**

4           **(4) SATISFIES ANY OTHER CRITERIA ESTABLISHED BY THE OFFICE.**

5 **18-28A-03.**

6           **THE OFFICE, IN CONSULTATION WITH THE DEPARTMENT, SHALL ADOPT**  
7 **REGULATIONS TO ESTABLISH:**

8           **(1) THE MAXIMUM STARTING INCOME FOR ELIGIBILITY IN THE**  
9 **PROGRAM;**

10           **(2) THE MAXIMUM TOTAL INCOME FOR ELIGIBILITY IN THE**  
11 **PROGRAM, INCLUDING ANY ADDITIONAL SOURCES OF INCOME;**

12           **(3) THAT PRIORITY FOR PARTICIPATION IN THE PROGRAM SHALL BE**  
13 **GIVEN TO A FARMER WHO:**

14                   **(I) GRADUATED FROM AN INSTITUTION OF HIGHER**  
15 **EDUCATION IN THE STATE IN THE LAST 10 YEARS;**

16                   **(II) IS EMPLOYED AS A FARMER ON A FULL-TIME BASIS; AND**

17                   **(III) AS DETERMINED BY THE DEPARTMENT, USES SUSTAINABLE**  
18 **AGRICULTURAL TECHNIQUES AND DEMONSTRATES ENVIRONMENTAL**  
19 **STEWARDSHIP;**

20           **(4) A LIMIT ON THE TOTAL AMOUNT OF ASSISTANCE PROVIDED BY**  
21 **THE OFFICE IN REPAYING THE HIGHER EDUCATION LOAN OF A FARMER, BASED ON**  
22 **THE FARMER'S TOTAL INCOME AND OUTSTANDING HIGHER EDUCATION LOAN**  
23 **BALANCE;**

24           **(5) A PROCEDURE AND SCHEDULE FOR THE PAYMENT OF THE**  
25 **AMOUNT OF LOAN ASSISTANCE PROVIDED BY THE OFFICE TO THE FARMER; AND**

26           **(6) AN ANNUAL REVIEW OF THE ELIGIBILITY OF EACH FARMER**  
27 **PARTICIPATING IN THE PROGRAM.**

28 **18-28A-04.**

1 FUNDS FOR THE PROGRAM SHALL BE PROVIDED ON AN ANNUAL BASIS IN THE  
2 STATE BUDGET.

3 18-28A-05.

4 AS PART OF THE ANNUAL REPORT REQUIRED UNDER § 18-1505 OF THIS  
5 TITLE, THE OFFICE SHALL INCLUDE INFORMATION REGARDING IMPLEMENTATION  
6 OF THE PROGRAM, INCLUDING:

7 (1) THE AMOUNT OF MONEY ALLOCATED FOR THE PROGRAM;

8 (2) THE NUMBER OF AWARDS MADE AND AMOUNTS OF THE AWARDS;  
9 AND

10 (3) THE NUMBER OF APPLICANTS DENIED AN AWARD.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
12 1, 2018.
