- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 That the Laws of Maryland read as follows:

- 16 (a) (1) (I) There is a Scenic and Wild Rivers Review Board.
- 17 **(II)** The Board consists of the Secretaries of Natural Resources, 18 Agriculture, and the Environment and the Director of Planning and a member of the 19 Garrett County Commissioners, who shall be a voting member of the Board only on matters

1 (2) Each board, as constituted by the local authority, may recommend 2 policies, laws, and regulations in furtherance of the aims of this subtitle to the appropriate 3 local governing body.

194. ONE REPRESENTATIVE OF AN ORGANIZATION IN THE20COUNTY WITH EXPERTISE IN AGRICULTURE, SUCH AS THE LOCAL FARM BUREAU,21GRANGE, OR SOIL CONSERVATION DISTRICT.
