- 5 (VI) ANY WEIGHTS THAT MAY CORRESPOND WITH THE 6 RECOMMENDED LEVEL OF FUNDING THAT SHOULD BE USED FOR STUDENTS IN 7 SPECIAL EDUCATION IN THE FORMULAS AND THE RATIONALES FOR SELECTING A 8 SPECIFIC WEIGHT.
- 9 (c) The Governor shall include sufficient funds in the State budget for the 10 appropriate fiscal years for the State Department of Education to cover the costs of 11 conducting the study.
- 12 (d) On or before [July] **SEPTEMBER** 1, 2019, the State Department of Education 13 shall report the findings and recommendations of the study, in accordance with § 2–1246 14 of the State Government Article, to the General Assembly.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2018.
