CHAPTER _____

1 AN ACT concerning

2 **Baltimore County – Alcoholic Beverages – Education Conference Facility/Dining**
3 **Service License**

4 FOR the purpose of establishing in Baltimore County a Class B–ECF/DS beer, wine, and
5 liquor license; authorizing the Board of License Commissioners for Baltimore County
6 to issue the license to certain people; authorizing the license holder to sell beer, wine,
7 and liquor for on–premises consumption at certain University of Maryland,
8 Baltimore County events; requiring profits from beer, wine, and liquor sales to be
9 deposited into a certain account; authorizing the Board to regulate the manner in
10 which beer, wine, and liquor is dispensed under the license; requiring the Board to
11 perform certain functions before issuing the license; ~~requiring certain policies of the~~
12 ~~University to be included in an application for the license;~~ establishing certain hours
13 and days of sale for the license; establishing a certain annual license fee; and
14 generally relating to a Class B–ECF/DS beer, wine, and liquor license.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 10 That Section(s) 13–1001 of Article – Alcoholic Beverages of the Annotated Code of Maryland
 11 be renumbered to be Section(s) 13–1001.1.

12 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
 13 as follows:

14 **Article – Alcoholic Beverages**

15 13–102.

16 This title applies only in Baltimore County.

18 **(A) THERE IS A CLASS B–ECF/DS (EDUCATION CONFERENCE**
 19 **FACILITY/DINING SERVICE) BEER, WINE, AND LIQUOR LICENSE.**

20 **(B) THE BOARD MAY ISSUE THE LICENSE TO AN INDIVIDUAL WHO IS:**

21 **(1) AUTHORIZED BY THE UNIVERSITY OF MARYLAND, BALTIMORE**
 22 **COUNTY TO:**

23 **(I) ACT ON BEHALF OF THE CAMPUS UNDER THE LICENSE; AND**

24 **(II) BE SUBJECT TO THE PENALTIES, CONDITIONS, AND**
 25 **RESTRICTIONS UNDER THIS TITLE; AND**

26 **(2) A RESIDENT OF THE ~~COUNTY~~ STATE.**

27 **(C) (1) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER,**
 28 **WINE, AND LIQUOR FOR ON–PREMISES CONSUMPTION FROM MULTIPLE**
 29 **DESIGNATED OUTLETS ON THE UNIVERSITY’S CAMPUS ONLY AT**
 30 **UNIVERSITY AUTHORIZED UNIVERSITY-RELATED EVENTS AS AUTHORIZED BY THE**
 31 **UNIVERSITY OFFICE OF ADMINISTRATIVE SERVICES CATERED BY THE**
 32 **UNIVERSITY’S CAMPUS DINING SERVICES CONTRACTOR.**

1 **(2) BEER, WINE, AND LIQUOR PURCHASED AT A DESIGNATED OUTLET**
2 **ARE TO BE CONSUMED IN THE CONFINES OF THAT OUTLET AND MAY NOT BE**
3 **TRANSPORTED TO ANOTHER OUTLET.**

4 **(D) ALL PROFITS FROM THE RETAIL SALE OF BEER, WINE, AND LIQUOR**
5 **SHALL BE DEPOSITED IN THE AUXILIARY SERVICES ACCOUNT OF THE UNIVERSITY**
6 **OF MARYLAND, BALTIMORE COUNTY.**

7 **(E) THE BOARD:**

8 **(1) MAY REGULATE THE MANNER IN WHICH BEER, WINE, AND LIQUOR**
9 **ARE DISPENSED UNDER THE LICENSE;**

10 **(2) BEFORE ISSUING THE LICENSE, SHALL DESIGNATE THE EXACT**
11 **CAMPUS LOCATIONS FOR THE OUTLETS FOR THE SALE OF BEER, WINE, AND LIQUOR;**

12 **(3) SHALL MAINTAIN A MAP AND DESCRIPTION OF THE DESIGNATED**
13 **OUTLETS FOR VERIFICATION ON THE RENEWAL OF THE LICENSE; AND**

14 **(4) SHALL REQUIRE THE UNIVERSITY OF MARYLAND, BALTIMORE**
15 **COUNTY TO REPORT TO THE BOARD AT LEAST 5 DAYS BEFORE A**
16 **~~UNIVERSITY AUTHORIZED~~ UNIVERSITY-RELATED EVENT AT WHICH BEER, WINE,**
17 **OR LIQUOR IS INTENDED TO BE SOLD OR SERVED.**

18 ~~**(F) THE POLICIES OF THE UNIVERSITY OF MARYLAND, BALTIMORE**~~
19 ~~**COUNTY THAT PERTAIN TO THE SPONSORSHIP OF UNIVERSITY AUTHORIZED**~~
20 ~~**EVENTS AT WHICH ALCOHOLIC BEVERAGES MAY BE SOLD SHALL BE FILED WITH THE**~~

23 **DURING THE HOURS AND DAYS AS SET OUT FOR A CLASS B BEER, WINE, AND LIQUOR**
24 **LICENSE UNDER § 13-2004 OF THIS TITLE.**

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
27 1, 2018.
