2 (a) (1) This section does not apply to Baltimore City.

3 (2) Subsections (b), (c), (d), and (f) of this section do not apply in Prince 4 George's County.

5 [(3) Subsections (b)(2) and (3) of this section do not apply in Washington 6 County.]

7 (b) (1) The term of a county superintendent is 4 years beginning on July 1. A 8 county superintendent continues to serve until a successor is appointed and qualifies.

9 (2) By February 1 of the year in which a term ends, the county 10 superintendent shall notify the county board whether the superintendent is a candidate for 11 reappointment.

12 (3) In the year in which a term begins, the county board shall appoint a 13 county superintendent between February 1 and June 30. However, if the county board 14 decides to reappoint the incumbent superintendent, the county board shall take final action 15 at a public meeting no later than March 1 of that year.

16 (4) If a county board is unable to appoint a county superintendent by July 17 1 of a year in which a term begins, the provisions of subsection (d) of this section apply.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2018.
