2 **Baltimore City – Board of License Commissioners – Notice of Legislative**
3 **Proposals**

4 FOR the purpose of requiring the Board of License Commissioners for Baltimore City to
5 give notice to certain persons on or before a certain time regarding any legislative
6 proposal the Board intends to submit to the Baltimore City delegation to the General
7 Assembly for introduction as a bill; and generally relating to notice by the Board of
8 License Commissioners for Baltimore City regarding legislative proposals.

6 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
7 That the Laws of Maryland read as follows:

8 **Article – Alcoholic Beverages**

9 12–102.

10 This title applies only in Baltimore City.

11 12–201.

12 There is a Board of License Commissioners for Baltimore City.

13 **12–211.**

14 **AT LEAST 3 MONTHS BEFORE THE START OF THE REGULAR SESSION OF THE**
15 **GENERAL ASSEMBLY EACH YEAR, THE BOARD SHALL GIVE NOTICE TO THE**
16 **FOLLOWING PERSONS REGARDING ANY LEGISLATIVE PROPOSAL THE BOARD**
17 **INTENDS TO SUBMIT TO THE CITY DELEGATION TO THE GENERAL ASSEMBLY FOR**
18 **INTRODUCTION AS A BILL:**

19 **(1) THE MAYOR OF BALTIMORE CITY;**

20 **(2) THE ~~PRESIDENT OF THE~~ BALTIMORE CITY COUNCIL; AND**

21 **(3) COMMUNITY AND RESIDENTIAL GROUPS IN THE CITY THAT HAVE**
22 **OPTED TO RECEIVE NOTICES FROM THE BOARD.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2018.
