10. Description and Purpose of Organization (Limit length to visible area)				
<p>Anne Arundel County is a local jurisdiction in the State of Maryland serving over 500,000 residents. Severn Danza Park is a 61 acre community park in Severn Maryland owned by the county, and providing 13 athletic fields, tennis and basketball courts, a BMX bicycle track, a playground and paved trails. The Severn Athletic Club is a 501(c)(3) co-recipient of the proposed bond bill and is responsible for the sports programs conducted at Severn Danza Park. The County will design and install lights on two softball fields within the Park. The County Department of Recreation and Parks is responsible for the operation and maintenance of the park with assistance from the Severn Athletic Club.</p>				

11. Description and Purpose of Project (Limit length to visible area)

This project is to provide field lighting on two existing softball fields to address the growth in youth sports in the Severn community and surrounding area. These lighting systems will double the evening capacity of the two fields, avoiding the acquisition of land, and the construction of new fields. This additional field capacity will help the Severn Athletic Club as it strives to accommodate the growing number of youth sports participants, and hopefully avoid any rejections. The County will install state of the art lights that minimize spill and glare. The support of the Maryland General Assembly will be greatly appreciated.
