### 10. Description and Purpose of Organization (Limit length to visible area)

The MSBC Five Star Program, Inc., is an IRS 501 (c)(3) Community Development Corporation, (CDC) that partners in the West Baltimore County community with other community outreach and service organizations in the enhancement of the lives of its residents. The goal of the MSBC Five Star Program, Inc. is to meet and support the needs of the community through outreach efforts, support services and community programs and activities. Located at 6665 Security Blvd., the CDC has served thousands of community members with social, educational, physical and mental health needs. Having oversight of The Renaissance Counseling Center and having managed a Teenage Abstinence Program and Transitional Housing Project, the CDC has a solid track record of community outreach and service. Its reach is limited only by current resources and the need for more operating space.

#### 11. Description and Purpose of Project (Limit length to visible area)

The purpose of the project is to acquire funds for renovating the Morning Star Family Life Center, (The FLC) to continue to serve the needs of the residents of the West Baltimore county. The FLC educational and outreach programs include youth tutoring and mentoring, before and after school care, recreational activities, Senior Day activities including social, financial, nutritional, aging and mental health services. This community outreach facility will also provide a commercial kitchen for culinary training, food distribution, and workforce development; along with a 300 seat community events space open to the entire community. Funding from this Bond Bill will afford the continuation of renovation, construction and HVAC revamping of the property to prepare for opening by December 2018. We request the approval of this grant to expand and continue our servicing the residents of the West Baltimore county community.

#### 28. Comments

Since its inception in 2001, the MSBC Five Star Program, Inc., CDC has been a major outreach and community service partner in the West Baltimore community. With a goal of building and rebuilding lives by meeting the needs of the under-served among us, the CDC had oversight of the Morning Star Daycare and Learning Center that has served families for 35 years, The Renaissance Counseling Center which has served hundreds of individuals and families and continues to assist in the healing of minds and spirits. The MSBC Five Star Program, Inc. continues their oversight of general outreach services including multigenerational educational services, e.g., GED training, workforce and career development, mentoring and tutoring programs, before and after school and recreational services, and community support of the limited and low income population via food, clothing and limited financial donations for those who have critical life-sustaining situations.

We began the demolition and renovation of the FLC in November 2017, and with additional funding, expect to complete Phase One of the project by December 2018.

As we continue to seek to serve, we respectfully request the funds to continue to provide the services in our soon to be renovated space at 1600 Whitehead Court in Woodlawn. With the additional funds, we will expand our reach to further enhance the services to this much needed West Baltimore population.
