AMENDMENTS TO SENATE BILL 793, AS AMENDED  
(First Reading File Bill – Second Printing)

AMENDMENT NO. 1

On page 1 of the bill, in line 18, after “circumstances;” insert “providing that the memorandum of understanding must be approved by the General Assembly before the University may establish a police department;”; strike beginning with “requiring” in line 25 down through “circumstances;” in line 27; in line 27, strike “the University to seek” and substitute “certain standards and policies to be designed to comply with;”; and in the same line, after “accreditation” insert “standards”.

On page 2 of the bill, in line 1, strike “and” and substitute a comma; in line 2, after “website” insert “, and establish a certain process for the filing and investigation of certain complaints;”; and in line 17, after “manner;” insert “requiring the University to seek accreditation from certain organizations, under certain circumstances; making certain provisions of this Act subject to a certain contingency;”.

AMENDMENT NO. 2

On page 9 of the bill, in line 20, after “(B)” insert “**(1)**”; and in lines 22, 25, 26, 27, and 28, strike “(1)”, “(I)”, “(II)”, “(III)”, and “(2)”, respectively, and substitute “**(I)**”, “**1.**”, “**2.**”, “**3.**”, and “**(II)**”, respectively.

On page 10 of the bill, in line 4, strike “(3)” and substitute “**(III)**”; and after line 5, insert:

**“(2) THE MEMORANDUM OF UNDERSTANDING MUST BE APPROVED BY THE GENERAL ASSEMBLY BEFORE THE UNIVERSITY MAY ESTABLISH A POLICE DEPARTMENT.”**

(Over)

On page 4 of the Judicial Proceedings Committee Amendments (SB0793/408976/1), in line 14 of Amendment No. 4, after the semicolon insert “AND”; and strike beginning with the semicolon in line 16 down through “(7)” in line 17.

On page 12 of the bill, in line 6, after the semicolon insert “AND”; strike beginning with the semicolon in line 13 down through “EMPLOYEES” in line 19; strike beginning with “SEEK” in line 20 down through “ORGANIZATION” in line 22; and before line 23, insert:

**“(D) THE STANDARDS AND POLICIES THAT THE UNIVERSITY ADOPTS UNDER THIS SECTION SHALL BE DESIGNED TO COMPLY WITH THE ACCREDITATION STANDARDS OF THE COMMISSION ON ACCREDITATION FOR LAW ENFORCEMENT AGENCIES, THE INTERNATIONAL ASSOCIATION OF CAMPUS LAW ENFORCEMENT ADMINISTRATORS, OR A SIMILAR ORGANIZATION.”**

On page 13 of the bill, in line 9, strike the second “AND”; in line 12, after “INITIATIVES” insert “;AND”

**(5) PROVIDE INDEPENDENT CIVILIAN CONTROL OVER THE INVESTIGATION OF COMPLAINTS REGARDING THE POLICE DEPARTMENT AND ITS EMPLOYEES**;

in line 13, strike “15” and substitute “22”; strike beginning with “AT” in line 18 down through “CAMPUS” in line 26 and substitute “A REPRESENTATIVE OF EACH OF THE FOLLOWING ORGANIZATIONS, APPOINTED BY THE ORGANIZATION:”

**(I) THE ABELL IMPROVEMENT ASSOCIATION;**

**(II) THE BETTER WAIVERLY COMMUNITY ORGANIZATION;**

(III) THE CHARLES VILLAGE CIVIC ASSOCIATION;

(IV) THE HARWOOD COMMUNITY ASSOCIATION;

(V) THE OAKENSHAW IMPROVEMENT ASSOCIATION;

(VI) THE OLD GOUCHER COMMUNITY ASSOCIATION;

(VII) THE GREATER REMINGTON IMPROVEMENT ASSOCIATION; AND

(VIII) THE WAIVERLY IMPROVEMENT ASSOCIATION”;

and strike beginning with “EXCEPT” in line 27 down through “BOARD” in line 29 and substitute “(I) THE ACCOUNTABILITY BOARD SHALL INCLUDE THE FOLLOWING DELEGATES, APPOINTED BY THE MEMBERS OF THE BALTIMORE CITY HOUSE DELEGATION TO THE GENERAL ASSEMBLY:

1. A DELEGATE WHO REPRESENTS THE 40TH LEGISLATIVE DISTRICT;

2. A DELEGATE WHO REPRESENTS THE 43RD LEGISLATIVE DISTRICT; AND

3. A DELEGATE WHO REPRESENTS THE 45TH LEGISLATIVE DISTRICT.

(II) THE ACCOUNTABILITY BOARD SHALL INCLUDE THE FOLLOWING SENATORS:

(Over)

1. THE SENATOR WHO REPRESENTS THE 40TH LEGISLATIVE DISTRICT;
2. THE SENATOR WHO REPRESENTS THE 43RD LEGISLATIVE DISTRICT; AND
3. THE SENATOR WHO REPRESENTS THE 45TH LEGISLATIVE DISTRICT”.

On page 5 of the Judicial Proceedings Committee Amendments, strike Amendment No. 5 in its entirety.

On page 14 of the bill, in line 1, strike “(I)” ; strike beginning with “(II)” in line 4 down through “SUBSECTION” in line 6 and substitute:

“(5) THE REMAINING MEMBERS OF THE ACCOUNTABILITY BOARD SHALL BE APPOINTED BY UNIVERSITY LEADERSHIP, SUBJECT TO THE APPROVAL OF THE BALTIMORE CITY COUNCIL”;

in line 10, strike the second “AND”; in line 12, after “TRAINING” insert “;

(4) REVIEW DATA GATHERED BY THE POLICE DEPARTMENT IN THE COURSE OF CONDUCTING ITS BUSINESS;

(5) SUBJECT TO TITLE 3, SUBTITLE 3 OF THE PUBLIC SAFETY ARTICLE, RECOMMEND DISCIPLINARY ACTION FOR AN OFFICER WHO IS FOUND TO HAVE ENGAGED IN MISCONDUCT; AND

(6) REVIEW VIDEO RECORDS MADE BY A BODY CAMERA WORN BY A UNIVERSITY POLICE OFFICER”;

in line 17, strike “AND”; and in line 19, after “PUBLIC” insert “;AND”

**(4) ESTABLISH A PROCESS TO:**

**(i) ALLOW ANY PERSON, INCLUDING MEMBERS OF THE POLICE DEPARTMENT, TO FILE COMPLAINTS AGAINST UNIVERSITY POLICE OFFICERS; AND**

**(ii) ENSURE TIMELY INVESTIGATION OF ALL COMPLAINTS REGARDING THE POLICE DEPARTMENT AND ITS EMPLOYEES”.**

On page 15 of the bill, in line 26, strike the second “AND”; and in line 28, after “DEPARTMENT” insert “;AND”

**(13) THE NUMBER OF LAWSUITS FILED AGAINST THE POLICE DEPARTMENT AND THE DISPOSITION OF EACH LAWSUIT”.**

On page 16 of the bill, in line 6, strike “TO THE EXTENT POSSIBLE”; and before line 14, insert:

**“(E) THE INFORMATION REPORTED UNDER THIS SECTION SHALL BE PUBLISHED ON THE UNIVERSITY’S WEBSITE.”.**

On page 18 of the bill, in line 10, after “WHO” insert “:

**1. RESIDE IN THE COMMUNITY WHERE AN INCIDENT BEING INVESTIGATED IS ALLEGED TO HAVE TAKEN PLACE; AND**

**2.”.**

(Over)

On page 21 of the bill, after line 3, insert:

“SECTION 5. AND BE IT FURTHER ENACTED, That on or before July 1, 2021, if the Johns Hopkins University establishes a police department under Section 2 of this Act, the University shall seek accreditation for the University police department authorized under Section 2 of this Act from:

- (1) the Commission on Accreditation for Law Enforcement Agencies;
- (2) the International Association of Campus Law Enforcement Administrators; or
- (3) a similar organization.

SECTION 6. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall remain in effect until July 1, 2021. Its continued effect shall be contingent on the receipt by the Johns Hopkins University of a letter confirming accreditation by an organization described under Section 5 of this Act. If the Johns Hopkins University does not receive a letter confirming accreditation on or before July 1, 2021, Section 2 of this Act, with no further action required by the General Assembly, shall be null and void and of no further force and effect. The Johns Hopkins University, within 5 days after receiving the accreditation letter from an organization described under Section 5 of this Act, shall forward a copy of the letter to the Department of Legislative Services, 90 State Circle, Annapolis, Maryland 21401.”;

and in line 4, strike “5.” and substitute “7.”.
