On page 1, at the top of the page, strike "EMERGENCY BILL"; in the sponsor line, strike "Senator Zirkin" and substitute "<u>Senators Zirkin, Nathan–Pulliam, Pinsky,</u> <u>and Young</u>"; in line 5, after "fee" insert "<u>under certain circumstances</u>"; in the same line, strike "requiring" and substitute "<u>authorizing</u>"; in line 8, strike "will" and substitute "<u>may</u>"; strike beginning with "prohibiting" in line 11 down through "application;" in line 12; strike beginning with "specifying" in line 14 down through "application;" in line 16; strike beginning with "requiring" in line 22 down through "manner;" in line 28; and in line 29, strike "making this Act an emergency measure;".

On page 2, in line 3, strike "14–615" and substitute "<u>14–610</u>".

#### <u>AMENDMENT NO. 2</u>

On page 2 in line 16, and on page 3 in line 8, in each instance, strike "AN INTERSTATE" and substitute " $\underline{A}$ ".

On page 2, strike in their entirety lines 18 through 22, inclusive; in line 23, strike "(E)" and substitute "<u>(C)</u>"; in line 25, strike "ACROSS MORE THAN ONE STATE"; strike beginning with "AN" in line 26 down through "ACT" in line 28 and substitute "<u>A PERMIT</u> <u>IS REQUIRED UNDER SECTION 404 OF THE FEDERAL CLEAN WATER ACT</u>"; and strike in their entirety lines 29 and 30.

On page 3, in line 1, strike "(G)" and substitute "<u>(D)</u>"; in line 12, after "FEE" insert "<u>, IF A FEE IS ESTABLISHED</u>,"; in line 14, strike "SHALL" and substitute "<u>MAY</u>"; strike beginning with "SHALL" in line 16 down through "**BASED**" in line 17 and substitute "<u>MAY BE BASED</u>"; in lines 18, 19, and 21, strike "(I)", "(II)", and "(III)", respectively,

and substitute "(1)", "(2)", and "(3)", respectively; and strike beginning with the semicolon in line 22 down through "**\$20,000**" in line 26.

On page 3 in line 11, and on page 4 in line 9, in each instance, strike "**28.08.02.10**" and substitute "<u>**26.08.02.10**</u>".

On page 4, in line 8, strike "(A)"; and strike in their entirety lines 10 and 11.

On pages 5 and 6, strike in their entirety the lines beginning with line 3 on page 5 through line 13 on page 6, inclusive.

On page 6, in line 14, strike "**14–609**." and substitute "**<u>14–608</u>**."; and in line 28, strike "**<u>14–610</u>**." and substitute "<u>**14–609**</u>."

On page 7, in line 17, strike "**14–611.**" and substitute "<u>**14–610.**</u>"; in line 10, strike "**14–609**" and substitute "<u>**14–608**</u>"; and in line 19, strike "**1 YEAR OF SUBMISSION OF** A COMPLETE APPLICATION" and substitute "<u>**THE PERIOD OF TIME AUTHORIZED**</u> <u>**UNDER FEDERAL LAW**".</u>

On page 8, strike in their entirety lines 1 through 30, inclusive.

## AMENDMENT NO. 3

On page 9, strike beginning with "is" in line 1 down through "enacted" in line 5 and substitute "<u>shall take effect June 1, 2019</u>".
