AMENDMENTS TO SENATE BILL 449  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “Election Day Voter”; in the same line, after “Registration” insert “and Voting at Precinct Polling Places”; in line 4, strike “certain”; in the same line, strike the second “to” and substitute “in the individual’s county of residence and”; strike beginning with “or” in line 4 down through “registration” in line 5; in line 5, strike “a certain” and substitute “an”; in line 6, after “registration” insert “on election day”; strike beginning with “verify” in line 7 down through “individual” in line 9 and substitute “determine whether an applicant for voter registration resides in the precinct and”; strike beginning with “requiring” in line 11 down through “circumstances;” in line 12; in line 13, strike “certain” and substitute “appropriate”; in line 14, after “addresses” insert “except under certain circumstances”; strike beginning with “requiring” in line 16 down through “manner;” in line 18; and in line 21, strike “election day voter registration” and substitute “registration and voting at precinct polling places”.

AMENDMENT NO. 2

On page 2, in line 24, strike “**THE**” and substitute “**A**”; strike beginning with “**THAT**” in line 25 down through “**(1)**” in line 28 and substitute “**AND**”; and strike beginning with the semicolon in line 28 down through “**REGISTRATION**” in line 30.

On page 3, in line 13, strike “**DESCRIBED UNDER SUBSECTION (A) OF THIS SECTION**”; strike beginning with the colon in line 14 down through “**(II)**” in line 17; in line 17, strike “**INDIVIDUAL**” and substitute “**APPLICANT RESIDES IN THE PRECINCT IN WHICH THE APPLICANT APPLIED AND**”; in line 19, strike “**AFTER VERIFYING THAT**” and substitute “**IF**”; in line 26, strike “**ISSUE THE VOTER A PROVISIONAL BALLOT**” and substitute “**;**”

**(I) ISSUE THE VOTER A VOTER AUTHORITY CARD;**

**(II) HAVE THE VOTER SIGN THE VOTER AUTHORITY CARD;**

**AND**

**(III) ISSUE THE VOTER A PROVISIONAL BALLOT**”;

and in line 27, strike “**THE**” and substitute “**UNLESS A LOCAL BOARD ELECTS TO MAKE THE NOTIFICATION, THE**”.

On page 4, strike in their entirety lines 5 through 15, inclusive; and in line 16, strike “**(F)**” and substitute “**(E)**”.
