## A BILL ENTITLED

1 AN ACT concerning

2 **Elections – Legislative and Congressional Redistricting and Apportionment –**  
3 **Commission and Process**

4 FOR the purpose of establishing the Legislative and Congressional Redistricting and  
5 Apportionment Commission as an independent unit of State government; providing  
6 for the intent of the General Assembly regarding legislative and congressional  
7 redistricting; requiring that the members of the Redistricting Commission be  
8 selected by a certain date in certain years in accordance with certain provisions of  
9 this Act; providing that the process for selecting members of the Redistricting  
10 Commission is designed to produce a certain Redistricting Commission; providing  
11 for the composition of the Redistricting Commission; providing for the qualifications,  
12 terms, duties, and compensation of members of the Redistricting Commission;  
13 requiring the State Ethics Commission to initiate a certain application process in  
14 certain years; requiring the Ethics Commission to remove certain applicants from a  
15 certain applicant pool; requiring the Ethics Commission to publish the names of  
16 certain applicants on or before a certain date of a certain year; providing for the  
17 selection and removal of members of the Redistricting Commission; providing for the  
18 process by which a certain vacancy is filled under certain circumstances; prohibiting  
19 members and employees of the Ethics Commission from communicating with certain  
20 elected officials or their employees or agents about certain matters; providing for a  
21 quorum and a chair for the Redistricting Commission; authorizing the Redistricting  
22 Commission to hire staff, attorneys, and consultants in accordance with the State  
23 budget; providing that employees of the Redistricting Commission are independent  
24 of the State Personnel Management System; providing that a certain finding may  
25 result in referral of a member or employee of the Redistricting Commission to the  
26 State Prosecutor; requiring the Redistricting Commission to conduct a certain

1 process, establish certain legislative and congressional districts, and conduct its  
2 business in a certain manner; providing that the activities of the Redistricting  
3 Commission are subject to the Open Meetings Act and the Maryland Public  
4 Information Act; requiring the Redistricting Commission to establish and implement  
5 a certain hearing process; authorizing the Redistricting Commission to supplement  
6 hearings with other activities subject to the discretion of the Redistricting  
7 Commission; requiring the Redistricting Commission to ensure certain plans are  
8 readily available to the public; requiring the Redistricting Commission to provide a  
9 certain public comment period before adopting certain plans; requiring the  
10 Redistricting Commission to take all steps necessary to ensure that a certain  
11 database is available and that procedures are in place to provide the public certain  
12 access to certain data and software for a certain purpose; requiring the Redistricting  
13 Commission to adopt certain plans that conform to certain standards; requiring a  
14 legislative districts plan to be numbered in a certain manner; requiring the  
15 Redistricting Commission to issue certain documents with certain plans; requiring  
16 the Redistricting Commission to certify and send certain plans to the presiding  
17 officers of the General Assembly; requiring the presiding officers to prepare certain  
18 plans for consideration by the General Assembly; requiring certain plans to be  
19 treated as a bill by the General Assembly for certain purposes; requiring the  
20 Redistricting Commission to petition the Court of Appeals to establish certain plans  
21 under certain circumstances; requiring the Redistricting Commission to represent  
22 the State in certain judicial proceedings; requiring the Redistricting Commission to  
23 intervene in certain cases on behalf of the State; providing that the Court of Appeals  
24 has original jurisdiction to establish legislative districts or the congressional districts  
25 under certain circumstances; authorizing certain voters to participate in a certain  
26 judicial proceeding as an amicus curiae; establishing a certain process for the Court  
27 of Appeals on the filing of a certain petition; requiring the Court of Appeals to give  
28 priority to ruling on a certain petition; requiring the Governor to include certain  
29 funding in the State budget; defining certain terms; making this Act contingent on  
30 the passage and ratification of a certain constitutional amendment; and generally  
31 relating to legislative and congressional redistricting and apportionment.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

13 (a) In this article the following words have the meanings indicated unless a  
14 different meaning is clearly intended from the context.

15 (dd) “Majority party” means the political party to which the incumbent Governor  
16 belongs, if the incumbent Governor is a member of a principal political party. If the  
17 incumbent Governor is not a member of one of the two principal political parties, “majority  
18 party” means the principal political party whose candidate for Governor received the  
19 highest number of votes of any party candidate at the last preceding general election.

20 (hh) “Political party” means an organized group that is qualified as a political party  
21 in accordance with Title 4 of this article.

22 (jj) “Principal minority party” means the principal political party whose candidate  
23 for Governor received the second highest number of votes of any party candidate at the last  
24 preceding general election.

25 (kk) “Principal political parties” means the majority party and the principal  
26 minority party.

13 IMPLEMENT THE PROVISIONS OF ARTICLE II, §§ 2, 3, AND 4, ARTICLE IV, § 14, AND  
14 ARTICLE XX, §§ 1 AND 2 OF THE MARYLAND CONSTITUTION.

22 (B) THE PROCESS FOR SELECTING THE MEMBERS OF THE REDISTRICTING  
23 COMMISSION IS DESIGNED TO PRODUCE A REDISTRICTING COMMISSION THAT IS:

24 (1) INDEPENDENT FROM LEGISLATIVE INFLUENCE; AND

25 (2) REASONABLY REPRESENTATIVE OF THE STATE'S GEOGRAPHICAL,  
26 RACIAL, AND GENDER MAKEUP.

28 (A) THE REDISTRICTING COMMISSION CONSISTS OF THE FOLLOWING NINE

1 MEMBERS:

2 (1) THREE MEMBERS REGISTERED WITH THE MAJORITY PARTY;

3 (2) THREE MEMBERS REGISTERED WITH THE PRINCIPAL MINORITY  
4 PARTY; AND

5 (3) THREE MEMBERS NOT REGISTERED WITH EITHER OF THE  
6 PRINCIPAL POLITICAL PARTIES.

7 (B) (1) A MEMBER OF A REDISTRICTING COMMISSION SHALL BE A  
8 REGISTERED VOTER WHO, FOR AT LEAST 3 YEARS IMMEDIATELY PRECEDING THE  
9 DATE OF SELECTION, HAS BEEN:

10 (I) CONTINUOUSLY REGISTERED IN THE STATE WITH THE SAME  
11 POLITICAL PARTY; OR

12 (II) CONTINUOUSLY NOT REGISTERED WITH A PRINCIPAL  
13 POLITICAL PARTY.

14 (2) A MEMBER OF A REDISTRICTING COMMISSION MAY NOT BE:

15 (I) A REPRESENTATIVE IN CONGRESS ELECTED FROM THE  
16 STATE OR A CANDIDATE FOR THAT OFFICE;

17 (II) A MEMBER OF THE GENERAL ASSEMBLY OF MARYLAND OR  
18 A CANDIDATE FOR THAT OFFICE;

19 (III) AN OFFICER OR EMPLOYEE OF A POLITICAL PARTY OR  
20 POLITICAL COMMITTEE;

21 (IV) 1. A CONTRACTOR PROVIDING PROFESSIONAL  
22 SERVICES TO:

23 A. THE GOVERNOR OR A CANDIDATE FOR THAT OFFICE;

24 B. A MEMBER OF THE GENERAL ASSEMBLY OF  
25 MARYLAND OR A CANDIDATE FOR THAT OFFICE; OR

26 C. A REPRESENTATIVE IN CONGRESS ELECTED FROM  
27 THE STATE OR A CANDIDATE FOR THAT OFFICE; OR

28 2. A CURRENT OR FORMER EMPLOYEE OF OR A

1 CONSULTANT TO AN INDIVIDUAL DESCRIBED IN ITEM 1 OF THIS ITEM;

2 (V) AN IMMEDIATE FAMILY MEMBER OF THE GOVERNOR OR OF  
3 AN INDIVIDUAL DESCRIBED IN ITEMS (I), (II), (III), OR (IV) OF THIS PARAGRAPH;

4 (VI) A STAFF MEMBER OF:

5 1. THE GOVERNOR OR A CANDIDATE FOR THAT OFFICE;

6 2. A MEMBER OF THE GENERAL ASSEMBLY OR A  
7 CANDIDATE FOR THAT OFFICE; OR

8 3. A REPRESENTATIVE IN CONGRESS ELECTED FROM  
9 THE STATE OR A CANDIDATE FOR THAT OFFICE; OR

10 (VII) A CURRENT OR FORMER REGISTERED LOBBYIST.

11 (C) (1) THE TERM OF A MEMBER OF THE REDISTRICTING COMMISSION  
12 EXPIRES ON FEBRUARY 28 EACH YEAR ENDING IN THE NUMBER ONE.

13 (2) A MEMBER OF THE REDISTRICTING COMMISSION IS NOT  
14 ELIGIBLE FOR REAPPOINTMENT.

15 (D) EACH MEMBER OF THE REDISTRICTING COMMISSION SHALL:

16 (1) APPLY THE PROVISIONS OF THIS SUBTITLE IN A MANNER THAT IS  
17 IMPARTIAL AND THAT REINFORCES PUBLIC CONFIDENCE IN THE INTEGRITY OF THE  
18 REDISTRICTING PROCESS; AND

19 (2) BE INELIGIBLE FOR A PERIOD OF 5 YEARS BEGINNING FROM THE  
20 DATE OF SELECTION TO:

21 (I) HOLD APPOINTIVE FEDERAL, STATE, OR LOCAL PUBLIC  
22 OFFICE;

23 (II) SERVE AS PAID STAFF FOR THE GENERAL ASSEMBLY OR  
24 ANY INDIVIDUAL MEMBER; OR

25 (III) REGISTER AS A STATE, COUNTY, OR MUNICIPAL LOBBYIST  
26 IN THE STATE.

27 (E) A MEMBER OF THE REDISTRICTING COMMISSION:

1           **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE**  
2 **REDISTRICTING COMMISSION; BUT**

3           **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**  
4 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

6           **(A) (1) IN EACH YEAR ENDING IN THE NUMBER ZERO, ON OR BEFORE**  
7 **DECEMBER 15 THE ETHICS COMMISSION SHALL INITIATE AN APPLICATION**  
8 **PROCESS FOR MEMBERSHIP ON THE REDISTRICTING COMMISSION.**

9           **(2) THE APPLICATION PROCESS SHALL:**

10           **(I) BE OPEN TO ALL REGISTERED VOTERS IN THE STATE; AND**

11           **(II) BE CONDUCTED IN A MANNER THAT PROMOTES THE**  
12 **RECRUITMENT OF A DIVERSE AND QUALIFIED APPLICANT POOL.**

13           **(B) THE ETHICS COMMISSION SHALL REMOVE FROM THE APPLICANT**  
14 **POOL APPLICANTS WHO ARE INELIGIBLE UNDER § 8-7A-05(B)(2) OF THIS SUBTITLE.**

15           **(C) (1) ON OR BEFORE JANUARY 15 EACH YEAR ENDING IN THE NUMBER**  
16 **ONE, THE ETHICS COMMISSION SHALL PUBLISH THE NAMES OF ALL THE ELIGIBLE**  
17 **APPLICANTS.**

18           **(2) THE ETHICS COMMISSION SHALL:**

19           **(I) DETERMINE THE MOST QUALIFIED APPLICANTS ON THE**  
20 **BASIS OF RELEVANT ANALYTICAL SKILLS, ABILITY TO BE IMPARTIAL, AND**  
21 **APPRECIATION FOR THE STATE'S DIVERSE DEMOGRAPHICS AND GEOGRAPHY; AND**

22           **(II) SELECT THE 30 MOST QUALIFIED APPLICANTS, AS**  
23 **FOLLOWS:**

24           **1. 10 APPLICANTS WHO ARE REGISTERED WITH THE**  
25 **MAJORITY PARTY;**

26           **2. 10 APPLICANTS WHO ARE REGISTERED WITH THE**  
27 **PRINCIPAL MINORITY PARTY; AND**

28           **3. 10 APPLICANTS WHO ARE NOT REGISTERED WITH**  
29 **EITHER OF THE TWO PRINCIPAL POLITICAL PARTIES.**

1           **(3) ON OR BEFORE FEBRUARY 15 EACH YEAR ENDING IN THE**  
2 **NUMBER ONE, THE ETHICS COMMISSION SHALL RANDOMLY SELECT THE NINE**  
3 **MEMBERS FROM THE 30 APPLICANTS CHOSEN UNDER PARAGRAPH (2) OF THIS**  
4 **SUBSECTION AS FOLLOWS:**

5                   **(I) THREE MEMBERS REGISTERED WITH THE MAJORITY PARTY;**

6                   **(II) THREE MEMBERS REGISTERED WITH THE PRINCIPAL**  
7 **MINORITY PARTY; AND**

8                   **(III) THREE MEMBERS WHO ARE NOT REGISTERED WITH EITHER**  
9 **OF THE TWO PRINCIPAL POLITICAL PARTIES.**

10           **(D) THE NINE APPLICANTS SELECTED UNDER SUBSECTION (C)(3) OF THIS**  
11 **SECTION SHALL SERVE AS THE MEMBERS OF THE REDISTRICTING COMMISSION**  
12 **BEGINNING ON MARCH 1 EACH YEAR ENDING IN THE NUMBER ONE.**

13           **(E) (1) IF THERE IS A VACANCY IN THE MEMBERSHIP OF THE**  
14 **REDISTRICTING COMMISSION, THE ETHICS COMMISSION SHALL FILL THE VACANCY**  
15 **WITHIN 30 DAYS AFTER THE VACANCY OCCURS BY RANDOMLY SELECTING ANOTHER**  
16 **MEMBER FROM THE APPLICANTS CHOSEN UNDER SUBSECTION (C)(2)(II) OF THIS**  
17 **SECTION.**

18                   **(2) (I) SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, IF**  
19 **NONE OF THE REMAINING APPLICANTS CHOSEN UNDER PARAGRAPH (1) OF THIS**  
20 **SUBSECTION ARE AVAILABLE FOR SERVICE, THE ETHICS COMMISSION SHALL FILL**  
21 **THE VACANCY FROM A NEW APPLICANT POOL USING THE PROCEDURES**  
22 **ESTABLISHED UNDER SUBSECTIONS (A) AND (B) OF THIS SECTION.**

23                   **(II) THE ETHICS COMMISSION MAY LIMIT APPLICATIONS TO**  
24 **VOTERS OF THE SAME VOTER REGISTRATION CATEGORY AS THE VACANT MEMBER.**

25           **(F) THE MEMBERS AND EMPLOYEES OF THE ETHICS COMMISSION MAY NOT**  
26 **COMMUNICATE WITH THE GOVERNOR, ANY MEMBER OF THE GENERAL ASSEMBLY,**  
27 **ANY REPRESENTATIVE IN CONGRESS ELECTED FROM THE STATE, OR THEIR**  
28 **EMPLOYEES OR AGENTS ABOUT ANY MATTER RELATED TO THE SELECTION OF**  
29 **MEMBERS FOR THE REDISTRICTING COMMISSION.**

30           **(G) (1) THE ETHICS COMMISSION MAY REMOVE A MEMBER OF THE**  
31 **REDISTRICTING COMMISSION:**

32                   **(I) FOR NEGLIGENCE OF DUTY;**



1 (II) FOR MISCONDUCT IN OFFICE;

2 (III) FOR A DISABILITY THAT MAKES THE MEMBER UNABLE TO  
3 DISCHARGE THE POWERS AND DUTIES OF OFFICE;

4 (IV) FOR FAILING TO MAINTAIN THE QUALIFICATIONS UNDER §  
5 8-7A-05 OF THIS SUBTITLE; OR

6 (V) IF THE MEMBER IS CONVICTED OF OR PLEADS GUILTY OR  
7 NOLO CONTENDERE WITH RESPECT TO A FELONY OR CRIME INVOLVING MORAL  
8 TURPITUDE, WHETHER OR NOT ANY APPEAL OR OTHER PROCEEDING IS PENDING TO  
9 HAVE THE CONVICTION OR PLEA SET ASIDE.

10 (2) BEFORE REMOVING A MEMBER OF THE REDISTRICTING  
11 COMMISSION, THE ETHICS COMMISSION SHALL GIVE THE MEMBER:

12 (I) WRITTEN NOTICE OF THE CHARGES; AND

13 (II) AN OPPORTUNITY TO ANSWER THE CHARGES.

14 (3) AT LEAST FOUR VOTES OF THE ETHICS COMMISSION SHALL BE  
15 REQUIRED TO REMOVE A MEMBER OF THE REDISTRICTING COMMISSION UNDER  
16 THIS SUBSECTION.

17 8-7A-07.

18 (A) (1) SEVEN MEMBERS OF THE REDISTRICTING COMMISSION IS A  
19 QUORUM.

20 (2) SEVEN OR MORE AFFIRMATIVE VOTES OF THE MEMBERS IS  
21 REQUIRED FOR ANY OFFICIAL ACTION OF THE REDISTRICTING COMMISSION,  
22 INCLUDING APPROVAL OF:

23 (I) ANY PLAN FOR LEGISLATIVE DISTRICTS OR  
24 CONGRESSIONAL DISTRICTS ADOPTED BY THE REDISTRICTING COMMISSION; AND

25 (II) ANY CHANGES TO AN APPROVED PLAN.

26 (B) FROM AMONG ITS MEMBERS, THE REDISTRICTING COMMISSION SHALL  
27 ELECT ONE MEMBER TO SERVE AS CHAIR.

28 (C) (1) THE REDISTRICTING COMMISSION MAY HIRE STAFF, ATTORNEYS,

1 AND CONSULTANTS IN ACCORDANCE WITH THE STATE BUDGET.

2 (2) EMPLOYEES OF THE REDISTRICTING COMMISSION SHALL BE  
3 INDEPENDENT OF THE STATE PERSONNEL MANAGEMENT SYSTEM.

4 (D) A FINDING OF A POSSIBLE CRIMINAL VIOLATION BY A MEMBER OR AN  
5 EMPLOYEE OF THE REDISTRICTING COMMISSION MAY RESULT IN REFERRAL TO THE  
6 STATE PROSECUTOR FOR CRIMINAL PROSECUTION.

8 (A) THE REDISTRICTING COMMISSION SHALL:

9 (1) CONDUCT A PROCESS THAT IS OPEN AND TRANSPARENT TO  
10 ENABLE FULL PUBLIC CONSIDERATION OF AND COMMENT ON THE ESTABLISHMENT  
11 OF LEGISLATIVE DISTRICTS AND CONGRESSIONAL DISTRICTS;

12 (2) ESTABLISH LEGISLATIVE DISTRICTS AND CONGRESSIONAL  
13 DISTRICTS ACCORDING TO THE REDISTRICTING STANDARDS SET FORTH IN THIS  
14 SUBTITLE AND ARTICLE II, §§ 3 AND 4 AND ARTICLE XX, § 1 OF THE MARYLAND  
15 CONSTITUTION; AND

16 (3) CONDUCT BUSINESS WITH INTEGRITY AND FAIRNESS.

17 (B) THE ACTIVITIES OF THE REDISTRICTING COMMISSION ARE SUBJECT TO  
18 THE OPEN MEETINGS ACT AND THE MARYLAND PUBLIC INFORMATION ACT.

19 (C) (1) THE REDISTRICTING COMMISSION SHALL ESTABLISH AND  
20 IMPLEMENT A HEARING PROCESS THAT IS OPEN TO THE PUBLIC FOR PUBLIC INPUT  
21 AND DELIBERATION THAT IS:

22 (I) SUBJECT TO PUBLIC NOTICE; AND

23 (II) DESIGNED TO ENCOURAGE CITIZEN OUTREACH AND TO  
24 SOLICIT BROAD PUBLIC PARTICIPATION IN THE REDISTRICTING PROCESS.

25 (2) (I) THE HEARING PROCESS ESTABLISHED UNDER PARAGRAPH  
26 (1) OF THIS SUBSECTION SHALL INCLUDE THE SCHEDULING OF HEARINGS:

27 1. TO RECEIVE PUBLIC INPUT BEFORE THE  
28 CONSIDERATION OF ANY PLAN BY THE REDISTRICTING COMMISSION; AND

29 2. FOLLOWING THE PROPOSAL OF A PLAN BY THE

1 **REDISTRICTING COMMISSION.**

2 (II) HEARINGS MAY BE SUPPLEMENTED WITH OTHER  
3 ACTIVITIES AS DETERMINED APPROPRIATE BY THE REDISTRICTING COMMISSION
