3 FOR the purpose of establishing the Public Charter School Facility Fund as a special, 4 nonlapsing fund; specifying the purpose of the Fund; requiring the State Department 5 of Education to administer the Fund; requiring the State Treasurer to hold the Fund 6 and the Comptroller to account for the Fund; specifying the contents of the Fund; 7 specifying the purpose for which the Fund may be used; providing for the investment 8 of money in and expenditures from the Fund; requiring interest earnings of the Fund 9 to be credited to the Fund; exempting the Fund from a certain provision of law requiring interest earnings on State money to accrue to the General Fund of the 10 11 State; requiring the amount of funding provided to a public charter school for each 12 fiscal year to be equal to certain facility expenses, subject to a certain limitation; 13 requiring the Governor to appropriate a certain amount to the Fund each year; 14 requiring the Department to establish certain procedures for public charter schools 15 to request funds; requiring the Department to establish certain award procedures; 16 defining certain terms; providing for the construction of this Act; and generally 17 relating to the Public Charter School Facility Fund.

- 5 (C) THE PURPOSE OF THE FUND IS TO PROVIDE FUNDING ON AN ANNUAL BASIS TO PUBLIC CHARTER SCHOOLS IN THE STATE TO ACQUIRE, PLAN, DEVELOP, FINANCE, CONSTRUCT, LEASE, IMPROVE, REPAIR, AND MAINTAIN PUBLIC CHARTER SCHOOL FACILITIES.
- 9 (D) THE DEPARTMENT SHALL ADMINISTER THE FUND.
- 10 **(E) (1)** THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT 11 SUBJECT TO § 7–302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.
- 12 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY, 13 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.
- 14 **(F)** THE FUND CONSISTS OF:
- 15 (1) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;
- 16 (2) ANY INTEREST EARNINGS OF THE FUND; AND
- 17 (3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR 18 THE BENEFIT OF THE FUND.
- 19 (G) THE FUND MAY BE USED ONLY TO PROVIDE FUNDING TO PUBLIC 20 CHARTER SCHOOLS IN THE STATE TO ACQUIRE, PLAN, DEVELOP, FINANCE, 21 CONSTRUCT, LEASE, IMPROVE, REPAIR, AND MAINTAIN PUBLIC CHARTER SCHOOL
- 22 FACILITIES.
- 23 (H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND 24 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.
- 25 (2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO 26 THE FUND.
- 27 (I) (1) SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, THE AMOUNT
 28 OF FUNDING PROVIDED TO A PUBLIC CHARTER SCHOOL UNDER THIS SECTION FOR
 29 EACH FISCAL YEAR SHALL BE EQUAL TO THE ELIGIBLE FACILITY EXPENSES THAT

- 2 (2) THE GOVERNOR ANNUALLY SHALL APPROPRIATE TO THE FUND 3 AN AMOUNT THAT EQUALS OR EXCEEDS THE TOTAL AGGREGATE ENROLLMENT IN 4 PUBLIC CHARTER SCHOOLS IN THE STATE MULTIPLIED BY \$1,600.
- 5 (3) THE AMOUNT OF FUNDING PROVIDED TO A PUBLIC CHARTER SCHOOL UNDER THIS SECTION FOR A SINGLE FISCAL YEAR MAY NOT EXCEED \$1,600 PER PUPIL ENROLLED IN THE PUBLIC CHARTER SCHOOL AS OF SEPTEMBER 30 OF THAT FISCAL YEAR.
- 9 (J) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE DEPARTMENT SHALL ESTABLISH APPLICATION PROCEDURES FOR PUBLIC CHARTER SCHOOLS TO REQUEST FUNDS UNDER THIS SECTION.
- 12 **(2)** THE DEPARTMENT SHALL ESTABLISH AWARD PROCEDURES TO MAKE AWARDS DISTRIBUTED FROM THE FUND NOT MORE THAN 45 DAYS AFTER RECEIVING AN APPLICATION.
- 15 (K) NOTHING IN THIS SECTION SHALL BE CONSTRUED TO REDUCE THE AMOUNT OF FUNDING TO WHICH PUBLIC CHARTER SCHOOLS ARE ENTITLED UNDER \$ 9–109 OF THIS ARTICLE.
