#### 1 AN ACT concerning

#### State Government – Written Policies for Public Communications – Revisions $\mathbf{2}$

- 3 FOR the purpose of requiring each unit in the Executive Branch to revise certain policies,
- submit the revised policies to a certain committee of the General Assembly, and post 4
- $\mathbf{5}$ the revised policies on the unit's website in a conspicuous place on or before a certain
- 6 date with a certain frequency; and generally relating to revisions to written policies
- 7 for public communications in State government.

#### SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 18 19That the Laws of Maryland read as follows:

### **Article – State Government**

- 22In this subtitle the following words have the meanings indicated. (a)

#### 23(b) "Public communication" means any inquiry, request, or complaint made by the 24public.

(c) "Unit" means each unit in the Executive Branch of the State government.
10-802.
Each unit shall adopt written policies that are within the legal authority of the unit for:
(1) the procedures to be followed by the unit in responding to a public communication;
(2) the circumstances that require the unit to maintain a record of a public communication and of the response of the unit; and
(3) the manner of maintaining records of public communications and of the responses of the unit.
10-803.
(A) Each unit shall submit the policies required under § 10–802 of this subtitle to the Joint Committee on Administrative, Executive, and Legislative Review.
(B) ON OR BEFORE DECEMBER 31, 2019, AND EVERY 4 YEARS THEREAFTER, EACH UNIT SHALL:
(1) REVISE THE POLICIES REQUIRED UNDER § 10–802 OF THIS SUBTITLE;
(2) SUBMIT THE REVISED POLICIES TO THE JOINT COMMITTEE ON ADMINISTRATIVE, EXECUTIVE, AND LEGISLATIVE REVIEW; AND
(3) POST THE REVISED POLICIES ON THE UNIT'S WEBSITE IN A CONSPICUOUS PLACE.
SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019.
