- and governmental units that will best serve the public convenience and promote the sale of

- 29 (c) Before issuing a license to an applicant, the Director shall consider such
- 30 factors as:

1 (1) the financial responsibility and security of the applicant and the 2 business or activity of the applicant; 3 (2)the accessibility of the place of business or activity to the public; 4 (3) the sufficiency of existing licenses to serve the public convenience; and the volume of expected sales. 5 **(4)** 6 (d) This subsection does not apply in: (1) 7 (i) Caroline County; 8 (ii) Cecil County; 9 (iii) Dorchester County; 10 (iv) Kent County: 11 Queen Anne's County; (v) 12(vi) Somerset County; 13 Talbot County; (vii) 14 Wicomico County; and (viii) 15 (ix) Worcester County. 16 (2)(i) Subject to subparagraph (ii) of this paragraph, the Director may 17 issue a license under this subtitle for not more than five instant ticket lottery machines to 18 an applicant that is a veterans' organization OR FRATERNAL ORGANIZATION. 19 A veterans' organization OR FRATERNAL ORGANIZATION that 20 is issued a license under this subsection shall locate and operate its instant ticket lottery machines at its principal meeting hall in the county in which the veterans' organization OR 2122 FRATERNAL ORGANIZATION is located. 23 **(I)** After deduction of any commission and validation prize payout 24as provided under § 9-117 of this subtitle, a veterans' organization issued a license under this subsection shall credit the remaining receipts from the sale of tickets from instant 25ticket lottery machines to the State Lottery Fund established under § 9–118 of this subtitle. 26

- purchase or lease the instant ticket lottery machines to be used by the veterans' organization **OR FRATERNAL ORGANIZATION**.
- 3 (ii) An organization may not use receipts from the sale of tickets 4 from instant ticket lottery machines that would otherwise be credited to the State Lottery 5 Fund for the costs of purchasing or leasing instant ticket lottery machines.
- 6 (III) A FRATERNAL ORGANIZATION MAY PURCHASE OR LEASE
  7 ITS INSTANT TICKET LOTTERY MACHINES FROM ANY VENDOR THAT IS APPROVED BY
  8 THE AGENCY TO SELL OR LEASE INSTANT TICKET LOTTERY MACHINES TO A
  9 FRATERNAL ORGANIZATION.
- 10 (5) The Director may adopt regulations to implement the provisions of this 11 subsection that [included] INCLUDE restricting the location of instant ticket lottery 12 machines in areas of a veterans' organization's OR FRATERNAL ORGANIZATION'S public 13 meeting hall that is accessible to the public.
- 14 (6) The [State Lottery and Gaming Control] Agency shall ensure that the element of chance in the conduct of the gaming through the instant ticket lottery machines established under this subsection is consistent with the holding in the case of Chesapeake Amusements Inc. v. Riddle, 363 Md. 16 (2001), in that the element of chance must be wholly within the pre—printed instant lottery ticket, and that player enhancements in an instant ticket lottery machine may not affect the element of chance being wholly within the pre—printed instant lottery ticket.
- 21 (e) The Director may not issue a license to:
- 22 (1) a person or governmental unit to engage in business primarily as a 23 licensed agent; or
- 24 (2) an individual who is under the age of 21 years.
- 25 (f) The Commission may hear and decide an appeal of a denial of a license.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019.
