8 9	(c)] The Board may issue a 7-day Class C (on-sale) beer, wine, and liquor license to a volunteer fire department.
10 11	[(d)] (C) (1) Subject to [subsection (b) of this section and] paragraph (2) of this subsection:
12 13	(i) the Board may issue [not more than two] Class H beer and wine, hotel and restaurant licenses; and
14	(ii) the licenses may be renewed or transferred.
15	(2) A license may be issued, transferred, or renewed if:
16 17	(i) pool tables, billiard tables, shuffleboards, dart boards, video games, pinball machines, or recreational devices are not used in the licensed premises; and
18 19	(ii) alcoholic beverages served by the license holder are consumed by customers while the customers are seated.
20 21	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019.
