A BILL ENTITLED

1 AN ACT concerning

2 Baltimore City Board of School Commissioners – Elected Voting Members

3 FOR the purpose of increasing the number of elected voting members on the Baltimore City 4 Board of School Commissioners; requiring each elected voting member of the board $\mathbf{5}$ to be elected from certain districts of Baltimore City; establishing the terms of the 6 elected voting members of the board; prohibiting a certain individual who has filed 7 a certain certificate of candidacy from seeking appointment to the board or being 8 appointed to the board by the Mayor of Baltimore City; requiring certain elected 9 members to be a resident of a certain district; prohibiting a certain elected member from continuing to serve as a member under certain circumstances; requiring the 1011 Baltimore City Council to appoint an individual to fill a certain vacancy on the board; 12providing that the terms of certain elected members are staggered as provided by a 13 certain provision of law on a certain date; providing for the initial terms of certain 14elected members; defining a certain term; and generally relating to membership of 15the Baltimore City Board of School Commissioners.

(e) Each member of the board shall be a resident of Baltimore City.

5 (f) (1) [The two] OF THE SIX elected voting members [shall be elected at large 6 by the voters of Baltimore City], ONE SHALL BE ELECTED FROM EACH OF THE SIX 7 LEGISLATIVE DISTRICTS OF BALTIMORE CITY ONLY BY THE VOTERS OF THAT 8 LEGISLATIVE DISTRICT.

9 (2) EACH ELECTED VOTING MEMBER FROM A LEGISLATIVE DISTRICT 10 SHALL BE A RESIDENT OF THAT LEGISLATIVE DISTRICT.

11(3)EACH ELECTED VOTING MEMBER FROM A LEGISLATIVE DISTRICT12WHO NO LONGER RESIDES IN THAT DISTRICT MAY NOT CONTINUE AS AN ELECTED13VOTING MEMBER FOR THAT DISTRICT.

- 14(4) THE BALTIMORE CITY COUNCIL SHALL APPOINT A QUALIFIED15INDIVIDUAL TO FILL A VACANCY OF AN ELECTED VOTING MEMBER FOR THE16REMAINDER OF THE TERM AND UNTIL A SUCCESSOR IS ELECTED AND QUALIFIES.

(i) (1) (i) The term of an appointed voting member is 3 years.

(ii) The term of an elected **VOTING** member is 4 years.

19 (2) (1) The terms of the appointed voting members are staggered as 20 required by the terms provided for the appointed members of the board on June 1, 1997.

21 (II) THE TERMS OF ELECTED VOTING MEMBERS ARE 22 STAGGERED AS REQUIRED BY THE TERMS PROVIDED FOR ELECTED VOTING 23 MEMBERS OF THE BOARD ON OCTOBER 1, 2019.

24 (3) At the end of a term, a voting member continues to serve until a 25 successor is elected or appointed and qualifies.

26 (4) A voting member who is appointed after a term has begun serves only 27 for the remainder of the term and until a successor is elected or appointed and qualifies.

(5) A voting member may not serve more than two consecutive full terms.

(6) (i) Except as provided in subparagraph (ii) of this paragraph, to the
extent practicable, the Mayor shall fill any vacancy for an appointed or elected member on
the board within 60 days of the date of the vacancy from a list of qualified individuals
