A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Alcoholic Beverages – Class B–D–7 Licenses**

3 FOR the purpose of adding a certain location in which the Board of License Commissioners
4 for Baltimore City may issue a Class B–D–7 license; and generally relating to
5 alcoholic beverages licenses issued in Baltimore City.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Alcoholic Beverages**

19 12–102.

20 This title applies only in Baltimore City.

1 (1) in the alcoholic beverages districts specified in subsection (b) of this
2 section:

3 (i) a 1-day license; or

4 (ii) a Class B beer, wine, and liquor license to a restaurant that:

5 1. has a minimum capital investment, not including the cost
6 of land and buildings, of \$200,000 for restaurant facilities; and

7 2. has a minimum seating capacity of 75 individuals;

8 (2) a Class C beer, wine, and liquor license in the 45th alcoholic beverages
9 district;

10 (3) a Class C beer, wine, and liquor license in ward 5, precinct 1 of the 44th
11 alcoholic beverages district;

12 (4) a Class C beer, wine, and liquor license in the 200 block of West
13 Saratoga Street in ward 4, precinct 3 of the 40th alcoholic beverages district;

14 (5) a Class B-D-7 license in the unit block of West North Avenue in the
15 45th alcoholic beverages district;

16 **(6) A CLASS B-D-7 LICENSE IN THE 5300 BLOCK OF BELAIR ROAD,**
17 **BOUNDED BY FRANKFORD AVENUE ON THE NORTH, NUTH AVENUE ON THE EAST,**
18 **COOK AVENUE ON THE SOUTH, AND BELAIR ROAD ON THE WEST, IN THE 45TH**
19 **ALCOHOLIC BEVERAGES DISTRICT;**

20 **[(6)] (7)** two Class B-D-7 licenses in the 2100 block of North Charles
21 Street in the 43rd alcoholic beverages district;

22 **[(7)] (8)** two Class B-D-7 licenses in the 2100 block of Maryland Avenue
23 in the 43rd alcoholic beverages district; and

24 **[(8)] (9)** subject to the requirements under subsection (e) of this section,
25 four Class B-D-7 licenses in the 43rd alcoholic beverages district.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
27 1, 2019.
