- 1 (x) (1) In this subsection, "eligible teacher" means an individual who is a 2 kindergarten through grade 12 classroom teacher in an elementary or secondary school in 3 the State on a full–time basis for an academic year ending during the taxable year.
 - (2) Subject to paragraph (3) of this subsection, the subtraction allowed under subsection (a) of this section includes up to [\$250] **\$500** of the unreimbursed expenses paid or incurred by an eligible teacher during a taxable year for the purchase of classroom supplies if the supplies are used by:
- 8 (i) students in the classroom; or
- 9 (ii) the eligible teacher to prepare for or during classroom teaching.
- 10 (3) The amount allowed as a subtraction under paragraph (2) of this subsection does not include an expense that is subtracted from federal adjusted gross income under § 62 of the Internal Revenue Code.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019, and shall be applicable to all taxable years beginning after December 31, 2018.
