Article – Public Safety

1-301.

(a) In this subtitle the following words have the meanings indicated.

(b) “Additional charge” means the charge imposed by a county in accordance with § 1-311 of this subtitle.

(c) “Board” means the Emergency Number Systems Board.

(d) “Commercial mobile radio service” or “CMRS” means mobile telecommunications service that is:

(1) provided for profit with the intent of receiving compensation or monetary gain;

(2) an interconnected, two-way voice service; and

(3) available to the public.

(e) “Commercial mobile radio service provider” or “CMRS provider” means a person authorized by the Federal Communications Commission to provide CMRS in the State.

1 (f) "County plan" means a plan for a 9-1-1 system or enhanced 9-1-1 system, or
2 an amendment to the plan, developed by a county or several counties together under this
3 subtitle.

4 (g) (1) "Customer" means:

5 (i) the person that contracts with a home service provider for CMRS;
6 or

7 (ii) the end user of the CMRS if the end user of the CMRS is not the
8 contracting party.

9 (2) "Customer" does not include:

10 (i) a reseller of CMRS; or

11 (ii) a serving carrier under an arrangement to serve the customer
12 outside the home service provider's licensed service area.

13 (h) "Enhanced 9-1-1 system" means a 9-1-1 system that provides:

14 (1) automatic number identification;

15 (2) automatic location identification; and

16 (3) any other technological advancements that the Board requires.

17 (i) "FCC order" means an order issued by the Federal Communications
18 Commission under proceedings regarding the compatibility of enhanced 9-1-1 systems and
19 delivery of wireless enhanced 9-1-1 service.

20 (j) "Home service provider" means the facilities-based carrier or reseller that
21 contracts with a customer to provide CMRS.

22 (k) "Next [generation] **GENERATION** 9-1-1 services" means an Internet Protocol
23 (IP)-based system, comprised of hardware, software, data, and operational policies and
24 procedures, that:

25 (1) provides standardized interfaces from emergency call and message
26 services to support emergency communications;

27 (2) processes all types of [emergency calls] **REQUESTS FOR EMERGENCY**
28 **SERVICES**, including voice, text, data, and multimedia information;

29 (3) acquires and integrates additional emergency call data useful to [call]
30 routing and handling **OF REQUESTS FOR EMERGENCY SERVICES**;

1 (4) delivers the emergency calls, messages, and data to the appropriate
2 public safety answering point and other appropriate emergency entities;

3 (5) supports data or video communications needs for coordinated incident
4 response and management; and

5 (6) provides broadband service to public safety answering points or other
6 first responder entities.

7 (l) “9-1-1-accessible service” means telephone service or another
8 communications service that connects an individual dialing the digits 9-1-1 to an
9 established public safety answering point.

10 (m) “9-1-1 fee” means the fee imposed in accordance with § 1-310 of this subtitle.

11 (n) (1) “9-1-1 service carrier” means a provider of CMRS or other
12 9-1-1-accessible service.

13 (2) “9-1-1 service carrier” does not include a telephone company.

14 **(O) “9-1-1 SPECIALIST” MEANS AN EMPLOYEE OF A COUNTY PUBLIC**
15 **SAFETY ANSWERING POINT, OR AN EMPLOYEE WORKING IN A COUNTY PUBLIC**
16 **SAFETY ANSWERING POINT, WHOSE DUTIES AND RESPONSIBILITIES INCLUDE:**

17 **(1) RECEIVING AND PROCESSING 9-1-1 REQUESTS FOR EMERGENCY**
18 **SERVICES;**

19 **(2) OTHER SUPPORT FUNCTIONS DIRECTLY RELATED TO 9-1-1**
20 **REQUESTS FOR EMERGENCY SERVICES; OR**

21 **(3) DISPATCHING LAW ENFORCEMENT OFFICERS, FIRE RESCUE**
22 **SERVICES, EMERGENCY MEDICAL SERVICES, AND OTHER PUBLIC SAFETY SERVICES**
23 **TO THE SCENE OF AN EMERGENCY.**

24 **[(o)] (P)** (1) “9-1-1 system” means telephone service that:

25 (i) meets the planning guidelines established under this subtitle;
26 and

27 (ii) automatically connects an individual dialing the digits 9-1-1 to
28 an established public safety answering point.

29 (2) “9-1-1 system” includes:

30 (i) equipment for connecting and outswitching 9-1-1 calls within a
31 telephone central office;

1 (ii) trunking facilities from a telephone central office to a public
2 safety answering point; and

3 (iii) equipment to connect 9-1-1 calls to the appropriate public safety
4 agency.

5 **[(p)] (Q)** “9-1-1 Trust Fund” means the fund established under § 1-308 of this
6 subtitle.

7 **[(q)] (R)** “Prepaid wireless E 9-1-1 fee” means the fee that is required to be
8 collected by a seller from a consumer in the amount established under § 1-313 of this
9 subtitle.

10 **[(r)] (S)** “Prepaid wireless telecommunications service” means a commercial
11 mobile radio service that:

12 (1) allows a consumer to dial 9-1-1 to access the 9-1-1 system;

13 (2) must be paid for in advance; and

14 (3) is sold in predetermined units that decline with use in a known amount.

15 **[(s)] (T)** “Public safety agency” means:

16 (1) a functional division of a public agency that provides fire fighting,
17 police, medical, or other emergency services; or

18 (2) a private entity that provides fire fighting, police, medical, or other
19 emergency services on a voluntary basis.

20 **[(t)] (U)** “Public safety answering point” means a communications facility that:

21 (1) is operated on a 24-hour basis;

22 (2) first receives 9-1-1 **[calls] REQUESTS FOR EMERGENCY SERVICES** in
23 a 9-1-1 service area; and

24 (3) as appropriate, dispatches public safety services directly, or transfers
25 9-1-1 **[calls] REQUESTS FOR EMERGENCY SERVICES** to appropriate public safety
26 agencies.

27 **[(u)] (V)** “Secretary” means the Secretary of Public Safety and Correctional
28 Services.

1 [(v)] (W) “Seller” means a person that sells prepaid wireless telecommunications
2 service to another person.

3 [(w)] (X) “Wireless enhanced 9–1–1 service” means enhanced 9–1–1 service
4 under an FCC order.

6 (a) (1) This subtitle does not require a public service company to provide any
7 equipment or service other than in accordance with tariffs approved by the Public Service
8 Commission.

9 (2) The provision of services, the rates, and the extent of liability of a public
10 service company are governed by the tariffs approved by the Public Service Commission.

11 (b) (1) This subtitle does not require a 9–1–1 service carrier to provide any
12 equipment or service other than the equivalent of the equipment and service required of a
13 telephone company under subsection (a) of this section.

14 (2) This subtitle does not extend any liability to a 9–1–1 service carrier or
15 seller of prepaid wireless telecommunications service.

17 (f) (1) Each public safety answering point shall notify the public safety
18 agencies in a county 9–1–1 system of [calls for assistance] **REQUESTS FOR EMERGENCY**
19 **SERVICES** in the county.

20 (2) Written guidelines shall be developed to govern the referral of [calls for
21 assistance] **REQUESTS FOR EMERGENCY SERVICES** to the appropriate public safety
22 agency.

23 (3) State, county, and local public safety agencies with concurrent
24 jurisdiction shall have written agreements to ensure a clear understanding of which specific
25 [calls for assistance] **REQUESTS FOR EMERGENCY SERVICES** will be referred to which
26 public safety agency.

28 (a) The Board shall coordinate the enhancement of county 9–1–1 systems.

29 (b) The Board’s responsibilities include:

30 (1) establishing planning guidelines for enhanced 9–1–1 system plans and
31 deployment of wireless enhanced 9–1–1 service in accordance with this subtitle;

1 (2) establishing procedures to review and approve or disapprove county
2 plans and to evaluate requests for variations from the planning guidelines established by
3 the Board;

4 (3) establishing procedures for the request for reimbursement of the costs
5 of enhancing a 9-1-1 system by a county or counties in which a 9-1-1 system is in
6 operation, and procedures to review and approve or disapprove the request;

7 (4) transmitting the planning guidelines and procedures established under
8 this section, and any amendments to them, to the governing body of each county;

9 (5) submitting to the Secretary each year a schedule for implementing the
10 enhancement of county or multicounty 9-1-1 systems, and an estimate of funding
11 requirements based on the approved county plans;

12 (6) developing, with input from counties, and publishing on or before July
13 1, 2004, an implementation schedule for deployment of wireless enhanced 9-1-1 service;

14 (7) reviewing and approving or disapproving requests for reimbursement
15 of the costs of enhancing 9-1-1 systems, and submitting to the Secretary each year a
16 schedule for reimbursement and an estimate of funding requirements;

17 (8) reviewing the enhancement of 9-1-1 systems;

18 (9) providing for an audit of county expenditures for the operation and
19 maintenance of 9-1-1 systems;

20 (10) ensuring inspections of public safety answering points;

21 (11) reviewing and approving or disapproving requests from counties with
22 operational enhanced 9-1-1 systems to be exempted from the expenditure limitations
23 under § 1-312 of this subtitle;

24 (12) authorizing expenditures from the 9-1-1 Trust Fund that:

25 (i) are for enhancements of 9-1-1 systems that:

26 1. are required by the Board;

27 2. will be provided to a county by a third party contractor;

28 and

29 3. will incur costs that the Board has approved before the
30 formation of a contract between the county and the contractor; and

31 (ii) are approved by the Board for payment:

- 1 1. from money collected under § 1–310 of this subtitle; and
- 2 2. directly to a third party contractor on behalf of a county;

4 (13) establishing planning guidelines for [next generation] NEXT
5 GENERATION 9–1–1 services system plans and deployment of [next generation] NEXT
6 GENERATION 9–1–1 services in accordance with this subtitle;

7 (14) ESTABLISHING MINIMUM STANDARDS FOR RECORDS RETENTION
8 GUIDELINES FOR 9–1–1 AUDIO, PICTURES, VIDEO, TEXT MESSAGES, AND DATA;

9 (15) ESTABLISHING TRAINING STANDARDS FOR PUBLIC SAFETY
10 ANSWERING POINT PERSONNEL BASED ON NATIONAL BEST PRACTICES; AND

14 (c) The guidelines established by the Board under subsection (b)(1) and (13) of
15 this section:

16 (1) shall be based on available technology and equipment; [and]

17 (2) SHALL REQUIRE NEXT GENERATION 9–1–1 SERVICES SYSTEMS TO
18 BE INTERCONNECTED AND INTEROPERABLE, AS DETERMINED BY THE BOARD; AND

19 [(2)] (3) may be based on any other factor that the Board determines is
20 appropriate, including population and area served by 9–1–1 systems.

21 (D) THE STANDARDS ESTABLISHED BY THE BOARD UNDER SUBSECTION
22 (B)(14) OF THIS SECTION SHALL INCLUDE PROCEDURES FOR:

23 (1) THE SECURITY OF THE RECORDS;

24 (2) THE ESTABLISHMENT AND REVISION, IN ACCORDANCE WITH THE
25 REGULATIONS, OF RECORD RETENTION AND DISPOSAL SCHEDULES TO ENSURE THE
26 PROMPT AND ORDERLY DISPOSITION OF RECORDS, INCLUDING ELECTRONIC
27 RECORDS, THAT ARE NO LONGER NEEDED FOR OPERATION; AND

28 (3) THE MAINTENANCE OF INVENTORIES OF RECORDS SERIES THAT
29 ARE ACCURATE AND COMPLETE.

18 (ii) the total amount collected from the 9-1-1 fee and the additional
19 charge shall be expended only for the installation, enhancement, maintenance, and
20 operation of a county or multicounty system.

21 (2) The Board may grant an exception to the provisions of paragraph (1) of
22 this subsection in extenuating circumstances.

23 (3) A county with an operational Phase II wireless enhanced 9-1-1 system
