Public Schools - School Resource Officers - Prohibited Conduct

3 FOR the purpose of prohibiting a school administrator or official or a school safety 4 coordinator from directing a school resource officer or a school security employee to 5 participate in the routine school discipline of a student; prohibiting a school resource 6 officer or a school security employee from participating in the routine school 7 discipline of a student; requiring a certain curriculum to include training in conduct 8 that is prohibited for school resource officers; and generally relating to prohibited 9 conduct of school administrators or officials, school safety coordinators, school resource officers, and school security employees. 10
