- 2 (2) A person may not knowingly and willfully obtain by deception, 3 intimidation, or undue influence the property of an individual that the person knows or 4 reasonably should know is at least 68 years old, with intent to deprive the individual of the 5 individual's property.
- 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 October 1, 2019.
