## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Baltimore County and Harford County – Motorcycles – Sunday Sales**

3 FOR the purpose of authorizing a dealer in Baltimore County or Harford County to sell,  
4 barter, deliver, give away, show, or offer for sale a motorcycle or certificate of title  
5 for a motorcycle on Sunday; and generally relating to Sunday motorcycle sales in  
6 Baltimore County and Harford County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

2 (d) Except in Howard, Montgomery, and Prince George’s counties, and except as  
3 provided in subsections (g), (h), and (i) of this section, a new or used car dealer may not sell,  
4 barter, deliver, give away, show, or offer for sale a motor vehicle or certificate of title for a  
5 motor vehicle on Sunday.

6 (g) In Anne Arundel County, **BALTIMORE COUNTY, HARFORD COUNTY,** and  
7 Worcester County, a dealer may sell, barter, deliver, give away, show, or offer for sale a  
8 motorcycle, as defined in § 11-136 of the Transportation Article, or certificate of title for a  
9 motorcycle on Sunday.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
11 ~~October~~ June 1, 2019.
