CHAPTER _____

1 AN ACT concerning

2 **Family Law – Parentage and Adoption**

3 FOR the purpose of providing that a child conceived by means of assisted reproduction
4 during the marriage of the child’s mother with the consent of the mother’s spouse is
5 the legitimate child of both spouses for all purposes; providing that the consent of
6 the mother’s spouse is presumed; providing that a child conceived by means of
7 assisted reproduction after the death of the mother’s spouse and using the genetic
8 material of the mother’s spouse is the legitimate child of both spouses under certain
9 circumstances; establishing the circumstances under which a child is the child of an
10 individual who did not give birth to the child; establishing a certain rebuttable
11 presumption regarding the parentage of a child born to parents who have not
12 participated in a marriage ceremony with each other; providing that an individual
13 who is the presumed parent of a child under certain provisions of law shall be
14 considered to be the child’s parent for certain purposes, under certain circumstances;
15 establishing rules regarding the rebuttal of a certain presumption of parentage;

 6 mother at the time of the prospective adoptee's birth or who, together with the
 7 prospective adoptee's mother, consented to the conception of the prospective adoptee
 8 by means of assisted reproduction in a certain manner; requiring a certain petitioner
 9 to submit certain documentation in an adoption proceeding under this Act;
 10 prohibiting a court from requiring a certain investigation or hearing in ruling on a
 11 petition for adoption under this Act, except under certain circumstances; requiring a
 12 court to enter an order for adoption under this Act on making certain findings;
 13 providing that an order for adoption granted under this Act is confirmation of
 14 parentage established under certain provisions of law; prohibiting this Act from
 15 being construed to require a certain individual to adopt a certain child; providing
 16 that certain presumptions of parentage apply in a certain paternity action; requiring
 17 unmarried parents to be provided an opportunity to execute a certain affidavit of
 18 parentage in a certain manner; altering rules and requirements for a certain
 19 affidavit of parentage; specifying that, if a child's mother was married at the time of
 20 either the conception or birth or between conception and birth, the name of the
 21 mother's spouse shall be entered on the child's birth certificate as the child's other
 22 parent; providing that any information in a certain certificate that relates to a parent
 23 who did not give birth to a child is prima facie evidence except under certain
 24 circumstances; prohibiting this Act from being interpreted to overturn or to alter in
 25 any way a certain holding by the Court of Appeals of Maryland; prohibiting this Act

5 (a) **(1)** A child born or conceived during a marriage is presumed to be the
 6 legitimate child of both spouses.

7 **(2)** Except as provided in § 1–207 of this subtitle, a child born at any time
 8 after [his] **THE CHILD’S** parents have participated in a marriage ceremony with each other,
 9 even if the marriage is invalid, is presumed to be the legitimate child of both parents.

10 (b) **(1)** A child conceived [by artificial insemination of a married woman] **BY**
 11 **MEANS OF ASSISTED REPRODUCTION DURING THE MARRIAGE OF THE CHILD’S**
 12 **MOTHER** with the consent of [her husband] **THE MOTHER’S SPOUSE** is the legitimate
 13 child of both [of them] **SPOUSES** for all purposes.

14 **(2)** Consent of the [husband] **MOTHER’S SPOUSE** is presumed.

15 **(3)** **A CHILD CONCEIVED BY MEANS OF ASSISTED REPRODUCTION**
 16 **AFTER THE DEATH OF THE MOTHER’S SPOUSE AND USING THE GENETIC MATERIAL**
 17 **OF THE MOTHER’S SPOUSE IS THE LEGITIMATE CHILD OF BOTH SPOUSES IF THE**
 18 **CHILD QUALIFIES AS A CHILD OF THE MOTHER’S SPOUSE UNDER § 1–205(A)(2) OF**
 19 **THIS SUBTITLE.**

21 (a) A child born to parents who have not participated in a marriage ceremony
 22 with each other [shall be considered to be] **IS** the child of [his] **THE CHILD’S** mother.

1 CONDITIONS UNDER § 1-205(A)(2) OF THIS SUBTITLE IF THE CHILD IS CONCEIVED
2 AFTER THE DEATH OF THE PARENT.

3 (C) THERE IS A REBUTTABLE PRESUMPTION THAT A CHILD BORN TO
4 PARENTS WHO HAVE NOT PARTICIPATED IN A MARRIAGE CEREMONY WITH EACH
5 OTHER IS THE CHILD OF AN INDIVIDUAL WHO DID NOT GIVE BIRTH TO THE CHILD IF
6 THE INDIVIDUAL:

7 [(2)] (1) Has acknowledged himself OR HERSELF, in writing, to be [the
8 father] A PARENT OF THE CHILD;

9 [(3)] (2) Has openly and notoriously recognized the child to be [his] THE
10 INDIVIDUAL'S child; or

11 [(4)] (3) Has subsequently married the mother and has acknowledged
12 himself OR HERSELF, orally or in writing, to be [the father] A PARENT OF THE CHILD.

14 (A) AN INDIVIDUAL WHO IS THE PRESUMED PARENT OF A CHILD UNDER
15 THIS SUBTITLE SHALL BE CONSIDERED TO BE THE CHILD'S PARENT FOR ALL
16 PURPOSES, INCLUDING INHERITANCE, CUSTODY AND VISITATION, SUPPORT
17 OBLIGATIONS, AND CHILD IN NEED OF ASSISTANCE PROCEEDINGS, UNLESS THE
18 PRESUMPTION OF PARENTAGE IS REBUTTED IN ACCORDANCE WITH THIS SECTION.

19 (B) (1) EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, A
20 PRESUMPTION OF PARENTAGE UNDER THIS SUBTITLE MAY BE REBUTTED ONLY IF A
21 COURT OF COMPETENT JURISDICTION DETERMINES IN A WRITTEN ORDER THAT IT
22 IS IN THE BEST INTEREST OF THE CHILD TO RECEIVE AND CONSIDER EVIDENCE
23 THAT COULD REBUT THE PRESUMPTION.

24 (2) A WRITTEN ORDER THAT IT IS NOT IN THE BEST INTEREST OF THE
25 CHILD TO REBUT A PRESUMPTION OF PARENTAGE:

26 (I) CONCLUSIVELY ESTABLISHES THAT THE PRESUMED
27 PARENT IS A PARENT OF THE CHILD FOR ALL PURPOSES; AND

28 (II) MAY BE MODIFIED OR SET ASIDE ONLY ON THE BASIS OF
29 FRAUD, MISTAKE, OR IRREGULARITY.

30 (C) AN INDIVIDUAL WHO IS THE PUTATIVE FATHER OF A CHILD IN A
31 PROCEEDING UNDER TITLE 5, SUBTITLE 10 OF THE FAMILY LAW ARTICLE MAY
32 OBTAIN AND USE EVIDENCE OF BLOOD OR GENETIC TESTING IN THE PROCEEDING
33 TO THE EXTENT AUTHORIZED UNDER TITLE 5, SUBTITLE 10 OF THE FAMILY LAW

13 COPY OF ANY WRITTEN AGREEMENT CONSENTING TO THE CONCEPTION OF THE
14 PROSPECTIVE ADOPTEE BY MEANS OF ASSISTED REPRODUCTION;

25 (2) THE COURT MAY HOLD A HEARING TO DETERMINE WHETHER

11 **WHOSE SPERM FERTILIZES AN OVUM, RESULTING IN THE BIRTH OF A CHILD.**

18 **OR WITHOUT CONSIDERATION, SPERM OR AN OVUM INTENDED FOR USE IN ASSISTED**
19 **REPRODUCTION.**

20 **(2) “GAMETE DONOR” DOES NOT INCLUDE THE MOTHER OF A CHILD**
21 **CONCEIVED BY MEANS OF ASSISTED REPRODUCTION USING THE MOTHER’S OVUM.**

22 **(H) “MOTHER” MEANS AN INDIVIDUAL, REGARDLESS OF GENDER, WHO**
23 **GIVES BIRTH TO A CHILD UNLESS PARENTAGE IS OTHERWISE ESTABLISHED.**

24 **(I) “PUTATIVE FATHER” MEANS:**

25 **(1) AN ALLEGED FATHER OF A CHILD WHO HAS NO PARENT OR**
26 **PRESUMED PARENT UNDER TITLE 1, SUBTITLE 2 OF THE ESTATES AND TRUSTS**

4 (a) An equity court may determine the legitimacy of a child pursuant to **[[§ 1-208]**
5 **TITLE 1, SUBTITLE 2** of the Estates and Trusts Article.

9 (a) At the trial, the burden is on the complainant to establish by a preponderance
10 of the evidence that the alleged father is the father of the child.

1 (b) The affidavit shall be completed on a standardized form developed by the
2 Department.

3 (c) (1) The completed affidavit of parentage form shall contain:

4 (i) in ten point boldface type a statement that the affidavit is a legal
5 document and constitutes a legal finding of **[paternity] PARENTAGE**;

6 (ii) the full name and the place and date of birth of the child;

7 (iii) the full name of the attesting **[father of] PARENT WHO DID NOT**
8 **GIVE BIRTH TO** the child;

9 (iv) the full name of the attesting mother of the child;

10 (v) the signatures of the **[father and the mother] PARENTS** of the
11 child attesting, under penalty of perjury, that the information provided on the affidavit is
12 true and correct;

13 (vi) a statement by the mother consenting to the assertion of
14 **[paternity] PARENTAGE** and acknowledging that **[her]**:

15 1. **THE MOTHER'S** cosignatory is the only possible father **OF**
16 **THE CHILD; OR**

17 2. **THE MOTHER AND THE MOTHER'S COSIGNATORY**
18 **CONSENTED TO THE CONCEPTION OF THE CHILD BY MEANS OF ASSISTED**
19 **REPRODUCTION WITH THE SHARED INTENT TO BE THE PARENTS OF THE CHILD;**

20 (vii) a statement by the **[father] INDIVIDUAL WHO DID NOT GIVE**
21 **BIRTH TO THE CHILD** that **[he]**:

22 1. **THE INDIVIDUAL** is the **[natural]** father of the child; **OR**

23 2. **THE INDIVIDUAL AND THE CHILD'S MOTHER**
24 **CONSENTED TO THE CONCEPTION OF THE CHILD BY MEANS OF ASSISTED**
25 **REPRODUCTION WITH THE SHARED INTENT TO BE THE PARENTS OF THE CHILD;** and

26 (viii) the Social Security numbers provided by each of the parents.

27 (2) Before completing an affidavit of parentage form, the unmarried
28 **[mother and the father] PARENTS** shall be advised orally and in writing of the legal
29 consequences of executing the affidavit and of the benefit of seeking legal counsel.

1 (d) (1) An executed affidavit of parentage constitutes a legal finding of
2 **[paternity] PARENTAGE**, subject to the right of any signatory to rescind the affidavit:

3 (i) in writing within 60 days after execution of the affidavit; or

5 1. in which the signatory is a party; and

26 (a) In this subtitle the following words have the meanings indicated.

27 (b) “Attending clinician” means the physician, nurse midwife, or direct-entry
28 midwife in charge of a birth outside an institution.

29 (c) “Attending physician” means the physician in charge of the patient’s care for
30 the illness or condition which resulted in death.

31 (d) “County registrar” means the registrar of vital records for a county.

1 (e) (1) “Dead body” means:

2 (i) A dead human body; or

3 (ii) Parts or bones of a human body if, from their condition, an
4 individual reasonably may conclude that death has occurred.

5 (2) “Dead body” does not include an amputated part.

6 (f) “Direct–entry midwife” means an individual licensed to practice direct–entry
7 midwifery under Title 8, Subtitle 6C of the Health Occupations Article.

8 (g) **“FATHER” HAS THE MEANING STATED IN § 5–1001 OF THE FAMILY LAW**
9 **ARTICLE.**

10 (H) “Fetal death” means death of a product of human conception, before its
11 complete expulsion or extraction from the mother, regardless of the duration of the
12 pregnancy, as indicated by the fact that, after the expulsion or extraction, the fetus does
13 not breathe or show any other evidence of life, such as heart beat, pulsation of the umbilical
14 cord, or definite movement of voluntary muscle.

15 [(h)] (I) “File” means to present for registration any certificate, report, or other
16 record including records transmitted by approved electronic media, including facsimile, of
17 birth, death, fetal death, adoption, marriage, or divorce for which this subtitle provides and
18 to have the Secretary accept the record.

19 [(i)] (J) “Filing date” means the date a vital record is accepted for registration
20 by the Secretary.

21 [(j)] (K) “Final disposition” means the burial, cremation, or other final
22 disposition of a body or fetus.

23 [(k)] (L) “Institution” means any public or private establishment:

24 (1) To which individuals are committed by law; or

25 (2) That provides to 2 or more unrelated individuals:

26 (i) Any inpatient or outpatient medical, surgical, or diagnostic care
27 or treatment; or

28 (ii) Any nursing, custodial, or domiciliary care.

29 [(l)] (M) “Licensed health care practitioner” means:

1 (1) An individual who is:

2 (i) A physician licensed under Title 14 of the Health Occupations
3 Article;

4 (ii) A psychologist licensed under Title 18 of the Health Occupations
5 Article;

6 (iii) A registered nurse licensed and certified to practice as a nurse
7 practitioner, nurse psychotherapist, or clinical nurse specialist under Title 8 of the Health
8 Occupations Article;

9 (iv) A licensed certified social worker–clinical licensed under Title 19
10 of the Health Occupations Article; or

11 (2) An individual who:

12 (i) Is licensed to practice a profession listed in item (1) of this
13 subsection in another state; and

14 (ii) Meets the requirements under the Health Occupations Article to
15 qualify for a license to practice the profession in this State.

16 **[(m)] (N)** “Live birth” means the complete expulsion or extraction of a product of
17 human conception from the mother, regardless of the period of gestation, if, after the
18 expulsion or extraction, it breathes or shows any other evidence of life, such as heart beat,
19 pulsation of the umbilical cord, or definite movement of voluntary muscle, whether or not
20 the umbilical cord is cut or the placenta is attached.

21 **(O) “MOTHER” HAS THE MEANING STATED IN § 5–1001 OF THE FAMILY LAW**
22 **ARTICLE.**

23 **[(n)] (P)** “Mortician” means a funeral director, mortician, or other person who is
24 authorized to make final disposition of a body.

25 **[(o)] (Q)** “Nurse midwife” means an individual certified to practice as a nurse
26 midwife under Title 8 of the Health Occupations Article.

27 **[(p)] (R)** “Physician” means a person authorized or licensed to practice medicine
28 or osteopathy pursuant to the laws of this State.

29 **[(q)] (S)** “Physician assistant” means an individual who is licensed under Title
30 15 of the Health Occupations Article to practice medicine with physician supervision.

31 **[(r)] (T)** “Registration” means acceptance by the Secretary and incorporation in
32 the records of the Department of any certificate, report, or other record of birth, death, fetal

1 death, adoption, marriage, divorce, or dissolution or annulment of marriage for which this
2 subtitle provides.

3 [(s)] (U) “Vital record” means a certificate or report of birth, death, fetal death,
4 marriage, divorce, dissolution or annulment of marriage, adoption, or adjudication of
5 paternity that is required by law to be filed with the Secretary.

6 [(t)] (V) “Vital statistics” means the data derived from certificates and reports
7 of birth, death, fetal death, marriage, divorce, dissolution or annulment of marriage, and
8 reports related to any of these certificates and reports.

9 4–208.

10 (a) (1) Within 5 calendar days after a birth occurs in an institution, or en route
11 to the institution, or outside an institution with an attending clinician, the administrative
12 head of the institution or a designee of the administrative head, or the attending clinician
13 or a designee of the attending clinician, shall:

14 (i) Prepare, on the form that the Secretary provides, a certificate of
15 birth;

16 (ii) Secure each signature that is required on the certificate; and

17 (iii) File the certificate.

18 (2) The attending physician, physician assistant, nurse practitioner, nurse
19 midwife, or attending clinician shall provide the date of birth and medical information that
20 are required on the certificate within 5 calendar days after the birth.

21 (3) The results of the universal hearing screening of newborns shall be

32 5–1028 of the Family Law Article;

33 (ii) Furnish to the mother written information prepared by the Child
34 Support Administration concerning the benefits of having the [paternity] **PARENTAGE** of

1 [her] **THE** child established, including the availability of child support enforcement
2 services; and

3 (iii) Forward the completed affidavit to the Maryland Department of
4 Health, Division of Vital Records. The Maryland Department of Health, Division of Vital
5 Records shall make the affidavits available to the parents, guardian of the child, or a child
6 support enforcement agency upon request.

7 (5) An institution, the administrative head of the institution, the designee
8 of the administrative head of an institution, an employee of an institution, the attending
9 clinician, and the designee of the attending clinician may not be held liable in any cause of
10 action arising out of the establishment of [paternity] **PARENTAGE**.

15 be named on the certificate as the [father] **OTHER PARENT**.

16 (7) **IF THE CHILD'S MOTHER WAS MARRIED AT THE TIME OF EITHER**
17 **THE CONCEPTION OR BIRTH OR BETWEEN CONCEPTION AND BIRTH, THE NAME OF**
18 **THE MOTHER'S SPOUSE SHALL BE ENTERED ON THE CERTIFICATE AS THE CHILD'S**
19 **OTHER PARENT**.

20 (8) In any case in which [paternity] **PARENTAGE** of a child is determined
21 by a court of competent jurisdiction, the name of the [father] **PARENT WHO DID NOT GIVE**
22 **BIRTH TO THE CHILD** and surname of the child shall be entered on the certificate of birth
23 in accordance with the finding and order of the court.

24 [(8)] (9) If the [father] **PARENT WHO DID NOT GIVE BIRTH TO THE**
25 **CHILD** is not named on the certificate of birth, no other information about [the father]
26 **THAT PARENT** shall be entered on the certificate.

27 (b) Within 5 calendar days after a birth occurs outside an institution without an
28 attending clinician, the birth shall be verified by the Secretary and a certificate of birth
29 shall be prepared, on the form that the Secretary provides, and filed by one of the following,
30 in the indicated order of priority:

31 (1) The attending individual.

32 (2) In the absence of an attending individual, [the father or mother]
33 **EITHER PARENT OF THE CHILD**.

35 **EITHER PARENT**, the individual in charge of the premises where the birth occurred.

1 (c) (1) When a birth occurs on a common carrier within the United States and
2 the child is first removed from the carrier in this State, the birth shall be registered in this
3 State, and the place where the child is first removed shall be considered the place of birth.

4 [(d)] (2) When a birth occurs on a common carrier while in international waters,
5 air space, or in a foreign country and the child is first removed from the carrier in this
6 State, the birth shall be registered in this State but the certificate shall show the actual
7 place of birth insofar as can be determined.

8 [(e)] (3) The certificate shall be filed within 5 calendar days after the child is
9 removed from the carrier.

10 [(f)] (D) (1) Each parent shall provide his or her own Social Security number
11 on the form provided by the Secretary under this section.

12 (2) (i) If the [father] **PARENT WHO DID NOT GIVE BIRTH TO THE**
13 **CHILD** is not available to provide [his] **THE PARENT'S** Social Security number on the form
14 provided under paragraph (1) of this subsection, the [father] **PARENT** shall provide [his]
15 **THE PARENT'S** Social Security number on a form provided by the Secretary for this

17 (ii) The form provided under this paragraph shall:

18 1. State that the form is for the purpose of providing the
19 Social Security numbers of parents, to be included on the portion of the form that remains

23 number shall be provided under penalty of perjury.

24 (3) The Social Security number as provided by each parent shall be
25 recorded on the portion of the form provided by the Secretary which remains in the official
26 birth record.

27 (4) The Social Security numbers of the parents may not appear on the
28 portion of the birth certificate issued as proof of birth.

29 (5) (i) The Secretary shall permit disclosure of the Social Security
30 numbers of the parents only to the Child Support Administration of the Department of
31 Human Services.

32 (ii) The Child Support Administration may use the Social Security
33 numbers of the parents to:

- 1 1. Locate a parent;
- 2 2. Establish [paternity] **PARENTAGE**; and
- 3 3. Establish and enforce a child support order under Title 10,
4 Subtitle 1 of the Family Law Article.

5 [(g)] **(E)** If, under subsection [(f)(1)] **(D)(1)** of this section, the [father's] Social
6 Security number **OF THE PARENT WHO DID NOT GIVE BIRTH TO THE CHILD** is not
7 entered on the form provided by the Secretary:

8 (1) Upon adjudication of [paternity] **PARENTAGE**, the court shall order the
9 [father] **PARENT** to provide [his] **THE PARENT'S** Social Security number to the clerk of
10 court; and

11 (2) The clerk of court shall send the [father's] **PARENT'S** Social Security
12 number to the Secretary, as provided under § 4-211(f) of this subtitle.

13 4-211.

14 (a) Except as provided in subsection (d) of this section, the Secretary shall make
15 a new certificate of birth for an individual if the Department receives satisfactory proof
16 that:

17 (1) The individual was born in this State; and

18 (2) Regardless of the location, one of the following has occurred:

19 (i) The previously unwed parents of the individual have married
20 each other after the birth of the individual;

21 (ii) A court of competent jurisdiction has entered an order as to the
22 parentage, legitimation, or adoption of the individual; or

23 (iii) If a [father] **PARENT WHO DID NOT GIVE BIRTH TO THE**
24 **INDIVIDUAL** is not named on an earlier certificate of birth:

25 1. The [father of] **PARENT WHO DID NOT GIVE BIRTH TO**
26 the individual has acknowledged himself **OR HERSELF** by affidavit to be [the father] **A**
27 **PARENT OF THE INDIVIDUAL**; and

28 2. The mother of the individual has consented by affidavit to

1 (c) Except as provided in subsection (d) of this section, the Secretary may make a
2 new certificate of birth for an individual who was born outside the United States if one of

5 other after the birth of the individual;

6 (2) A court of competent jurisdiction in this State has entered an order as
7 to parentage or legitimation; or

8 (3) The [father of] **PARENT WHO DID NOT GIVE BIRTH TO** the individual
9 acknowledged himself **OR HERSELF** by affidavit to be [the father] **A PARENT OF THE**
10 **INDIVIDUAL** and the mother of the individual has consented by affidavit to the
11 acknowledgment.

12 (e) A new certificate of birth shall be prepared on the following basis:

13 (1) The individual shall be treated as having at birth the status that later
14 is acquired or established and of which proof is submitted.

15 (2) **(I)** If the parents of the individual were not married and [paternity]
16 **PARENTAGE** is established by legal proceedings, the name of the [father] **PARENT WHO**
17 **DID NOT GIVE BIRTH TO THE INDIVIDUAL** shall be inserted.

18 **(II)** The legal proceeding should request and report to the Secretary
19 that the surname of the subject of the record be changed from that shown on the original

24 (4) The new certificate of birth shall contain wording that requires each

26 (h) Each clerk of court shall send to the Secretary, on the form that the Secretary
27 provides, a report of:

28 (1) Each decree of adoption;

29 (2) Each adjudication of [paternity] **PARENTAGE**, including the [father's]

31 (3) Each revocation or amendment of any decree of adoption or
32 adjudication of paternity that the court enters.

2 (a) Except as otherwise provided in this section, if a certificate of birth, death, or
3 fetal death is filed within 1 year after the event, the original or a certified copy of the
4 certificate is prima facie evidence of the facts stated in it.

5 (b) (1) **[Any] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
6 **SUBSECTION, ANY** information in the certificate that relates to **[the father of] A PARENT**
7 **WHO DID NOT GIVE BIRTH TO** a child is prima facie evidence **[only if the alleged father is**
8 **the husband of the mother]**.

9 (2) If the **[alleged father is not the husband of the mother and paternity is**
10 **contested] PARENTAGE OF THE CHILD IS CONTESTED, AND THE PARENT WHO DID NOT**
