- 1 (1) a person or governmental unit to engage in business primarily as a 2 licensed agent; or
- 3 (2) an individual who is under the age of 21 years.
- 4 (f) The Commission may hear and decide an appeal of a denial of a license.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 6 October 1, 2019.
