A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Senior Apartment Housing Facilities – Security Guard Services**

3 FOR the purpose of requiring the property management company of each senior apartment
4 housing facility in Baltimore City to contract with a licensed security guard agency
5 for the provision of security guard services at the senior apartment housing facility
6 at certain times; defining certain terms; and generally relating to security guard
7 services at senior apartment housing facilities in Baltimore City.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

Article – Real Property

16 **8–119.**

17 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
18 INDICATED.

19 (2) “LICENSED SECURITY GUARD AGENCY” HAS THE MEANING
20 STATED IN § 19–101 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE.

21 (3) “SECURITY GUARD SERVICES” HAS THE MEANING STATED IN §
22 19–101 OF THE BUSINESS OCCUPATIONS AND PROFESSIONS ARTICLE.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(4) (I) "SENIOR APARTMENT HOUSING FACILITY" MEANS A**
2 **RESIDENTIAL RENTAL FACILITY THAT:**

3 **1. IS PRIVATELY OR PUBLICLY FUNDED;**

4 **2. CONTAINS 50 OR MORE UNITS; AND**

5 **3. IS INTENDED AND OPERATED FOR OCCUPANCY BY**
6 **INDIVIDUALS AT LEAST 55 YEARS OLD.**

7 **(II) "SENIOR APARTMENT HOUSING FACILITY" DOES NOT**
8 **INCLUDE A NURSING HOME OR AN ASSISTED LIVING FACILITY.**

9 **(B) THIS SECTION APPLIES ONLY IN BALTIMORE CITY.**

10 **(C) THE PROPERTY MANAGEMENT COMPANY OF EACH SENIOR APARTMENT**
11 **HOUSING FACILITY SHALL CONTRACT WITH A LICENSED SECURITY GUARD AGENCY**
12 **FOR THE PROVISION OF SECURITY GUARD SERVICES AT THE SENIOR APARTMENT**
13 **HOUSING FACILITY AT ALL TIMES THAT THE PROPERTY MANAGEMENT COMPANY IS**
14 **NOT OPEN FOR CONDUCTING BUSINESS ON THE SITE OF THE SENIOR APARTMENT**
15 **HOUSING FACILITY.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2019.
