## Income Tax - Carried Interest - Additional Tax

- 3 FOR the purpose of imposing a certain State income tax on the Maryland taxable income attributable to certain investment management services of an individual or a 4 5 corporation or the distributive share of a pass—through entity; providing that the tax 6 does not apply under certain circumstances; defining certain terms; requiring the 7 Comptroller to provide certain notice to the Department of Legislative Services; 8 providing for the application of this Act; providing for the termination of this Act if 9 certain federal legislation is enacted into law; and generally relating to the State income tax and investment management services. 10

- 21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- "Distributable cash flow" means taxable income reportable by a 1 2 pass—through entity on its federal income tax return for the taxable year: 3 adjusted, in the case of an entity using the accrual method of accounting to report federal taxable income, to reflect the amount of taxable income that 4 would have been reported under the cash method of accounting; 5 6 increased by the sum of: (ii) 7 1. cash receipts for the taxable year that are not includable 8 in the gross income of the entity, including capital contributions and loan proceeds; 9 2. amounts allowable to the entity for the taxable year as deductions for depreciation, amortization, and depletion; and 10 11 the decrease, if any, in the entity's liability reserve as of 12the end of the taxable year; and 13 (iii) decreased by the sum of: 14 cash expenditures for the taxable year that are not deductible in computing the taxable income of the entity, not including distributions to 15 shareholders, partners, or members; and 16 17 the increase, if any, in the entity's liability reserve as of 18 the end of the taxable year. 19 "INVESTMENT MANAGEMENT SERVICES" (3)**MEANS SERVICES** 20 PROVIDED BY A PARTNER OR SHAREHOLDER TO A PARTNERSHIP, AN S 21 CORPORATION, OR ANY OTHER ENTITY IF THE SERVICES INCLUDE PROVIDING A 22 SUBSTANTIAL QUANTITY OF: 23 **(I)** ADVISING AS TO THE ADVISABILITY OF INVESTING IN, PURCHASING, OR SELLING A SPECIFIED ASSET; 2425 (II) MANAGING, ACQUIRING, OR DISPOSING OF A SPECIFIED 26 ASSET; 27 (III) ARRANGING FINANCING WITH RESPECT TO ACQUIRING A 28 SPECIFIED ASSET; OR

- 3 (2) The tax required to be paid for any taxable year on behalf of nonresident 4 or nonresident entity members by a pass—through entity may not exceed the sum of all of 5 the nonresident and nonresident entity members' shares of the pass—through entity's 6 distributable cash flow.
- 7 (3) (I) IN ADDITION TO THE TAX IMPOSED UNDER SUBSECTION (B)
  8 OF THIS SECTION, A STATE TAX IS IMPOSED THAT IS EQUAL TO 17% OF THE
  9 DISTRIBUTIVE SHARE OR PRO-RATA SHARE OF A PASS-THROUGH ENTITY'S

- 19 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS 20 INDICATED.
- 21 (2) "INVESTMENT MANAGEMENT SERVICES" MEANS A SERVICE 22 PROVIDED BY A PARTNER OR SHAREHOLDER TO A PARTNERSHIP, AN S
- 23 CORPORATION, OR ANY OTHER ENTITY IF THE SERVICES INCLUDE PROVIDING A

  4 STATE TAX IS IMPOSED ON THE MARYLAND TAXABLE INCOME OF A CORPORATION
  5 OR AN INDIVIDUAL, INCLUDING SPOUSES FILING A JOINT RETURN OR A SURVIVING
  6 SPOUSE OR HEAD OF HOUSEHOLD AS DEFINED IN § 2 OF THE INTERNAL REVENUE
  7 CODE, THAT IS ATTRIBUTABLE TO INVESTMENT MANAGEMENT SERVICES.
- 8 (2) The tax imposed under paragraph (1) of this subsection 9 For a corporation or an individual, including spouses filing a joint 10 Return or a surviving spouse or head of household as defined in § 2 of 11 The Internal Revenue Code, is equal to 17% of the Maryland taxable 12 Income that is attributable to investment management services.
- 13 (3) A PARTNER OR SHAREHOLDER IS NOT SUBJECT TO THE TAX
  14 UNDER THIS SUBSECTION IF, DURING THE TAXABLE YEAR, AT LEAST 80% OF THE
  15 AVERAGE FAIR MARKET VALUE OF THE SPECIFIED ASSETS OF THE PARTNERSHIP, S
  16 CORPORATION, OR OTHER ENTITY CONSISTS OF REAL ESTATE.
- SECTION 2. AND BE IT FURTHER ENACTED, That the Comptroller shall notify the Department of Legislative Services within 5 days after determining that the United States Congress has passed and the President of the United States has signed legislation having an identical effect to this Act applicable to income attributable to investment management services earned in all of the states and territories.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019, and shall be applicable to all taxable years beginning after December 31, 2018. It shall remain effective until 30 days after the day on which the Department of Legislative Services receives notice under Section 2 of this Act, and at the end of the 30th day, and with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
