Task Force to Study the Home and Hospital Teaching Program for Students
Home and Hospital Teaching Program for Students – Report

FOR the purpose of establishing the Task Force to Study the Home and Hospital Teaching 4 Program for Students; providing for the composition, chair, and staffing of the Task 5 6 Force: prohibiting a member of the Task Force from receiving certain compensation. 7 but authorizing the reimbursement of certain expenses; requiring the Task Force to 8 study and make recommendations regarding certain matters; requiring the Task 9 Force to report its findings and recommendations to the Governor, the State Board of Education, and the General Assembly on or before a certain date; requiring the 10 State Department of Education to study and make recommendations regarding 11 certain matters relating to the Home and Hospital Teaching Program for Students; 12 13 requiring the Department to report its findings to the Governor, the State Board of Education, and the General Assembly on or before a certain date; providing for the 14 15 termination of this Act; and generally relating to the Task Force to Study the Home 16 and Hospital Teaching Program for Students.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 18 That:

19 (a) There is a Task Force to Study the Home and Hospital Teaching Program for 20 Students.

19 20 21 22	(g) (b) On or before December 31, 2019, the <u>Task Force State Department of Education</u> shall submit its findings and recommendations to the Governor, the State Board of Education, and, in accordance with § 2–1246 of the State Government Article, the General Assembly.
23 24 25 26	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019. It shall remain effective for a period of 1 year and, at the end of June 30, 2020, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
