A BILL ENTITLED

1 AN ACT concerning

2 **Community Career Centers for 21st-Century Jobs**

3 FOR the purpose of requiring each local workforce development board to recruit employers
4 to provide youth apprenticeships, registered apprenticeships, and job opportunities
5 for certain students and graduates; requiring each local workforce development
6 board to match high school students with youth apprenticeships, registered
7 apprenticeships, and job opportunities; requiring each local workforce development
8 board to counsel high school students, in school and outside school, on certain career
9 paths; requiring local workforce development boards to work with local high schools
10 to offer certain career counseling services to all high school students in schools and
11 online in a certain manner; requiring the State Department of Education to annually
12 provide to the Comptroller certain information; requiring the State and certain local
13 governing bodies, beginning in a certain fiscal year, to distribute a certain amount
14 of funding to certain local workforce development boards; specifying that a local
15 workforce development board may use certain funds only toward achieving certain
16 requirements; specifying that certain funding provided to a local workforce
17 development board is supplemental to certain other funds; requiring the Governor's
18 Workforce Development Board to monitor and track the progress of each local
19 workforce development board toward achieving certain requirements; requiring the
20 Governor's Workforce Development Board to make certain recommendations under
21 a certain circumstance; requiring each local workforce development board to submit
22 a certain report on or before a certain date each year; defining certain terms; and
23 generally relating to workforce development boards.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Labor and Employment

EACH LOCAL WORKFORCE DEVELOPMENT BOARD SHALL:

(1) RECRUIT EMPLOYERS TO PROVIDE:

(I) YOUTH APPRENTICESHIPS TO HIGH SCHOOL STUDENTS;

**(II) REGISTERED APPRENTICESHIPS FOR HIGH SCHOOL
STUDENTS AND HIGH SCHOOL GRADUATES; AND**

**(III) JOB OPPORTUNITIES FOR HIGH SCHOOL AND COLLEGE
GRADUATES;**

**(2) MATCH HIGH SCHOOL STUDENTS WITH YOUTH APPRENTICESHIPS,
REGISTERED APPRENTICESHIPS, AND JOB OPPORTUNITIES;**

**(3) COUNSEL HIGH SCHOOL STUDENTS, IN SCHOOL AND OUTSIDE
SCHOOL, ON:**

**(I) SPECIFIC CAREER PATHS, INCLUDING THE SKILLS AND
CREDENTIALS REQUIRED FOR THE CAREER PATH; AND**

**(II) EDUCATION AND TRAINING OPPORTUNITIES TO LEARN THE
SKILLS REQUIRED FOR SPECIFIC CAREER PATHS; AND**

**(4) WORK WITH LOCAL HIGH SCHOOLS TO OFFER THESE CAREER
COUNSELING SERVICES TO ALL HIGH SCHOOL STUDENTS IN THE SCHOOLS AND
ONLINE THROUGH GROUP PRESENTATIONS AND INDIVIDUAL COUNSELING.**

**(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
INDICATED.**

**(2) “FULL–TIME EQUIVALENT HIGH SCHOOL ENROLLMENT” MEANS
THE SUM OF:**

1 **(I) THE NUMBER OF STUDENTS ENROLLED IN GRADES 9**
2 **THROUGH 12 OR THEIR EQUIVALENT IN REGULAR DAY SCHOOL PROGRAMS ON**
3 **SEPTEMBER 30 OF THE PREVIOUS SCHOOL YEAR;**

4 **(II) THE NUMBER OF FULL-TIME EQUIVALENT STUDENTS, AS**
5 **DETERMINED BY A REGULATION OF THE STATE DEPARTMENT OF EDUCATION,**
6 **ENROLLED IN EVENING HIGH SCHOOL PROGRAMS DURING THE PREVIOUS SCHOOL**
7 **YEAR; AND**

8 **(III) THE NUMBER OF P-TECH STUDENTS, AS PROVIDED IN §**
9 **7-1804(B) OF THE EDUCATION ARTICLE.**

10 **(3) “LOCAL SHARE” MEANS THE LOCAL PROPORTION FOR A COUNTY**
11 **RESULTING FROM THE RATIO OF STATE FUNDING TO LOCAL FUNDING FOR THE**
12 **FOUNDATION PROGRAM FOR PUBLIC SCHOOLS AS CALCULATED UNDER § 5-202 OF**
13 **THE EDUCATION ARTICLE MULTIPLIED BY THE PROGRAM AMOUNT FOR THAT**
14 **COUNTY.**

15 **(4) “PROGRAM AMOUNT” MEANS THE LOCAL SCHOOL SYSTEM’S**
16 **FULL-TIME EQUIVALENT HIGH SCHOOL ENROLLMENT DIVIDED BY THE STATE’S**
17 **FULL-TIME EQUIVALENT HIGH SCHOOL ENROLLMENT, MULTIPLIED BY \$45,000,000.**

18 **(5) “STATE SHARE” MEANS THE STATE PROPORTION FOR A COUNTY**
19 **RESULTING FROM THE RATIO OF STATE FUNDING TO LOCAL FUNDING FOR THE**
20 **FOUNDATION PROGRAM FOR PUBLIC SCHOOLS AS CALCULATED UNDER § 5-202 OF**
21 **THE EDUCATION ARTICLE MULTIPLIED BY THE PROGRAM AMOUNT FOR THAT**
22 **COUNTY.**

23 **(B) THE STATE DEPARTMENT OF EDUCATION ANNUALLY SHALL PROVIDE**
24 **TO THE COMPTROLLER THE STATE SHARE FOR EACH LOCAL WORKFORCE**
25 **DEVELOPMENT BOARD.**

26 **(C) BEGINNING IN FISCAL YEAR 2021 AND FOR EACH FISCAL YEAR**
27 **THEREAFTER:**

28 **(1) FOR A LOCAL WORKFORCE DEVELOPMENT BOARD THAT SERVES**
29 **ONLY ONE COUNTY:**

30 **(I) THE STATE SHALL DISTRIBUTE TO EACH LOCAL**
31 **WORKFORCE DEVELOPMENT BOARD THE STATE SHARE FOR THE COUNTY SERVED**
32 **BY THE LOCAL WORKFORCE DEVELOPMENT BOARD; AND**

1 **(II) THE LOCAL GOVERNING BODY SHALL DISTRIBUTE TO THE**
2 **LOCAL WORKFORCE DEVELOPMENT BOARD THE LOCAL SHARE FOR THE COUNTY**
3 **SERVED BY THE LOCAL WORKFORCE DEVELOPMENT BOARD; AND**

4 **(2) FOR A REGIONAL LOCAL WORKFORCE DEVELOPMENT BOARD**
5 **THAT SERVES MORE THAN ONE COUNTY:**

6 **(I) THE STATE SHALL DISTRIBUTE TO THE REGIONAL LOCAL**
7 **WORKFORCE DEVELOPMENT BOARD THE AGGREGATE STATE SHARE FOR THE**
8 **COUNTIES SERVED BY THE REGIONAL LOCAL WORKFORCE DEVELOPMENT BOARD;**
9 **AND**

10 **(II) EACH LOCAL GOVERNING BODY IN A COUNTY SERVICED BY**
11 **THE REGIONAL LOCAL WORKFORCE DEVELOPMENT BOARD SHALL DISTRIBUTE TO**
12 **THE REGIONAL LOCAL WORKFORCE DEVELOPMENT BOARD THE LOCAL SHARE OF**
13 **THE COUNTY.**

14 **(D) (1) A LOCAL WORKFORCE DEVELOPMENT BOARD MAY USE THE**
15 **FUNDING PROVIDED UNDER THIS SECTION ONLY TOWARD ACHIEVING THE**
16 **REQUIREMENTS UNDER § 11-603 OF THIS SUBTITLE.**

17 **(2) THE FUNDING PROVIDED UNDER THIS SECTION MAY BE USED BY**
18 **A LOCAL WORKFORCE DEVELOPMENT BOARD TO SUPPLEMENT FUNDS FROM OTHER**
19 **FUNDING SOURCES FOR CAREER COUNSELING AND JOB MATCHING SERVICES.**

20 **(E) (1) THE GOVERNOR'S WORKFORCE DEVELOPMENT BOARD SHALL**
21 **MONITOR AND TRACK THE PROGRESS OF EACH LOCAL WORKFORCE DEVELOPMENT**
22 **BOARD IN ACHIEVING THE REQUIREMENTS UNDER § 11-603 OF THIS SUBTITLE.**

23 **(2) IF SUFFICIENT PROGRESS IS NOT BEING MADE BY A LOCAL**
24 **WORKFORCE DEVELOPMENT BOARD TOWARD ACHIEVING THE REQUIREMENTS**
25 **UNDER § 11-603 OF THIS SUBTITLE, THE GOVERNOR'S WORKFORCE DEVELOPMENT**
26 **BOARD SHALL MAKE ANY APPROPRIATE RECOMMENDATIONS RELATED TO THE**
27 **DISTRIBUTION OF FUNDS UNDER THIS SECTION.**

28 **(F) ON OR BEFORE DECEMBER 1, 2020, AND EACH DECEMBER 1**
29 **THEREAFTER, EACH LOCAL WORKFORCE DEVELOPMENT BOARD SHALL REPORT TO**
30 **THE GOVERNOR'S WORKFORCE DEVELOPMENT BOARD ON THE LOCAL WORKFORCE**
31 **DEVELOPMENT BOARD'S PROGRESS TOWARD ACHIEVING THE REQUIREMENTS**
32 **UNDER § 11-603 OF THIS SUBTITLE, INCLUDING:**

33 **(1) THE LOCAL WORKFORCE DEVELOPMENT BOARD'S EMPLOYER AND**
34 **JOB SEEKER SERVICES;**

1 **(2) THE ENGAGEMENT OPPORTUNITIES WITH HIGH SCHOOL**
2 **STUDENTS PROVIDED BY THE LOCAL WORKFORCE DEVELOPMENT BOARD;**

3 **(3) THE NUMBER OF EMPLOYERS RECRUITED TO PROVIDE YOUTH**
4 **APPRENTICESHIPS TO HIGH SCHOOL STUDENTS, DISAGGREGATED BY INDUSTRY**
5 **AND GEOGRAPHY;**

6 **(4) THE NUMBER OF EMPLOYERS RECRUITED TO PROVIDE**
7 **REGISTERED APPRENTICESHIPS FOR HIGH SCHOOL STUDENTS AND HIGH SCHOOL**
8 **GRADUATES, DISAGGREGATED BY INDUSTRY AND GEOGRAPHY;**

9 **(5) THE NUMBER OF EMPLOYERS RECRUITED TO PROVIDE JOB**
10 **OPPORTUNITIES FOR HIGH SCHOOL AND COLLEGE GRADUATES, DISAGGREGATED**
11 **BY INDUSTRY AND GEOGRAPHY;**

12 **(6) THE NUMBER OF MATCHED HIGH SCHOOL STUDENTS WITH YOUTH**
13 **APPRENTICESHIPS, REGISTERED APPRENTICESHIPS, OR JOB OPPORTUNITIES,**
14 **DISAGGREGATED BY INDUSTRY AND GEOGRAPHY;**

15 **(7) THE NUMBER OF HIGH SCHOOL STUDENTS COUNSELED ON**
16 **SPECIFIC CAREER PATHS; AND**

17 **(8) THE NUMBER OF HIGH SCHOOL STUDENTS RECEIVING CAREER**
18 **COUNSELING SERVICES IN SCHOOLS AND ONLINE.**

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
20 1, 2019.
